# RACE 1 : SYM DAY / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1050 metres

The start of this event was delayed approximately one minute owing to PARTING SHOT being fractious in its barrier after being loaded. PARTING SHOT was examined by the Club's Veterinary Surgeon who ruled the filly fit to race.

PARTING SHOT (A. Doyle) jumped away awkwardly.

GRAN SABANA (T. Pannell) raced keenly in the early and middle stages of the event.

GRAN SABANA (T. Pannell) was inclined to lay in under pressure in the straight.

### RACE 2 : SNOWTOWN CUP / SABOIS FILLIES & MARES MAIDEN PLATE - 1200 metres

HEIDI STAR (S. Price) jumped away awkwardly and shifted out contacting MIGHTY MAHER (C. Lindop).

STAR PEDRILLE (J. Potter) was inclined to over-race throughout the event.

MONICA'S MACHINE (T. Baker) raced greenly throughout the event. MONICA'S MACHINE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

HEIDI STAR (S. Price) was inclined to lay in under pressure in the straight.

### RACE 3 : MY BUTCHER / SABOIS MAIDEN PLATE - 1050 metres

AL MU'TAZZ (J. Potter) jumped away awkwardly, shifted out and bumped BIEN CHOISI (S. Price).

VAN PERSIE (R. Stewart) jumped away awkwardly.

# RACE 3 : MY BUTCHER / SABOIS MAIDEN PLATE - 1050 metres (Cont'd)

FIRETALE (T. Pannell) jumped away awkwardly and shifted out contacting NO MERCY (A. Herrmann).

GANGSTA HOUR (A. Doyle) was slow to begin.

LA PEROUSE (D. Tourneur) was inclined to lay in under pressure in the straight.

FIRETALE (T. Pannell) raced greenly in the straight.

## RACE 4 : COPPER COAST CUP MAIDEN PLATE - 1400 metres

The start of this event was delayed approximately two minutes owing to EMCEECEE becoming fractious in its barrier after being loaded. EMCEECEE was examined by the Club's Veterinary Surgeon who reported the gelding had sustained a laceration to the near side shoulder and was unfit to race. Acting on that advice Stewards withdrew EMCEECEE at 2.26 pm. Ms D. Tulk, the Trainer of EMCEECEE, was advised the gelding would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

TRESPASSER (C. Lindop) was held up for clear running from in the vicinity of the 600 metres until in the vicinity of the 400 metres when awkwardly placed between the heels of DAKASHA'S PRIDE (T. Pannell) and JOCKS GLEN (J. Toeroek).

In the vicinity of the 200 metres MAKO MAGIC (Z. Spain), improved to the inside of DAKASHA'S PRIDE (T. Pannell) and shifted out. As a result DAKASHA'S PRIDE shifted out and away from MAKO MAGIC. As a consequence TRESPASSER (C. Lindop) was tightened onto SKILLZ THAT KILLZ (J. Holder) and was obliged to be steadied. Z. Spain was advised to exercise more care when his mounts commence to shift ground in future.

TRESPASSER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### RACE 5 : YORKETOWN CUP CLASS 1 HANDICAP - 1200 metres

The start of this event was delayed approximately two minutes owing to TURBO STREET, which was kicked by another runner on arrival at the barriers, having to be examined by the Club's Veterinary Surgeon who ruled the gelding fit to race. The start was further delayed owing to BEAU'S MY BOY being examined by the Club's Veterinary Surgeon after it had struck its head on a perimeter fence on entering the mounting yard, and was ruled unfit to race as it had blood in its near side nostril. Acting on that advice Stewards withdrew BEAU'S MY BOY at 2.59 pm.

PETIT SOEUR (A. Herrmann) was slow to begin losing many lengths.

In the vicinity of the 900 metres MOORE ALPHA (J. Potter) became awkward in its action and shifted out abruptly, contacting FRANK HEAVENS (C. Lindop), which was inconvenienced for a number of strides. Mrs H. Lehmann, the Trainer of MOORE ALPHA, was advised the gelding would be required to complete an Official Barrier Trial prior to presenting for a future race. MOORE ALPHA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Over the concluding stages KHAPTIVATA (J. Toeroek) shifted out onto MOORE ALPHA (J. Potter), which was tightened onto SERBIAN CROWN (C. Jones). As a result MOORE ALPHA was obliged to be steadied. J. Toeroek was severely reprimanded and advised to make a greater care in future when his mounts commence to shift ground.

## RACE 5 : YORKETOWN CUP CLASS 1 HANDICAP - 1200 metres (Cont'd)

S. Carr, the rider of TIMES LIKE THESE (NZ), reported her mount felt awkward in its action throughout the event. TIMES LIKE THESE (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

PETIT SOEUR, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### RACE 6 : PORT BROUGHTON CUP RATING 0-68 HANDICAP - 1050 metres

ARROGANT CAT (J. Matthews) jumped away awkwardly and shifted out contacting MAGISUE (A. Herrmann).

In the vicinity of the 700 metres SHIP'S CAPTAIN (Z. Spain) raced ungenerously and got its head up for several strides on a number of occasions.

At the entrance to the straight SHIP'S CAPTAIN (Z. Spain) raced in restricted room between the heels of OUR BELVOIR (C. Lindop) and SHOP FRAAR'N WIDE (J. Potter) and was obliged to alter course to the outside of OUR BELVOIR in the vicinity of the 300 metres to obtain clear ground.

HURRICANE ANDY, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported a poor recovery.

#### RACE 7 : COOPERS CLEAR ADELAIDE PLAINS CUP (RATING 0-68) - 1600 metres

ANURADHA (T. Pannell) jumped away awkwardly and shifted out contacting RICH PRIDE (M. Vance).

WHERE'S THAT (B. Hoppo) jumped away awkwardly and shifted in onto STYRIA'S GEM (D. Tourneur), which became awkward on the heels of CHOISELLE (T. Baker).

In the vicinity of the 700 metres SWINGING SOLDIER (J. Kah) laid in onto INCANDESCENT (C. Lindop), which was taken in onto RIP APART (A. Herrmann) and when being corrected INCANDESCENT shifted out brushing SWINGING SOLDIER, which was taken out. As a result WHERE'S THAT (B. Hoppo), which was following, clipped the heels of SWINGING SOLDIER and stumbled. WHERE'S THAT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

SWINGING SOLDIER (J. Kah) was inclined to lay in under pressure in the straight.

SWINGING SOLDIER lost its off hind plate during the event.

### RACE 8 : MAITLAND CUP RATING 0-68 HANDICAP - 1400 metres

On arrival on course DANCING POETESS was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the near foreleg. Acting on that advice Stewards withdrew DANCING POETESS at 4.06 pm.

In the vicinity of the 700 metres EXPORT QUALITY (C. Lindop) became awkwardly placed on the heels of SIMPATICO (M. Nielson) for a number of strides.

At the entrance to the straight THOMASON (J. Frew) shifted in of its own accord onto MR BEE GEE (T. Baker), which was tightened onto JUST A SPARK (R. Stewart). As a result MR BEE GEE was awkwardly placed between the heels of THOMASON and JUST A SPARK for a number of strides.

### RACE 8 : MAITLAND CUP RATING 0-68 HANDICAP - 1400 metres (Cont'd)

J. Maund, the rider of MOLASMO JET, was reminded of his obligations under AR137A(3) in relation to excessive use of the whip over the concluding stages in this event.

EXPORT QUALITY, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported a poor recovery.

T. Baker, the rider of MR BEE GEE, reported his mount did not feel comfortable in its action during the event. MR BEE GEE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in both forelegs and the off hind leg. Mr T. Snelling, the Trainer of MR BEE GEE, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.
