THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 7 March 2015

RACE 1 : BOOK YOUR EVENT @ MORPHETTVILLE HANDICAP - 1000 metres

COMPRENDE (D. Tourneur) jumped away awkwardly and shifted out, tightening RIGHT HERE (J. Toeroek) onto C'EST BEAU LA VIE (C. Lindop) resulting in both horses being hampered and unable to maintain their positions.

C'EST BEAU LA VIE (C. Lindop) and CERTAIN ELLIE (A. Creighton) raced greenly in the straight.

RACE 2 : STEVEN BYRNES BUCKS DAY HANDICAP - 1000 metres

CHANDLERY, which kicked out in its race day stall and injured itself on arrival on course, was examined by the Club's Veterinary Surgeon who reported a laceration to the near hind leg. First Aid was administered. Acting on that advice, Stewards withdrew CHANDLERY at 11.52 am.

PERIDUKI (E. Boyd) raced wide without cover throughout and laid out rounding the home turn. PERIDUKI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

SWINGING ARMS (J. Toeroek) laid in, in the straight.

RACE 3: DRINK DRIVING? GROW UP HANDICAP - 1400 metres

The start of this race was delayed approximately two minutes owing to BEGOR I'M SURE, which lost its off fore plate en route to the barriers, requiring Farrier attention on arrival at the start. BEGOR I'M SURE was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

C. Jones, the rider of SPIRITOF ENDEAVOUR (USA), reported she was concerned with the gelding's action in its near foreleg on return to Scale. SPIRITOF ENDEAVOUR (USA) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: DRINK DRIVING? GROW UP HANDICAP - 1400 metres (Cont'd)

M. Neilson, the rider of BEGOR I'M SURE, explained the gelding failed to respond to his riding and performed disappointingly. BEGOR I'M SURE, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

STAR FORTUNE lost its off hind plate during the event.

RACE 4 : WILLIAM HILL HANDICAP - 1400 metres

MAYAN PROPHECY (I. Gundogdu) raced wide without cover in the early stages and raced keenly in the vicinity of the 900 metres.

RAFFINATO (J. Holder) was held up from the entrance to the straight until inside the 300 metres when racing behind MAYAN PROPHECY (I. Gundogdu) and was obliged to alter course to that mare's inside to obtain clear ground.

M. Dee, the rider of PEPPERMINT LANE, which was eased out of the event in the vicinity of the 150 metres, explained he had been instructed to obtain a position forward of mid-field in the early stages. He stated he was able to comply with those instructions, however, when asked for an effort in the vicinity of the 600 metres PEPPERMINT LANE was under pressure and thereafter, in the vicinity of the 200 metres, he did not persist with riding it out to the finish as he considered there may be something amiss with the filly. PEPPERMINT LANE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

D. Tourneur, the rider of FLIRTATIOUS DREAM, was questioned regarding the use of his whip prior to the 100 metres. He pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in consecutive strides prior to the 100 metres and was reprimanded. He also pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

SHEEZ ON TOP was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : PROJECTION GRAPHICS MAIDEN PLATE - 1250 metres

The start of this race was delayed approximately two minutes owing to SUB ATLANTIC being examined by the Club's Veterinary Surgeon on arrival at the barriers who reported the filly to be short in front, particularly the off foreleg. SUB ATLANTIC was ruled unfit to race. Acting on that advice, Stewards withdrew SUB ATLANTIC at 2.52 pm.

DEGILIO (J. Holder) jumped away awkwardly and was slow to begin.

THESPINIS (T. Pannell) jumped away awkwardly and shifted out. As a result DEANNA JEAN (J. Potter) shifted out and away from that filly, tightening SHOW SET (L. Stojakovic) onto HUSSON'S SHOUT (D. Tourneur), resulting in those two horses making contact and their hindquarters being turned.

In the vicinity of the 900 metres FREDERATION (S. Price) got its head up, raced ungenerously for a short distance and shifted out abruptly.

In the vicinity of the 700 metres MISTER TEEJAY (M. Vance) shifted in across the running of SHOW SET (L. Stojakovic), which was momentarily inconvenienced. M. Vance was severely reprimanded and advised to take greater care when shifting ground in future.

FREDERATION (S. Price) laid in, in the straight. FREDERATION was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : PROJECTION GRAPHICS MAIDEN PLATE - 1250 metres (Cont'd)

J. Holder, the rider of DEGILIO, explained that after being slow to begin the filly failed to muster early speed and raced greenly during the event.

RACE 6 : DARLEY HANDICAP - 2400 metres

The start of this race was delayed approximately two minutes owing to an interstate delay.

JOSEPH ARNOLD was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mr. W. Clarken, the Trainer of JOSEPH ARNOLD, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

BREAK THE MOMENT, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : FARMERS UNION ICED COFFEE HANDCIAP - 1400 metres

DEVON was withdrawn by Stewards at 7.35 am due to Mr. G. Young, the Trainer of the gelding, failing to scratch DEVON by the prescribed time. Mr. Young was fined \$200 under LR19.1.

MR BACKCHAT was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg and off hind leg. Mr. T. McEvoy, the Trainer of MR BACKCHAT, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

RACE 8 : CARBINE CLUB HANDICAP - 1950metres

GO DREAMING (C. Lindop) over-raced in the early stages of the event.

At the entrance to the straight PRINCE OF CAPERS (M. Dee) attempted to improve into a tight run between GO DREAMING (C. Lindop) to its outside and STIMULATTE (R. Hurdle), which rolled out slightly. As a consequence PRINCE OF CAPERS was inconvenienced, shifted out and brushed with GO DREAMING. Thereafter PRINCE OF CAPERS and GO DREAMING brushed for several strides.

STIMULATTE, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

D. Tourneur, the rider of WOAKWINE, reported, in his opinion, the gelding performed below expectations. WOAKWINE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 9 : MOET & CHANDON HANDICAP - 1250metres

CON'S GOLD (E. Boyd) raced keenly in the early stages of the race.

RIGHT IDEA (J. Frew) had difficulty obtaining clear running from in the vicinity of the 200 metres and was obliged to alter course to the outside of CON'S GOLD (E. Boyd) over the concluding stages.

RACE 9 : MOET & CHANDON HANDICAP - 1250metres (Cont'd)

K. Brooks, the rider of TRUE SASSO, reported she was concerned with the mare's action. TRUE SASSO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

E. Boyd, the rider of CON'S GOLD, was questioned regarding the use of her whip. She pleaded guilty to a charge under AR137A(4)(b) in that she used her whip in a manner that raised her arm above shoulder height over the concluding stages and was fined \$200.

SPOILSPOT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
