STIPENDIARY STEWARDS REPORT

Report on Race Meeting held at Clare Racecourse
by the Clare Valley Racing Club on Sunday, 8 March 2015

RACE 1 : TAYLOR'S WINES / SABOIS COLTS, GELDINGS AND ENTIRES MAIDEN PLATE - 1100 metres

On jumping away DANISH VALUE (T. O'Donnell) and SHARP THREADS (A. Herrmann) were inconvenienced when LITTLE SAMUEL (J. Potter) jumped away awkwardly and shifted out and JESSE 'N' JAMES (J. Toeroek) jumped away awkwardly and shifted in. As a result DANISH VALUE lost its position.

SEASIDE MANNER (E. Boyd) jumped away awkwardly and shifted out, bumping WHITE JADE (Z. Spain).

SHEPHERDING (A. Doyle) jumped away awkwardly.

SHARP THREADS (A. Herrmann) raced keenly in the early and middle stages of the event.

SEASIDE MANNER (E. Boyd) hung out throughout the event. SEASIDE MANNER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. T. Jolly, the Trainer of SEASIDE MANNER, was advised a warning has been placed on the gelding's racing manners.

RACE 2 : SUBWAY / SABOIS FILLIES AND MARES MAIDEN PLATE - 1100 metres

On arrival at the barriers ALL THE TIME, which struck the gate when leaving the mounting yard en route to the barriers, was examined by the Club's Veterinary Surgeon who ruled the mare fit to race.

The start of this race was delayed approximately three minutes owing to NO MERCY proving fractious in the barriers. NO MERCY was examined by the Club's Veterinary Surgeon who ruled the mare fit to race. The start was further delayed owing to NO MERCY then proving difficult to load. Mr. B. Bogarts, the Trainer of NO MERCY, was advised a warning has been placed on the mare's loading manners.

ALL THE TIME (A. Doyle) stood flat-foot and was very slow to begin. Mr. J. Dunn, the Trainer of ALL THE TIME, was advised a warning has been placed on the mare in relation to its starting manners.

SILVER MINT (T. Pannell) jumped away awkwardly and shifted in, brushing JUST ONE WISH (J. Matthews).

Shortly after the start JUST ONE WISH (J. Matthews) shifted in, bumping ONE TUFF CUPCAKE (T. Baker).

RACE 2 : SUBWAY / SABOIS FILLIES AND MARES MAIDEN PLATE - 1100 metres
(Cont'd)

In the vicinity of the 200 metres POLLYWAGON (Z. Spain) improved onto the heels of ONE TUFF CUPCAKE (T. Baker) and as a result shifted wider at the same time as DANCER'S DREAM (R. Stewart) shifted in to improve his position. As a consequence POLLYWAGON had to be steadied and lost its position. R. Stewart was severely reprimanded and advised to take greater care in future when shifting ground.

ONE TUFF CUPCAKE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : O'DEA ELECTRICAL RATING 0-68 HANDICAP – 1100 metres

JUAN TUFFAMIGO (J. Matthews) jumped away awkwardly.

NORTH BEACH (J. Frew) raced keenly in the early stages of the event.

Shortly after the start JUAN TUFFAMIGO (J. Matthews) bucked for a considerable distance and lost contact with the field. JUAN TUFFAMIGO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. D. Smedley, the Trainer of JUAN TUFFAMIGO, was advised the gelding would be required to race in a tractable manner in an Official Barrier Trial prior to accepting for a future race.

In the vicinity of the 800 metres NORTH BEACH (J. Frew) was momentarily inconvenienced when taken wider by DABAMIRAK (A. Doyle), which shifted out and away from CHARLIE'S PRINCESS (J. Potter).

From the vicinity of the 300 metres to the vicinity of the 200 metres MADIBA'S VISION (Z. Spain) was held up for clear running when racing on the heels of CHARLIE'S PRINCESS (J. Potter).

RACE 4 : CLARE VALLEY TOYOTA / SABOIS MAIDEN PLATE – 1800 metres

On arrival on course SAL'S SHINKO, which had not raced since July 2013, was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

In the vicinity of the 600 metres STEALTH MODE (A. Herrmann) had to be steadied and as a result was momentarily inconvenienced when SAL'S SHINKO (Z. Spain) shifted in and eased the pace of the race. Z. Spain was reprimanded under AR137(d) for excessively easing the pace.

In the vicinity of the 400 metres SAL'S SHINKO (Z. Spain) had to be steadied momentarily when STEALTH MODE (A. Herrmann) shifted out to improve around the heels of Direct Deal (J. Frew).

Z. Spain, the rider of SAL'S SHINKO, reported the gelding was inclined to lay out throughout the event. SAL'S SHINKO was examined by the Club's Veterinary Surgeon who reported fresh cuts to the corner of its mouth.

RACE 5 : MAYOR'S CUP / SABOIS FILLIES AND MARES RATING 0-68 HANDICAP - 1200 metres

As Stewards were able to identify BELLA TAHLEE from records held by them when the Thoroughbred Identification Card was not available for inspection, they permitted the mare to start. Mr. P. Sandford, the Trainer of BELLA TAHLEE, was fined \$50 under AR59A for failing to produce the Thoroughbred Identification Card.

TWILIGHT DANCER (A. Herrmann) jumped away awkwardly and as a result was slow into stride.

RACE 6 : MAGIC FM/5CS COLTS, GELDINGS & ENTIRES RATING 0-58 HANDICAP - 1800 metres

DAMAGE CONTROL (T. Baker) laid in under pressure in the straight.

In the vicinity of the 100 metres DAMAGE CONTROL (T. Baker), which was continuing to lay in under pressure, shifted in, inconveniencing KANGAROO JACK (J. Matthews). T. Baker was reprimanded and advised to take greater care in future when his mounts commence to shift ground.

KHAPTIVATA lost its off fore plate during the event.

DAMAGE CONTROL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

KHAPITVATA was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg as a result of losing its off fore plate during the event.

RACE 7 : JIM BARRY WINES RATING 0-58 HANDICAP - 1700 metres

After the field was dispatched from the barriers in this event it was established that, due to a mechanical malfunction with the tractor attached to the Barrier Gates, the barrier gates and the tractor would not be able to be moved from the track as is the usual practice. Having regard for the available running room in the vicinity of where the tractor and Barrier Gates were situated (200 metres), all riders in the event were alerted, in the vicinity of the 400 metres, to restrain their mounts and not continue riding competitively for the remainder of the event. All horses were subsequently eased out of the event. Subsequent to the event, Stewards, acting under AR.139, declared the race void at 4.52 pm.
