**RACE 1 : ATHOLY HOLLAND MEMORIAL / SABOIS MAIDEN PLATE - 1000 metres**

EAMADATA (L. Stojakovic) proved difficult to load. Trainer, Mr R. King advised Stewards that the gelding would be retired; nonetheless, he was advised that if the gelding returned to work it would be required to load without delay in an Official Barrier Trial prior to accepting for a future race.

HIGH CRESCENDO (D. Tootell) proved difficult to load and as the start was effected, stood flat-footed and lost considerable ground. Co-Trainer, Mr K. Frew, was advised the mare would be retired, nonetheless, he was advised that if the gelding returned to work it would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

DINNER CAMP (R. Mayers) and CRACKERJACK QUEEN (M. Henderson) were slow to begin.

DINNER CAMP (R. Mayers) raced greenly throughout the event.

**RACE 2 : LETCHER & MORONEY CHARTERED ACCOUNTANTS BENCHMARK 72 HANDICAP - 1000 metres**

After being loaded ARTHURIAN LEGEND broke through the front of the barriers and was immediately restrained. ARTHURIAN LEGEND was examined by the Club's Veterinary Surgeon who passed the gelding fit to start.

ARTHURIAN LEGEND (Z. Spain) was fractious in the barriers and slow to begin.

SUPERBAD (A. Doyle) was slow to begin.

Correct Weight for this event was delayed to allow Mr D. Courtney, the Trainer of HEZAFRAAR, to view the Official Photo finish. Correct Weight was further delayed as Z. Spain, the rider of ARTHURIAN LEGEND had made application for his mount to be declared a non-runner. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards determined that ARTHURIAN LEGEND had not been denied a fair start and was declared a runner.

**RACE 3 : STREAKY BAY RACING CLUB'S VALUED SPONSORS BENCHMARK 54**  
**HANDICAP - 1200 metres**

On arrival on course EXALTED ANGEL was examined by the Club's Veterinary Surgeon who reported the mare had a healing laceration to the hip and passed fit to race.

Mr T.Haddy, the Trainer of NEW WAVE, was questioned regarding his failure to produce his Thoroughbred Identification Card as required by the rules. As Stewards were able to confirm the identity of NEW WAVE from records held by them and its microchip, the gelding was permitted to start and Mr Haddy was fined \$50 under AR59A.

On jumping away NEW WAVE (A. Doyle) shifted out and brushed BLACK JUGAH (D. Tootell).

GOT TO HURRY (R. Mayers) was slow to begin.

A. Doyle, the rider of NEW WAVE, reported that in his opinion, his mount which was racing on a dirt surface for the first time, had not appreciated the kick back and as a result got its head up and raced ungenerously. He added, after being restrained in the early stages and eased to the outside of the field, the gelding commenced to race tractably.

GOT TO HURRY (R. Mayers) was inclined to lay out throughout the event.

NEW WAVE lost both fore plates during the event.

**RACE 4 : STREAKY BAY'S FABULOUS BEACHES RATING 0-62 HANDICAP**  
**- 1400 metres**

THE HEADMISTRESS (K. Brooks) was inclined to hang out throughout the event. THE HEADMISTRESS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Trainer Mr C. Cox was advised the mare was required to perform to the Stewards satisfaction in an Official Barrier Trial prior to presenting for a future race.

TIZZY LIZZY (Z. Spain) laid in under pressure in the straight. TIZZY LIZZY was examined by the Club's Veterinary Surgeon who reported the mare to be lame in both forelegs. Trainer, Ms N. Bruggemann, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

SWINGIN' DAZZLER (L. Stojakovic) became held up over the concluding stages inside the heels of TIZZY LIZZY (Z. Spain).

L. Stojakovic, the rider of SWINGIN' DAZZLER, reported that in her opinion, although she was unable to fully test her mount over the concluding stages, it had little left to offer.

**RACE 5 : XXXX GOLD STREAKY BAY COMMUNITY HOTEL CUP - 1800 metres**

TESTATE (G. Willoughby) was slow to begin.

SHADE OF GREEN (D. Tootell) raced ungenerously whilst being restrained in the early stages and hung out making the first turn.

VALUE AS (K. Bishop) shifted out under pressure in the straight inconveniencing TESTATE (G. Willoughby), which was weakening from the event. K. Bishop was reprimanded and advised in future to make a greater effort to correct he mounts when they commence to shift ground. VALUE AS was examined by the Club's Veterinary Surgeon who reported the gelding, whilst not lame, was displaying pain in the superficial digital flexor tendons on both

forelegs. Trainer, G. Bacchus was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

R. Mayers, the rider of COSTLY ARGUMENT, could offer no explanation for the disappointing performance. COSTLY ARGUMENT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 6 : STREAKY BAY & CEDUNA MEAT SERVICE / MARINE PRODUCTS LINCOLN ESTATE WINES BENCHMARK 54 HANDICAP - 1800 metres**

DAL ROMMEL (NZ) (G. Willoughby) began awkwardly and shifted out.

ETERNAL HEART (A. Doyle) began awkwardly, raced extremely ungenerously in the early stages and hung out making the first turn.

MISTAKEN VALUE (K. Bishop) made the first turn awkwardly.

LITTLE AUDREY (Z. Spain) over-raced in the early and middle stages of the event.

Correct Weight was delayed to allow G. Wiloughby, the rider of DAL ROMMEL (NZ), K. Brooks, the rider of VIA SAVOIA and S. Whittle, the Trainer of that gelding, to view the Official Footage of the start. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards were satisfied that both runners had been afforded a fair start.

LUSTEMAN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

DAL ROMMEL (NZ) WAS examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ROULETTE PRINCE was examined by the Club's Veterinary Surgeon who reported the gelding had sustained a cut to its tongue.
