RACE 1 : UBET ADELAIDE RACING CARNIVAL MAY 2015 HANDICAP - 1200 metres

The start of this event was delayed approximately two minutes owing to CRYSTAL RUBY, requiring resaddling on arrival at the barriers.

OUR LITTLE TREASURE (T. Pannell) was slow to begin and shortly after was inconvenienced by SHELBY APPLES (P. Gatt), which shifted in on jumping away.

CRYSTAL RUBY (H. Coffey) and ARROGANT CAT (J. Toeroek) raced keenly in the early and middle stages of the event.

SHELBY APPLES (P. Gatt) was held up from the vicinity of the 500 metres until approaching the 200 metres when awkwardly placed between the heels of CRYSTAL RUBY (H. Coffey) and ARROGANT CAT (J. Toeroek), which had both commenced to give ground.

ARROGANT CAT, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

SHELBY APPLES lost its near fore plate during the event.

RACE 2 : MOET & CHANDON HANDICAP - 1100 metres

SAGABELLA (T. Pannell) jumped away awkwardly and shortly after lost its position as TOM'S LUCK (S. Carr) shifted out on jumping away.

SAGABELLA (T. Pannell) over-raced in the early and middle stages of the event.

OGUNDE (E. Boyd) hung out over the concluding 700 metres of the event. OGUNDE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : MOET & CHANDON HANDICAP - 1100 metres (Cont'd)

SAGABELLA, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : HAPPY 95TH PEGGY MCKINNON HANDICAP - 2020 metres

GAMBLIN' GURU (J. Holder) shifted out on jumping away onto AMALGAMATE (A. Herrmann), which was hampered.

VIMA (T. Pannell) over-raced in the early and middle stages of the event.

In the vicinity of the 400 meters ASSIGN (IRE) (M. Payne) shifted out slightly onto CAPODECINA (J. Bowditch), which was tightened onto COUNT ENCOSTA (H. Coffey) resulting in these two runners coming together and making contact on several occasions approaching the 200 metres.

ASSIGN (IRE) (M. Payne) was inclined to lay in under pressure in the straight.

D. Tourneur, the rider of WOAKWINE, reported the gelding hung out throughout the event. WOAKWINE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Stewards questioned J. Holder, the rider of GAMBLIN' GURU, into his whip use in this event. After considering his explanation J. Holder pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in a forehand manner in consecutive strides prior to the 100 metres and was fined \$500. J. Holder also pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$500.

VIMA, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : DEQUETTEVILLE STAKES- 1050 metres

HAZY LANE (P. Gatt) reared on jumping away and was slow to begin.

SCHISM (T. Pannell) shifted out on jumping away and bumped PEARL STAR (M. Payne).

VIDDORA (J. Bowditch) shifted in on jumping away tightening TZAREVNA (E. Boyd) onto MADDIE MOO MOO (B. Rawiller).

MISTY WATERS shifted out abruptly on jumping away unbalancing rider J. Noonan who was unable to remain in the saddle and was dislodged shortly after the start.

MADDIE MOO MOO (B. Rawiller) laid in under pressure in the straight and inside the 200 metres shifted in abruptly behind the heels of VIDDORA (J. Bowditch), which was taken out by TYPHOON WITNESS (D. Tourneur), which shifted out under-riding. D. Tourneur was reprimanded and advised in future to make a greater effort to keep his mounts straight when they commence to shift ground. MADDIE MOO MOO was examined by the Club's Veterinary Surgeon who reported lacerations on both hind pasterns.

HAZY LANE lost its near hind plate during the event.

J. Bowditch, the rider of VIDDORA, explained the filly had travelled well in the early and middle stages of the event, however, in the vicinity of the 300 metres when placed under pressure, had failed to respond to his riding, had commenced to make excess respiratory

noise and finished the event off poorly. VIDDORA was examined by the Club's Veterinary Surgeon who reported the filly was making excess respiratory noise. Trainer, Mr L. Kennewell was advised the results of an endoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

MISTY WATERS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : PROJECTION GRAPHICS REDEL VA STAKES - 1100 metres

SILENT WHISPER (J. Noonan) jumped away awkwardly and was slow to begin.

IDATWO (J. Brown) jumped away awkwardly.

DUCKWORTH (M. Neilson) over-raced in the early and middle stages of the event.

As the pace steadied approaching the 600 metres BURGUNDY BLAST (C. Lindop) improved onto the heels of PUZZLE (M. Payne), which lost ground when DURENDAL (J. Winks) rolled in marginally away from GET THE NOD (J. Bowditch), resulting in BURGUNDY BLAST (C. Lindop) clipping the heels of PUZZLE (M. Payne), knuckled and losing its position.

In the vicinity of the 300 metres KALABEK (J. Holder) shifted out onto DURENDAL (J. Winks), which was taken out onto I AM GYPSY (S. Carr), which was forced to be checked, when taken out across the heels of GET THE NOD (J. Bowditch), which held its line. As a consequence SILENT WHISPER (J. Noonan), which was racing behind I AM GYPSY (S. Carr) was forced to be steadied and taken out onto WILANDER PRINCESS (S. Price), which was taken out contacting the hind quarters of ALCOBRO (J. Toeroek), which was inconvenienced. J. Holder pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Sunday, 19 April and to conclude at midnight Wednesday, 29 April 2015: a period of four (4) meetings.

Approaching the 200 metres ÉCLAIR CHOICE (D. Tourneur) shifted in under riding onto GET THE NOD (J. Bowditch), which was inconvenienced when taken in onto DURENDAL (J. Winks), which was forced to stop riding momentarily. D. Tourneur was reprimanded and advised in future to make a greater effort to keep his mounts straight when they commence to shift ground.

M. Neilson, the rider of DUCKWORTH, reported the gelding laid in severely over the concluding 600 metres. DUCKWORTH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

NOVEL DANCER was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

The track was downgraded to Soft 6 at 3.27 pm due to continued rain.

RACE 6 : HUGHES CHAUFFEURED LIMOUSINES R N IRWIN STAKES - 1100 metres

SCARLET BILLOWS (M. Payne) was slow to begin and failed to maintain contact with the field during the event.

DAYTONA GREY (C. Lindop) had difficulty obtaining clear ground in the early part of the straight.

RACE 6 : HUGHES CHAUFFEURED LIMOUSINES R N IRWIN STAKES - 1100 metres
(Cont'd)

M. Payne, the rider of SCARLET BILLOWS, reported the mare had not felt comfortable in its action in the early stages of the event and she had allowed the mare to settle in an attempt to recorrect, however, SCARLET BILLOWS was reluctant to race and for this reason she had not ridden the mare out in her normal manner. SCARLET BILLOWS was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off hind leg and a lower than expected heart rate. Trainer D. Weir was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

B. Rawiller, the rider of PLATELET, which performed below expectations, explained the mare had travelled well in the early and middle stages of the event, however, when placed under pressure at the entrance to the straight, had failed to respond in its normal manner and finished the event of poorly. PLATELET was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

The track was downgraded to Soft 7 at 4.00 pm due to continued rain.

RACE 7 : SCHWEPPERVESENCE STAKES - 1800 metres

The start of this event was delayed approximately two minutes owing to ALBORBROWN having to be resaddled on arrival at the barriers.

HIPSTER GIRL (P. Gatt) was slow to begin.

At the entrance to the straight MONOPOLE (B. Claridge) shifted out and contacted HIPSTER GIRL (P. Gatt), which was inconvenienced.

At the entrance to the straight REDASUN (C. Lindop) shifted out and bumped FITOCRACY (T. Pannell).

In the vicinity of the 300 metres FINDA FITTER FILLY (S. Price) rolled in and inconvenienced CATHY'S MARK (J. Winks).

Approaching the 200 metres ONDINA (B. Spriggs) shifted out under pressure momentarily inconveniencing DEANNA JEAN (J. Potter).

ALBORBROWN lost its off fore plate on jumping away.

S. Price, rider of FINDA FITTER FILLY, was questioned regarding his use of the whip in the straight. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

INTO THE MIST, which performed poorly, was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the near foreleg. Trainer T. McEvoy was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

RACE 8 : DRINK DRIVING? GROW UP HANDICAP - 1600 metres

Acting on advice from Trainer Mr D. Jolly that HEIRDOM had turned a plate, injured its near hind hoof and would be unfit to race, Stewards withdrew the gelding at 8.34 am.

Mr J. O' Connor, the Trainer of HERE TO THERE (NZ), put a submission to Stewards that the gelding be a late scratching due to the track downgrade. Stewards acceded to this request and withdrew HERE TO THERE (NZ) at 3.30 pm.

RACE 8 : DRINK DRIVING? GROW UP HANDICAP - 1600 metres (Cont'd)

LADY SILHOUETTE (S. Price) and CAVALOCE (C. Lindop) both jumped away awkwardly and were slow to begin.

In the vicinity of the 1200 metres the pace slackened resulting in CAVALOCE (C. Lindop), SLIPPERY NINJA (R. Stewart), REGAL MAGNUS (B. Claridge) and LADY SILHOUETTE (S. Price) over racing for a number of strides.

S. Price, the rider of LADY SILHOUETTE, which performed below expectations, explained that after being slow to begin the mare had only travelled fairly in the early and middle stages of the event and when placed under pressure, it failed to respond to his riding and in his opinion, had not handled the track condition. LADY SILHOUETTE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

B. Claridge, the rider of REGAL MAGNUS, reported that in his opinion the filly had held its breath during the running of the event. REGAL MAGNUS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
