# RACE 1 : ADELAIDE GALVANISING INDUSTRIES MAIDEN PLATE - 1054 metres

# RACE 2 : FIRST DEGREE / SABOIS THREE-YEAR-OLD MAIDEN PALTE - 1208 metres

Acting on confirmed telephone call from Ms K. Byrnes that EXALTED BLOOM, injured itself en route to the course, Stewards withdrew EXALTED BLOOM at 10.50 am,

The start of this event was delayed approximately two minutes owing to AETHER proving difficult to load. Trainer, Mr J. MacMillan was advised a warning had been placed on the colt regarding its loading manners.

SHOW SET (A. Herrmann) jumped away awkwardly and shifted out inconveniencing TRENTPARK (S. Carr).

LETHAL LILY (A. Doyle) and HEIDI STAR (J. Toeroek) were taken wider.

PERUVIAN POWER (K. Bishop) over-raced in the early and middle stages of the event.

In the vicinity of the 200 metres SHOW SET (A. Herrmann) had to momentarily steady when SCHOONER WON (J. Matthews) shifted in under pressure.

TRENTPARK, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

# RACE 3 : JACOBS CREEK DOUBLE BARREL / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE - 1408 metres

Acting on confirmed telephone call from Ms K. Byrnes that EXALTED LILY, injured itself en route to the course, Stewards withdrew EXALTED LILY at 10.50 am,

Acting on confirmed telephone call from Mr J. Smith that LAST MOMENT was lame; Stewards withdrew the mare at 8.00 am.

From the vicinity of the 800 metres to the vicinity of the 600 metres LAST MOMENT (T. Pannell) was awkwardly placed on the heels of MISS EEJAY (M. Neilson).

#### RACE 4 : WOODSTOCK RATING 0-68 HANDICAP - 1408 metres

KINETIC ENERGY (J. Toeroek), GWYDIR (A. Doyle), HE'LL TELL US (E. Boyd) and ROCHERE (K. Bishop) jumped away awkwardly.

TOKEN ONE (R. Mayers) was slow to begin.

RIGHT IDEA (S. Carr) raced keenly in the early and middle stages of the event.

URBAN BOURBON, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 5 : MY BUTCHER MURRAY VALLEY GOLD RATING 0-62 HANDICAP - 1208 metres

CHAMBRAY (A. Herrmann) jumped away awkwardly and shifted out bumping ZIPNOTIZED (C. Jokic).

EXALTED JOURNEY (C. Lindop) was inclined to lay in throughout the event.

Approaching the 200 metres DULCIE JANE (J. Bowditch) shifted out, inconveniencing MASTER BLACK (R. Hurdle), CANNES CONI (B. Claridge) and CANON DIABLO (C. Jones), which were all taken wider. J. Bowditch was reminded of his obligations when shifting ground in future.

EXALTED JOURNEY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CANON DIABLO, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 6 : AUSSIE CIDER / SABOIS FILLIES & MARES RATING 0-68 HANDICAP - 1408 metres

Mr G. Carter, the Trainer of BOURBONDETTA, advised Stewards that he would instruct its rider to settle, if possible, forward of mid field with cover.

Mr J. MacMillan, the Trainer of NOVEL IDEA, advised Stewards that he would instruct its rider to ride the filly more quietly in the early stages of the event and to attempt to settle mid field with cover.

MORE READY (D. Tootell) jumped away awkwardly and shifted out brushing CERASTIUM (A. Doyle).

# RACE 6 : AUSSIE CIDER / SABOIS FILLIES - 1408 metres (Cont'd)

MAGIDUE (E. Boyd) and ZERPRISE JOURNEY (C. Lindop) both raced ungenerously in the early and middle stages of the event.

In the vicinity of the 900 metres SCHADUW (D. Tourneur) had to momentarily steady and raced ungenerously for a short distance on the heels of MORE READY (D. Tootell), which shifted ground inwards. D. Tootell was reprimanded and advised to take greater care when shifting ground in future.

At the entrance to the home straight NOVEL IDEA (J. Bowditch) was racing on the heels of MORE READY (D. Tootell) and was unable to obtain clear running until approaching the 200 metres.

BOURBONDETTA (G. Willoughby) was inclined to lay in under pressure in the straight.

SCHADUW, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 7 : COOPERS CELEBRATION ALE / SABOIS PLUS BENCHMARK 72 HANDICAP - 2210 metres

The start of this event was delayed approximately three minutes owing to UMALUKA proving fractious in the barriers. UMALUKA was examined by the Club's Veterinary Surgeon who passed the gelding fit to race. Trainer, Mr K. Buick, was advised a warning had been placed on the gelding in regards to its barrier manners.

IN TAIPEI, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

R. Hurdle, the rider of RUNALUK, pleaded guilty to a charge under AR145 in that he weighed in more than half a kilogram over his allotted weight. R. Hurdle was fined \$200.

NOVIKOV, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported the gelding to have a lower than expected heart rate.

UMALUKA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

# RACE 8 : BIRNIE SANDERS HOTEL BROKER RATING 0-68 HANDICAP - 1608 metres

Acting on confirmed telephone call from Ms K. Byrnes that EXALTED TOBY, injured itself en route to the course, Stewards withdrew EXALTED TOBY at 10.50 am,

GRAND GROUP (D. Caboche) and DEVARICH (A. Herrmann) were slow to begin.

REWIND TIME (M. Neilson) raced ungenerously in the early and middle stages of the event.

DEVON (S. Cahill) was inclined to hang out throughout the event.

In the vicinity of the 300 metres DEVON (S. Cahill), which was continuing to hang out, inconvenienced TUNISIA TRAVELLER (T. Baker), which as a result had to be steadied and lost its position.

DEVON was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
