## THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

# Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 16 May 2015

#### RACE 1 : SEVEN NEWS NATIONAL STAKES - 1200 metres

The start of this race was delayed approximately five minutes owing to SHINING BROOKE, which lost its near fore plate en route to the barriers, requiring Farrier attention. SHINING BROOKE was examined by the Club's Veterinary Surgeon who ruled the filly fit to race.

SPIRITED MATCH (T. Pannell) and BADAJOZ (G. Boss) jumped away awkwardly.

Approaching the 1000 metres EVIL DREAMS (J. Toeroek) shifted in taking BADAJOZ (G. Boss) in, resulting in BADAJOZ having to be checked to avoid the heels of EVIL DREAMS. As a consequence BADAJOZ shifted in and contacted STRYKUM (B. Melham), turning that filly's hindquarters. J. Toeroek pleaded guilty to a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 23 May and to conclude at midnight on Wednesday, 3 June 2015; a period of five (5) meetings.

BADAJOZ (G. Boss) was held up for clear running from in the vicinity of the 500 metres when racing behind STRYKUM (B. Melham) and to the inside of EVIL DREAMS (J. Toeroek) and was only able to obtain clear running inside the 200 metres.

In the vicinity of the 500 metres EVIL DREAMS (J. Toeroek) shifted out and away from STRYKUM (B. Melham) onto BEAU RIVAGE (J. Matthews), which rolled out slightly onto SPRINGFIELD LEW (J. Potter), which was inconvenienced.

In the vicinity of the 150 metres ATALANTA MISS (M. Payne) was disappointed for clear running for a number of strides when racing behind BEAU RIVAGE (J. Matthews) and COUNTER PULSE (C. Lindop).

EVIL DREAMS was examined by the Club's Veterinary Surgeon who reported the gelding had been galloped on the near hind leg. First Aid was administered.

#### RACE 1: SEVEN NEWS NATIONAL STAKES - 1200 metres (Cont'd)

STRYKUM, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Subsequent to the event SHINING BROOKE was again examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 2: JAPAN TROPHY - 2500 metres

REMORSE (C. Parnham) stood flat-footed at the start and lost approximately four to five lengths.

REMORSE (C. Parnham) and BELVEDERE ROAD (G. Boss) raced wide without cover in the middle stages of the event.

ZANTECA (NZ) was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the near hind leg. Mr. D. Weir, the Trainer of ZANTECA (NZ), was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

BELVEDERE ROAD was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### RACE 3: WILLIAM HILL SA FILLIES CLASSIC - 2500 metres

On arrival on course SNOW SECRET (NZ) was examined by the Club's Veterinary Surgeon who ruled the filly fit to race.

KEEP THE KLASS (NZ) (M. Payne) was slow to begin.

In the vicinity of the 2000 metres CINNAMON CARTER (J. Bowditch), which was racing keenly, raced in restricted room to the inside of SNOW SECRET (NZ) (G. Boss), which shifted in to improve, got its head up when being restrained and was ungenerous for several strides. G. Boss was reprimanded and advised to take greater care when shifting ground in future.

At the entrance to the straight TRY YOUR BEST (NZ) (D. Tourneur) shifted out to improve and contacted BAHAMAS (D. Oliver), resulting in that filly's hindquarters being turned. D. Tourneur was reprimanded and advised to take greater care when shifting ground in future.

Over the concluding stages OKAHU BAY (M. Neilson) shifted out under riding and crossed the running of SNOW SECRET (NZ) (G. Boss), which had to be checked to avoid that filly's heels. As a consequence MONOPOLE (J. Holder), which was following, was untested over the concluding stages. M. Neilson pleaded guilty to a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 23 May and to expire at midnight on Wednesday, 3 June 2015; a period of five (5) meetings.

C. Williams, the rider of UNGRATEFUL ELLEN, explained his instructions and intentions were to settle mid-field with cover, however, owing to the filly beginning better than expected, he was unable to obtain cover mid-field and was obliged to follow SNOW SECRET (NZ) (G. Boss) into the run. He added that in his opinion the pace was only moderate in the early stages and as a consequence he was trapped wide without cover for most of the event and was unable to obtain cover. He further stated notwithstanding the fact he was unable to obtain his preferred position in running, the filly responded in a respectable manner but did not finish the race off in its normal manner.

### RACE 4: MITTYS CENTAUREA STAKES - 2000 metres

On arrival at the barriers ANFITRIONA required resaddling.

CLEAR DIRECTION (NZ) (H. McKechnie) jumped away awkwardly and shifted out, inconveniencing AVA'S DELIGHT (M. Payne).

Approaching the entrance to the straight MARIANNE (NZ) (D. Oliver) shifted out to improve and brushed with STAR FASHION (M. Neilson) taking that mare wider on the track.

LADY CUMQUAT (M. Zahra) was held up for clear running shortly after the entrance to the straight until in the vicinity of the 200 metres.

Shortly after the entrance to the straight GIRL IN FLIGHT (M. Allen) shifted in to improve and inconvenienced SPECIAL MISS (NZ) (T. Pannell), which was obliged to be steadied. M. Allen was reprimanded and advised to take greater care when shifting ground in future.

MARIANNE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 5: WILLIAM HILL PROUD MISS STAKES - 1200 metres

SPIRITS DANCE proved fractious in the barriers after being loaded. Mr. D. Jolly, the Trainer of SPIRITS DANCE, was advised a warning had been placed on the mare and should it perform in a similar manner in future, action may be taken against it.

In the vicinity of the 300 metres NATURAL DISASTER (P. Gatt) shifted out and crossed the running of DANESTROEM (C. Williams), which had to be steadied. P. Gatt, was severely reprimanded and advised to take greater care when shifting ground in future.

C. Williams, the rider of DANESTROEM, explained his mount slipped behind on jumping away and as a consequence he was unable to take up a more forward position as intended.

I LOVE IT, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 6: HUGHES CHAUFFEURED LIMOUSINES R A LEE STAKES - 1600 metres

Mr. C. Bieg, the Trainer of EXCITES ZELADY, advised Stewards he would instruct Jockey P. Gatt to attempt to settle mid-field or back with cover in an effort to have the gelding finish the race off better than it has in recent runs.

QADIR (J. Holder) was slow to begin.

METAPHORICAL (G. Boss) was held up for clear running from the entrance to the straight when racing behind JAPHILS (D. Yendall) and DYLANSON (C. Lindop) and was only able to obtain clear running in the vicinity of the 150 metres.

In the vicinity of the 100 metres TEXT'N HURLEY (C. Williams) shifted out to improve taking FLOW METER (R. Stewart) out onto GRIS CARO (GB) (B. Melham), which was inconvenienced and had to be steadied. C. Williams was reprimanded and advised to take greater care when shifting ground in future.

B. Melham, the rider of GRIS CARO (GB), reported the horse hung out throughout the event.

OUR IVANHOWE (GER) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 7: DARLEY GOODWOOD - 1200 metres

UNDER THE LOUVRE (M. Zahra) jumped away awkwardly and shifted out onto GREGERS (C. Williams), which was taken out onto BLACK HEART BART (G. Smith), which was inconvenienced.

IT IS WRITTEN (M. Allen) over-raced in the early stages of the event.

HUCKLEBUCK (D. Tourneur) raced keenly in the early stages of the event.

DAYTONA GREY (C. Lindop) raced wide without cover throughout the event.

Approaching the 200 metres UNDER THE LOUVRE (M. Zahra) shifted out to improve and tightened RIZIZ (P. Gatt) onto DAYTONA GREY (C. Lindop), which was taken out onto the heels of LUCKY HUSSLER (G. Boss), which shifted in marginally, resulting in DAYTONA GREY having to be checked to avoid the heels of that gelding. As a consequence RIZIZ continued to race in restricted room between DAYTONA GREY and UNDER THE LOUVRE, which continued to shift out, and had to be checked. M. Zahra was found guilty of a charge of Careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 23 May and to conclude at midnight on Sunday, 7 June 2015; a period of seven (7) meetings.

HUCKLEBUCK, which lost its near fore plate at the start, was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mr. P. Stokes, the Trainer of HUCKLEBUCK, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

LUCKY HUSSLER was examined by the Club's Veterinary Surgeon who reported the gelding had been galloped on the near hind heel. First Aid was administered.

## RACE 8 : DRINK DRIVING? GROW UP SA SPRINT SERIES FINAL - 1100 metres

LAST DAY (NZ) (M. Neilson) was tightened at the start between RIFLEMAN (M. Zahra) and ILGATTINO (D. Oliver), which both shifted ground, and lost its position.

Inside the 800 metres WANAEA (C. Lindop), which had commenced to over-race, was obliged to be steadied to avoid the heels of RIFLEMAN (M. Zahra) as that gelding was taken in by DAUNTING DANCER (E. Boyd), which shifted in. E. Boyd was reprimanded and advised to take greater care when shifting ground in future.

At the entrance to the straight LAST DAY (NZ) (M. Neilson) shifted out to improve and contacted DEL PRADO (C. Parnham), which was taken wider.

In the vicinity of the 300 metres WANAEA (C. Lindop) had difficulty obtaining clear running when racing behind BOLD SENATOR (R. Stewart) and DOUBLE POCKETS (S. Price).

Approaching the 200 metres HEART OF A LION (J. Bowditch) shifted in to improve taking RHINESTONE RUBY (J. Toeroek) in across the running of SAGABELLA (J. Potter), which had elected to improve to the outside of RHINESTONE RUBY and shifted out. As a consequence RHINESTONE RUBY was inconvenienced. J. Bowditch was reprimanded and advised to take greater care when shifting ground in future. Shortly thereafter, approaching the 100 metres, HEART OF A LION continued to shift in across the running of TARCO (J. Holder), resulting in TARCO having to be steadied to avoid the heels of HEART OF A LION. As a consequence T. Pannell, the rider of READY SUNSHINE, which was following, was unable to ride his mount in his normal manner over the concluding stages of the event. J. Bowditch pleaded guilty to a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 23 May and to conclude at midnight on Wednesday, 3 June 2015; a period of five (5) meetings.

#### RACE 8 : DRINK DRIVING? GROW UP SA SPRINT SERIES FINAL - 1100 metres (Cont'd)

MISS JOOLIA (H. McKechnie) had difficulty obtaining clear running in the vicinity of the 200 metres when awkwardly placed between the heels of CON'S GOLD (P. Gatt) and LAST DAY (NZ) (M. Neilson).

In the vicinity of the 100 metres AURUMCERT (J. Noonan) was unable to obtain clear running for a short distance.

Over the concluding stages ILGATTINO (D. Oliver) shifted in onto DOUBLE POCKETS (S. Price) taking that gelding in onto WANAEA (C. Lindop), resulting in DOUBLE POCKETS having to be steadied to avoid the heels of ILGATTINO. D. Oliver was reminded of his obligations when shifting ground in future.

ILGATTINO and RHINESTONE RUBY were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### **GENERAL:**

Jockey R. Stewart was questioned regarding his failure to arrive on course to fulfil his engagement in Race 5. After considering his explanation, Stewards reprimanded R. Stewart under AR85B and reminded him in future he should advise the Stewards he would be arriving late.

#### RACE 7 : DARLEY GOODWOOD - 1200 metres

As the Thoroughbred Identification Card for BLACK HEART BART was not available as required by the Rules, Stewards permitted the gelding to race when they were able to identify it from records held by them. Mr. V. Sigley, the Trainer of BLACK HEART BART, was fined \$100 under ARR.59A.
