**RACE 1 : BAROSSA FUNERALS / SABOIS DISTANCE MAIDEN PLATE – 2100 metres**

Inside the 1700 metres COMMAND THE SUN (T. Zanker) got its head up when being restrained and raced ungenerously for a number of strides.

DAKASHA'S PRIDE and HE'S EINSTEIN were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 2 : COOPERS CLEAR / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1100 metres**

ASCENDANCE (M. Neilson) jumped away awkwardly and then over-raced in the early stages of the event.

Approaching the 900 metres GALAXY GAZER (C. Lindop), which was racing greenly, commenced to lay in and became awkwardly placed on the heels of LUNCH BREAK (J. Potter) and had to be restrained.

Shortly after the entrance to the straight STEVIE GEE (T. Pannell), which raced greenly, rolled in and inconvenienced GALAXY GAZER (C. Lindop), which was taken in.

M. Neilson, the rider of ASCENDANCE, explained the gelding did not begin as well as he expected but notwithstanding this fact he was able to settle in a forward position as intended. He added the gelding over-raced in the early stages, placing him at a disadvantage. ASCENDANCE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 3 : IAN GORE 60TH BIRTHDAY / SABOIS MAIDEN PLATE - 1200 metres**

Mr. J. MacMillan, the Trainer of FORGET THE POSSE, advised Stewards he would instruct Jockey T. Pannell to attempt to settle where comfortable with cover.

The start of this event was delayed approximately four minutes owing to HOSTILE requiring Farrier attention on arrival at the barriers after it was established the gelding had lost its near fore plate en route to the start. HOSTILE was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

**RACE 3 : IAN GORE 60TH BIRTHDAY / SABOIS MAIDEN PLATE - 1200 metres**  
**(Cont'd)**

CLAREMONT KID (A. Doyle) jumped away awkwardly and shifted out onto LAND OF THE FREE (P. Gatt), which was tightened onto SILVER ILLUSION (A. Herrmann), which was taken out onto the heels of LONDON TRADER (D. Tourneur), resulting in SILVER ILLUSION being unable to maintain its position.

Approaching the 400 metres PLAYBOY LANE (S. Cahill) improved into a run between SILVER ILLUSION (A. Herrmann) and MAGGIE'S CALL (C. Jones). Shortly thereafter both SILVER ILLUSION and MAGGIE'S CALL rolled marginally, resulting in PLAYBOY LANE racing in restricted room for a number of strides and being unable to maintain its position.

From in the vicinity of the 500 metres CLAREMONT KID (A. Doyle) laid out.

Inside the 300 metres MAGGIE'S CALL (C. Jones) laid out and shifted out into the running of SILVER ILLUSION (A. Herrmann), which was obliged to be steadied to avoid the heels of MAGGIE'S CALL. C. Jones pleaded guilty to a charge of Careless Riding under AR137(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 17 May and to conclude at midnight on Wednesday, 27 May 2015; a period of four (4) meetings.

***Following this event, the track was upgraded to Good 4 at 1.40 pm, retrospective to Race 3.***

**RACE 4 : SPORTSBET – WATCH LIVE RACING ON MOBILE / SABOIS F&M MAIDEN PLATE - 1100 metres**

J. Maund, who was dislodged from his mount PRINCESS COSTA en route to the barriers, was examined by the First Care medical personnel and ruled fit to fulfil his engagement.

In the vicinity of the 800 metres PRINCESS COSTA (J. Maund) was obliged to be steadied when awkwardly placed inside the heels of JESSIE'S OWN (T. Pannell).

Z. Spain, the rider of AERONUT, reported the mare hung out throughout the event. AERONUT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

WHISPERING WILLOW was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 5 : HOLIATT DAANT RATING 0-58 HANDICAP - 1100 metres**

A. Doyle, who was dislodged from his mount WARRASIDE en route to the barriers, was examined by the First Care medical personnel and ruled fit to fulfil his engagement.

SATURDAY'S CHILD (K. Brooks) jumped away awkwardly and shifted in onto I DREAM OF GINA (D. Caboche), tightening that mare onto LADY HEDERAJ (E. Boyd), resulting in I DREAM OF GINA losing its position.

In the vicinity of the 200 metres RUGGED ANGEL (J. Toeroek) rolled in onto EXALTED ROSE (K. Bishop) at the same time as FIRST CLASS FLYER (C. Jones), which was hanging out, rolled out, resulting in EXALTED ROSE being inconvenienced.

FIRST CLASS FLYER (C. Jones) and THE KUNUNURRA KID (R. Hurdle) hung out throughout in the straight.

### **RACE 5 : HOLIATT DAANT RATING 0-58 HANDICAP - 1100 metres (Cont'd)**

Returning to the mounting enclosure, K. Brooks was dislodged from SATURDAY'S CHILD. SATURDAY'S CHILD galloped for a short distance before being caught by the Clerks of the Course. K. Brooks was examined by the First Care medical personnel who ruled her fit to fulfil her remaining engagements.

Z. Spain, the rider of CHOSEN FRIEND, reported the gelding hung out during the event.

### **RACE 6 : WATERSEARCH RATING 0-58 HANDICAP - 1700 metres**

JUST A SPARK (A. Doyle) reared as the start was effected and was slow to begin.

E. Boyd, the rider of SHOWVIZ, explained her instructions were to be positive early. She added that despite her wide barrier she was able to take up a forward position as intended and was aware of the position of MAGISUE (K. Brooks), which had extended its lead on the field, but was comfortably satisfied with the tempo she had established during the early and middle stages. She also stated that on straightening the mare did not finish the race off as expected and was disappointing. SHOWVIZ was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

K. Brooks, the rider of MAGISUE, explained her instructions were to take up an early lead and establish a break on the field in the early stages, attempt to settle in the middle stages and then make her run from inside the 800 metres.

### **RACE 7 : GOLDFIN FARMS BAROSSA CUP - 1700 metres**

The start of this event was delayed approximately two minutes owing to HIOCTDANE requiring Farrier attention on arrival at the barriers when the gelding lost its near fore plate en route to the start. HIOCTDANE was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

LITTLE AKIE (S. Price) over-raced in the early and middle stages of the event.

FREE THE WIND (E. Boyd) laid in, in the straight.

LITTLE AKIE (S. Price) was eased out of the event near the entrance to the straight and S. Price did not ride the gelding in his normal manner to the finish. S. Price explained the gelding commenced to lay in from in the vicinity of the 700 metres and felt sore in its action and for that reason he did not persevere with his riding in the straight as he felt something may be amiss with the gelding. LITTLE AKIE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 8 : BALLYCROFT VINEYARDS & CELLARS / SABOIS FILLIES & MARES RATING 0-68 HANDICAP - 1200 metres**

SWEDISH BITTERS (E. Boyd) jumped away awkwardly.

Shortly after the start EMMOOKI'S STAR (S. Cahill) and WILD RUN (A. Doyle) contacted when both horses shifted ground slightly.

WILD RUN (A. Doyle) commenced to pull very hard and was difficult to restrain from in the vicinity of the 900 metres and became awkwardly placed on the heels of BOLDACIOUS GIRL (R. Stewart) until in the vicinity of the 700 metres. As a consequence of racing ungenerously WILD RUN rolled about, shifted ground and contacted LADY ANDRESS (NZ) (P. Gatt) on several occasions.

**RACE 8 : BALLYCROFT VINEYARDS & CELLARS / SABOIS FILLIES & MARES RATING**  
**0-68 HANDICAP - 1200 metres (Cont'd)**

LADY ANDRESS (NZ) (P. Gatt) was eased out of the event from in the vicinity of the 200 metres. P. Gatt explained the filly travelled well in the early stages of the event, commenced to lay in from in the vicinity of the 600 metres and when asked for an effort at the entrance to the straight, continued to lay in and in his opinion felt uncomfortable in its action and for that reason he did not persevere with his riding from in the vicinity of the 200 metres as he felt something may be amiss with the filly. LADY ANDRESS (NZ) was examined by the Club's Veterinary Surgeon who reported an elevated heart rate.
