**RACE 1 : ALAN SHEPPARD CONSTRUCTIONS TWO-YEAR-OLD HANDICAP**  
**- 1000 metres**

HOT GOSSIP (T. Pannell) shifted out on jumping away and contacted BEAU RIVAGE (P. Gatt).

METIER (M. Nielson) shifted out on jumping onto BANNEKER (J. Beriman), which was taken out tightening HEARTZ ABLAZE (J. Toeroek) onto ROYAL RUMBLE (J. Holder), which was hampered. As a result HEARTZ ABLAZE lost its position.

Inside the 300 metres ROYAL RUMBLE (J. Holder) was disappointed when attempting a run between the heels of HEARTZ ABLAZE (J. Toeroek) and HOT GOSSIP (T. Pannell), which rolled out.

ENCHANTING BEAUTY (C. Lindop) laid in under pressure in the straight and approaching the 100 metres was obliged to alter course when HEARTZ ABLAZE (J. Toeroek) shifted out slightly as ENCHANTING BEUTY (C. Lindop) continued to lay in.

In the vicinity 50 metres ROYAL RUMBLE (J. Holder) improved onto the heels of NITRO NICK (D. Stackhouse) which had commenced to give ground and was obliged to alter course to that colts inside.

D. Stackhouse, the rider of NITRO NICK reported that the colt had raced keenly in the early and middle stages of the event.

NITRO NICK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ENCHANTING BEAUTY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

HOT GOSSIP, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 2 : HUGHES CHAUFFEURED LIMOUSINES THREE-YEARS-OLD HANDICAP -**  
**1300 metres**

DUCKWORTH (S. Carr) and ROCKET COMMANDER (P. Gatt) jumped away awkwardly.

ALCOBRO (J. Toeroek) and DUANEO (J. Beriman) came together and bumped on jumping away.

ALCOBRO (J. Toeroek) raced keenly in the early and middle stages of the event.

Rounding the turn in the vicinity of the 900 metres BLACK CAESAR (J. Holder) rolled in slightly onto DUCKWORTH (S. Carr), which was inconvenienced for a short distance.

Inside the 100 metres DUCKWORTH (S. Carr) was forced to race in restricted room for a number of strides when FLINDERS BEAUTY (T. Pannell) rolled in.

S. Carr, the rider of DUCKWORTH, explained she had been instructed to settle more forward in today's event, however, after jumping away awkwardly, she found herself in the rear of the field. She added after being inconvenienced near the 900 metres the gelding had travelled on and off the bit and when placed under pressure in the straight, had finished the event off well. DUCKWORTH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 3 : MCMAHON SERVICES THREE-YEAR-OLD BENCHMARK 70 HANDICAP -**  
**1550 metres**

SOLID BULLET (J. Holder) jumped away awkwardly and was slow into stride.

In the vicinity of the 1200 metres BEAU'S MY BOY (T. Pannell) shifted in when insufficiently clear of ZERPRISE JOURNEY (C. Lindop), which was forced to check to avoid that gelding's heels. As a consequence ILOVEWHATSEBRINGS (M. Neilson), which was racing behind ZERPRISE JOURNEY had to be steadied and in doing so rolled in onto CLUB STAR (D. Stackhouse), which was forced to be steadied for several strides. T. Pannell pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Saturday, 30 May and to conclude at midnight on Sunday, 7 June 2014: a period of four (4) meetings.

CLUB STAR (D. Stackhouse) had difficulty obtaining clear ground from the vicinity of the 500 metres until the entrance to the straight when racing behind ILOVEWHATSEBRINGS (M. Neilson) and inside PEPPER THE PIN (S. Carr).

SOLID BULLET (J. Holder) was inclined to lay in under pressure in the straight.

T. Pannell the rider of BEAU'S MY BOY pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

P. Gatt, the rider of REGAL MAGNUS, reported he had become concerned with the filly's action approaching the 200 metres and for that reason had not ridden out in his normal manner. REGAL MAGNUS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

E. Boyd, the rider of POLLYWAGON, reported to Stewards that her saddle had shifted to the off side shortly after the start, placing her at a slight disadvantage for the remainder of the event.

PEPPER THE PIN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 3 : MCMAHON SERVICES THREE-YEAR-OLD BENCHMARK 70 HANDICAP - 1550 metres (Cont'd)**

CLUB STAR was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

**RACE 4 : MERCEDES-BENZ ADELAIDE BENCHMARK 82 HANDICAP - 1950 metres**

The start of this event was delayed approximately one minute owing to SAHARA SYMPHONY becoming fractious on leaving the mounting yard, dislodging T. Pannell. T. Pannell was examined by the First Care Medical Personnel and passed fit to ride. SAHARA SYMPHONY was examined by the Club's Veterinary Surgeon and passed fit to race.

GLACIAL AGE (IRE) (J. Beriman) and CAPODECINA (M. Neilson) raced keenly in the early and middle stages of the event.

MISS WYNETTE (J. Holder) had difficulty obtaining clear ground and became held up in the vicinity of the 500 metres until inside the 200 metres.

D. Tourneur, the rider of HELD HOSTAGE, which performed poorly, explained the mare had travelled well in the early and middle stages of the event, however, when placed under pressure in the vicinity of the 600 metres had failed to respond to his riding and had finished the event off poorly. He added, in his opinion, HELD HOSTAGE may not have appreciated the quick back up. HELD HOSTAGE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Z. Spain, the rider of LITTLE AUDREY reported the mare was inclined to lay out throughout the event. LITTLE AUDREY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 5 : MIDDY'S DATA & ELECTRICAL RATING 0-72 HANDICAP - 1400 metres**

Mr R. Balfour, trainer of UNSPUN, advised Stewards that he would instruct rider T. Pannell to attempt to obtain a position mid-field with cover in this event, rather than settle on pace as it had at its most recent start.

UNSPUN (T. Pannell) jumped away awkwardly and was slow to begin.

ON A DREAM (S. Carr) raced keenly in the early and middle stages of the event.

From the entrance to the straight until inside the 300 metres SATURDAY SORCERER (P. Gatt) had difficulty in obtaining clear ground when awkwardly placed on the heels of ON A DREAM (S. Carr), which rolled out and inside WAPPING (S. Price).

PRIMITIVE MAN, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Trainer Mr G. Searle was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

**RACE 6 : THOMAS FARMS RATING 0-72 HANDICAP - 1250 metres**

Shortly after the start MEADOWS ANGEL (T. Pannell) was inconvenienced and unable to maintain its position when tightened between FORCE OF THREE (S. Price), which shifted in slightly at the same time as GET PRONTO (K. Bishop) shifted out slightly.

### **RACE 6 : THOMAS FARMS RATING 0-72 HANDICAP - 1250 metres (Cont'd)**

MEADOWS ANGEL (T. Pannell), GET PRONTO (K. Bishop) and SCHADUW (D. Tourneur) raced keenly in the early and middle stages of the event.

Approaching the 200 metres SCHADUW (D. Tourneur) shifted in onto ANNANDALE LASS (P. Gatt), which had to be steadied for a short distance. D. Tourneur was severely reprimanded and advised to ensure he was sufficiently clear prior to shifting ground in future.

J. Toeroek, the rider of DAZZLING LILY, reported the mare was inclined to hang out throughout the event. DAZZLING LILY was examined by the Club's Veterinary Surgeon who reported superficial lacerations to the off hind just above the hock.

H. Coffey, the rider of SNOW JEWEL, reported the mare was inclined to over-race throughout the event and had a tendency to lay out rounding the turns. SNOW JEWEL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ANNANDALE LASS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 7 : HAMILTON HOLDEN HANDICAP - 1250 metres**

DOUBLE POCKETS (H. Coffey) made the turn in the vicinity of the 900 metres awkwardly.

CONSERVATORIUM (Z. Spain) raced wide without cover throughout the event.

At the entrance to the straight ALCOHOL (J. Toeroek) was disappointed when attempting a tight run to the inside of UNDERESTIMATION (J. Holder), which held its line, resulting in ALCOHOL becoming awkwardly placed on the heels of COULDN'T AGREEMORE (E. Finnegan) until the vicinity of the 200 metres.

DOUBLE POCKETS (H. Coffey) had difficulty obtaining clear ground from the entrance to the straight until inside the 200 metres when awkwardly placed on the heels of JUSTIFY THAT (S. Carr).

CONSERVATORIUM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

KARACATIS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

COULDN'T AGREEMORE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 8 : RESOURCECO BENCHMARK 82 HANDICAP - 1400 metres**

Acting on confirmed advice from Trainer, Mr B. Cozamanis that VENTIC had injured it's near side hip and would be unfit to start. Stewards withdrew VENTIC at 9.33 am.

GRAND ORATOR (J. Noonan) dipped shortly after jumping away.

Shortly after the start GRAND ORATOR (J. Noonan) shifted in onto CAVALOCE (C. Lindop), which was taken in bumping MARCO POLO (E. Boyd). J. Noonan was reminded of his obligations when shifting ground in future.

## **RACE 8 : RESOURCECO BENCHMARK 82 HANDICAP - 1400 metres (Cont'd)**

Approaching the 1200 metres REDEEM BOUNTY (J. Toeroek) reduced the speed of his mount resulting in HERE TO THERE (NZ) (J. Matthews) and MARCO POLO (E. Boyd) improving onto that gelding's heels and commencing to race keenly whilst being steadied. J. Toeroek was reminded of his obligation under AR137(d) in relation to reducing the speed of his mounts.

In the vicinity of the 900 metres HERE TO THERE (NZ) (J. Matthews) made the turn awkwardly and shifted out taking MARCO POLO (E. Boyd) out onto FUTURE SOLUTION (H. Coffey), which was inconvenienced when taken wider on the track.

IT AND A BIT (P. Gatt) was inclined to lay out under pressure in the straight and inside the 200 metres rolled out and brushed CAVALOCE (C. Lindop).

E. Boyd, the rider of MARCO POLO reported that after receiving a bump in the early stages of the event her saddle had shifted to the off side placing her at a slight disadvantage for the remainder of the event.

CAVALOCE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
