## RACE 1 : ARKABA / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE 1400 metres

MOON GAZER (J. Frew) was very slow to begin.

GREY HAMMOCK NIECE (T. Zanker) was slow to begin.

CONTEGO (G. Willoughby) reared on jumping away.

CONTEGO (G. Willoughby) hung out throughout the event.

CONTEGO (G. Willoughby) became held up for clear running on the heels of REBER (R. Bell), which had commenced to weaken from approaching the 500 metres until the entrance to the straight. CONTEGO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 2: HAWKER / SABOIS MAIDEN PLATE - 1100 metres

DINNER CAMP (R. Mayers) raced greenly and laid out throughout the event. DINNER CAMP was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 3: K S RASHEED MEMORIAL RATING 0-62 HANDICAP - 1100 metres

Mr T. Trenowden, the Trainer of GOT TO HURRY advised Stewards owing to transport difficulties the gelding had not been transported to today's meeting. Acting on this advice GOT TO HURRY was declared a late scratching by order of Stewards at 11.30 am.

Prior to loading, CASH AT DAWN dislodged it rider, W. Kerford, broke free and galloped for some distance. CASH AT DAWN was examined by the Club's Veterinary Surgeon who ruled the gelding unfit to race. Acting on this advice, Stewards withdrew CASH AT DAWN at 2. 40 pm. Stewards ordered that all monies invested on CASH AT DAWN be refunded and that all successful wagers be subject to the deductions of 9 cents in the dollar for a win and 7 cents in the dollar for a place. Ms D. Tulk, the Trainer of CASH AT DAWN, was advised a warning had been placed on that gelding's pre-race behaviour and should it perform in a similar manner in future, stronger action may be taken against it. W. Kerford was uninjured in the incident.

# RACE 3: K S RASHEED MEMORIAL RATING 0-62 HANDICAP - 1100 metres (Cont'd)

On jumping away CHAMBRAY (L. Stojakovic) shifted in onto YOU AND ME (R. Mayers), tightening that gelding onto KING RODNEY (M. Henderson), resulting in YOU AND ME losing its position.

In the vicinity of the 400 metres I DREAM OF GINA (R. Bell) was obliged to be checked and alter course as it improved onto the heels of MAGNUM PE I (D. Caboche).

- J. Frew, the rider of RIGHT AND READY, which performed below expectations, explained the gelding never felt comfortable in today's track conditions and didn't finish the race off as expected. RIGHT AND READY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
- G. Willoughby, the rider of GIGABYTE reported she had concerns with the gelding's action from the 400 metres and for this reason elected not to ride her mount out in her normal manner to the finish. GIGABYTE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### **RACE 4: NORTHPOINT TOYOTA HAWKER CUP – 1750 metres**

On jumping away RICH PRIDE (W. Kerford) shifted out onto KINGDOM OF WAR (D. Caboche), which was taken out onto SACHIN (J. Frew) which lost its position when tightened onto LATIN HERO (L. Stojakovic).

SACHIN (J. Frew) was reluctant to stretch out in the early stages of the event.

Inside the 400 metres NEW WAVE (M. Henderson) rolled out taking NOBLE ROMP (R. Bell) out onto RICH PRIDE (W. Kerford), which was taken wider on the track.

AL CHICAGO (A. Doyle) laid out placing that gelding's rider at a disadvantage for a short distance entering the home straight. AL CHICAGO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

In the vicinity of the 50 metres RICH PRIDE (W. Kerford) rolled in bumping NOBLE ROMP (R. Bell).

### RACE 5: XXXX GOLD WONOKA RATING 0-62 HANDICAP - 1400 metres

LUSTREMAN was examined by the Club's Veterinary Surgeon on arrival at the barriers as its rider had become concerned with the gelding's action. LUSTREMAN and was passed fit to race.

Shortly after the start EMCEECEE (W. Kerford) commenced to buck dislodging its rider. Trainer Ms D. Tulk was advised the gelding, would be required to prove tractable in an Official Barrier Trial prior to accepting for a future race. W. Kerford was examined by the First Care Medical Personnel and declared fit.

In the vicinity of the 400 metres TINSLEY GREEN (L. Stojakovic) was inconvenienced when it improved to the inside of STONE SOBER (J. Frew), which rolled in. J. Frew was reminded of his obligations when shifting ground in future.

From in the vicinity of the 100 metres until the finish line TRIUMPHANT ONE (A. Doyle) rolled out and bumped CATCH HIM (R. Bell) on a number of occasions.
