## RACE 1: GAWLER CUP DAY 27 SEPTEMBER RATING 0-120 HURDLE - 3340 metres

CROSS CONSTANCE (P. Hamblin) raced keenly in the early and middle stages of the event.

FENTON LASS (J. Lynch) landed awkwardly after making the first jump.

TARGET EXPLORER (B. Small) made the sixth jump awkwardly.

TARGET EXPLORER (B. Small) made the twelfth jump awkwardly.

CROSS CONSTANCE was examined by the Club's Veterinary Surgeon who reported a minor abrasion just above the off fore knee.

BAKLAVA BOY (NZ) was examined by the Club's Veterinary Surgeon who reported minor lacerations to the near hind leg.

## RACE 2: BANK / ACCOUNTANTS DAY FILLIES & MARES MAIDEN PLATE - 1100 metres

The start of this event was delayed approximately two minutes owing to TRUPT becoming fractious in its barrier after being loaded. TRUPT was examined by the Club's Veterinary Surgeon and was passed fit to start.

MATERIALISED (P. Gatt) was slow to begin.

HOT DEMAND (S. Price) hung out severely from the vicinity of the 800 metres until the entrance to the straight. HOT DEMAND was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Trainer, Mr D O'Leary was advised the filly would have to prove tractable in an Official Barrier Trial prior to accepting for a future race.

# RACE 2 : BANK / ACCOUNTANTS DAY FILLIES & MARES MAIDEN PLATE - 1100 metres (Cont'd)

MATERIALISED (P. Gatt) was held up from the entrance to the straight until inside the 200 metres when racing behind JESSIE'S OWN (T. Pannell) and inside LAST MOMENT (E. Boyd), which was inconvenienced when MATERIALISED shifted out to obtain clear ground.

On return to the mounting yard MATERIALISED shifted out abruptly, dislodging P. Gatt. P. Gatt was examined by the First Care Medical Personnel and ruled unfit to fulfil his remaining engagements.

## RACE 3: YOUNG DAYS DAY 11 JULY SABOIS MAIDEN PLATE - 1200 metres

PERUVIAN POWER (K. Bishop) shifted in on jumping away inconveniencing LOQUETEUX (S. Price).

At the entrance to the straight LOUDANZO (E. Boyd) shifted out and away from LOQUETEUX (S. Price), which had improved quickly to its inside onto PERUVIAN POWER (K. Bishop), which was inconvenienced when taken out onto MAGGIE'S CALL (T. Pannell).

In the vicinity of the 50 metres PERUVIAN POWER (K. Bishop) shifted out abruptly making heavy contact with MAGGIE'S CALL (T. Pannell), which dipped and became awkward for a number of strides. Trainer J. Dunn was advised that PERUVIAN POWER would have to prove tractable in an Official Barrier Trial prior to accepting for a future race.

- J. Holder, the rider of JOKED YA, which performed below expectations, explained the gelding had raced keenly in the early and middle stages of the event and when placed under pressure, only responded moderately and had not finished the race off over the final 200 metres. JOKED YA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
- S. Cahill, the rider of EXALTED LIGHTNING, reported in his opinion the gelding felt short in its action over the concluding 200 metres. EXALTED LIGHTNING was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 4: TE AROHA JOCKEY CLUB MAIDEN PLATE - 1500 metres

MIDRADA (K. Bishop) raced extremely greenly throughout the event.

In the vicinity of the 400 metres MIDRADA (K. Bishop) had to be steadied momentarily when tightened between RENEUTRALIZE (NZ) (D. Tourneur), which shifted out slightly at the same time as MARYORE (B. Claridge) shifted in.

FORGET THE POSSE (T. Pannell) was held up from the entrance to the straight until the vicinity of the 50 metres when awkwardly placed on the heels of COBBY GIRL (J. Potter) and inside PADLOT (IRE) (J. Holder).

J. Holder, the rider of PADLOT (IRE), reported the gelding had travelled well in the early and middle stages of the event, however, when placed under pressure at the entrance to the straight, had only been one paced to the line. He added that in his opinion, the gelding would benefit racing over a longer distance.

RENEUTRALIZE (NZ), which performed poorly, was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

## RACE 4: TE AROHA JOCKEY CLUB MAIDEN PLATE - 1500 metres (Cont'd)

MIDRADA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Trainer, Mr J. Dunn was advised that a warning had been placed on the gelding in relation to its racing manners.

#### RACE 5: WOLF BLASS GREY LABEL RATING 0-62 HANDICAP - 1100 metres

GO'EN HOFF (K. Bishop) jumped away awkwardly.

MASTER BLACK (Z. Spain) and SPARKLING BELLA (J. Holder) came together and bumped on jumping away.

PERESSINI (D. Tourneur) shifted in on jumping away and contacted GEORDIE'S SECOND (B. Claridge).

TEQUILA RED (S. Cahill) was inclined to lay in under pressure in the straight.

FIRST CLASS FLYER, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 6: COOPERS CLEAR RATING 0-62 HANDICAP- 1100 metres

The start of this event was delayed approximately two minutes owing to a request for the Club's Veterinary Surgeon to examine CANNES CONI from rider B. Claridge, who was concerned with the mare's action en route to the barriers, as in his opinion it was significantly different to when he had previously ridden CANNES CONI. Due to the concerns expressed by the rider, Stewards withdrew the mare at 2.44 pm.

Approaching the 1000 metres ONEHUNDREDCLICKS (NZ) (E. Boyd) had to be steadied when LADY HEDERAJ (S. Carr) shifted in. S. Carr was reprimanded and advised to ensure she was sufficiently clear prior to shifting ground in future.

ONEHUNDREDCLICKS (NZ) (E. Boyd) raced wide without cover throughout the event.

D. Tourneur, the rider of SANDHILL JETT, which performed below expectations, explained the gelding had travelled well in the early and middle stages of the event, however, when placed under pressure at the entrance to the straight had failed to respond to his riding and had finished the event off poorly. SANDHILL JETT was examined by the Club's Veterinary Surgeon who reported the gelding to low-grade lameness in the hindquarters.

ONEHUNDREDCLICKS (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 7 : SPORTSBET RATING 0-68 HANDICAP - 2100 metres

WHERE'S THAT (A. Doyle) raced wide without cover throughout the event.

T. Zanker, the rider of CLAY PAVER, reported that in the vicinity of the 1600 metres, the gelding was reluctant to maintain its position inside other runners and gave ground on its own accord.

## RACE 8 : GAWLER SOUTH BAKERY FILLIES & MARES RATING 0-68 HANDICAP - 1500 metres

In the vicinity of the 500 metres LIMBO QUEEN (D. Tootell) rolled out onto ELEGANT RUSH (S. Price), which was inconvenienced.

G. Willoughby, the rider of BOURBONDETTA, reported the mare failed to quicken at the entrance to the straight and she became concerned with its action over the concluding 200 metres. BOURBONDETTA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

# RACE 9 : COOPER CARLSBERG COLTS, GELDINGS & ENTIRES RATING 0-68 HANDICAP - 1500 metres

STANBOROUGH (D. Caboche) dipped on jumping away.

COMBAT DANCER (R. Mayers) raced keenly in the early stages of the event and whilst being restrained between the 1200 metres and the 1000 metres, dipped on a number of occasions in the going.

From the vicinity of the 400 metres until the entrance to the straight SUPER SKILLS (NZ) (B. Claridge) had difficulty in obtaining clear ground when awkwardly placed between the heels of EXALTED TOBY (K. Bishop) and ROCHERE (S. Carr).

Stewards questioned A. Doyle, the rider of GWYDIR, into his whip use in this event. A. Doyle pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

COMBAT DANCER, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

EXALTED TOBY, which performed poorly, was examined by the Club's Veterinary Surgeon who reported an elevated heart rate.
