THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday. 6 June 2015

RAIL: Out 12 metres from 1200 metres to 400 metres, 10 metres from 400 metres to 2000 metres, 8 metres remainder. Sectional 615 metres

RACE 1: WILLIAM HILL HANDICAP - 1000 metres

ENCHANTING BEAUTY (J. Holder) jumped away awkwardly and was slow into stride.

ROSELLI STING (J. Matthews) was slow to begin and raced keenly in the early stages of the event.

In the vicinity of the 800 metres STEVIE GEE (C. Jones) shifted in onto LEMON ZEST (L. Stojakovic), which was obliged to be steadied. C. Jones was severely reprimanded for shifting ground when insufficiently clear.

ENCHANTING BEAUTY (J. Holder) raced greenly throughout the event and approaching the 100 metres, commenced to lay in and shifted towards the heels of HEARTZ ABLAZE (J. Toeroek). As a consequence J. Holder was obliged to attempt to straighten his mount placing him at a disadvantage.

AUGUSTA BELLE was examined by the Club's Veterinary Surgeon who reported a higher than expected heart rate.

RACE 2: HUGHES CHAUFFEURED LIMOSINES HANDICAP - 1600 metres

NORTH BEACH (J. Toeroek), REWIND TIME (M. Neilson) and UNSPUN (P. Gatt) raced keenly in the early stages of the event.

In the vicinity of the 400 metres REWIND TIME (M. Neilson) became momentarily held up for clear running when racing behind NORTH BEACH (J. Toeroek) and to the inside of DEVON (D. Tourneur).

S. Carr, the rider of ON A DREAM, reported her mount felt awkward in its action during the event. ON A DREAM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: MOET & CHANDON HANDICAP - 2051 metres

Mr B. Williams, the Trainer of LENNYBE, advised Stewards prior to the event that he would instruct his rider to attempt to obtain a position forward of mid-field.

RIVER'S LANE (C. Jones) began awkwardly, shifted out and contacted HIOCTDANE (J. Toeroek).

SKY RAIDER (B. Claridge) jumped away awkwardly and shifted out taking LENNYBE (D. Tourneur) wider on the track.

CAPODECINA (M. Neilson) over-raced in the early and middle stages of the event.

In the vicinity of the 800 metres SIR LASZLO (NZ) (J. Holder) shifted out to improve and inconvenienced CAPODECINA (M. Neilson).

In the vicinity of the 400 metres CAPODECINA (M. Neilson) became momentarily held up when racing behind SIR LASZLO (NZ) (J. Holder). SIR LASZLO (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

D. Tourneur, the rider of LENNYBE, explained that after being able to comply with his instructions in the early part of the event when obtaining a position forward of mid-field, the pace in the event slackened and as he was trapped wide without cover in the vicinity of the 1600 metres, he elected rather than to restrain his mount, which in his opinion had a tendency to have a high head carriage, to allow it to stride forward and led the race by default.

RACE 4: THE LEGENDARY JACK SMITH HANDICAP - 1200 metres

Shortly after the start SECRETMENSBUSINESS (C. Jones) shifted out and away from BELARUSKI (J. Holder), which shifted out resulting in SECRETMENSBUSINESS tightening BUNGALALLY BELLE (K. Bishop) onto YEN (D. Tourneur), which was taken out onto RHINESTONE RUBY (J. Toeroek), resulting in both YEN and RHINESTONE RUBY racing in restricted room having to be steadied and losing their positions.

In the vicinity of the 900 metres SAGABELLA (J. Potter) over-raced got its head up and raced ungenerously for a short distance when awkwardly placed on the heels of DAUNTING DANCER (E. Boyd).

Approaching the 800 metres RHINESTONE RUBY (J. Toeroek) commenced to over-race and became awkwardly placed on the heels of SECRETMENSBUSINESS (C. Jones) for a number of strides.

- E. Boyd, the rider of DAUNTING DANCER, reported her mount dipped on a number of occasions during the event. DAUNTING DANCER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
- S. Carr, the rider of OUR ROYAL ROSE, reported the mare felt awkward in its action during the event. OUR ROYAL ROSE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

SECRETMENSBUSINESS lost its near fore plate during the event.

SECRETMENSBUSINESS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : SCHWEPPES HANDICAP - 1200 metres

D. Tourneur, the rider of LUCKY SYMBOL was questioned regarding his riding of this gelding over the concluding stages. After considering the evidence D. Tourneur was charged with a breach of AR137(b) for failing to ride his mount out to the end of the race for approximately three strides just prior to the winning post. D. Tourneur pleaded guilty and was fined \$1500. LUCKY SYMBOL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6: JAMES BOAG'S HANDICAP - 1200 metres

IMPRESSIVE YIELD was examined by the Club's Veterinary Surgeon on arrival on course who reported the gelding to be sore in both forelegs. Acting on this advice Stewards declared IMPRESSIVE YIELD a late scratching at 1.34 pm.

GRAND BRITANNIA (J. Potter) jumped away awkwardly, shifted out and inconvenienced STAR RECRUIT (P. Gatt).

RED ECLIPSE (J. Holder) when being restrained in the vicinity of the 800 metres, got its head up and raced ungenerously for a short distance.

RUSSIAN ROCKER (GB) (J. Toeroek) raced wide without cover throughout the event.

Approaching the 400 metres TANGIER SUN (M. Vance) rolled in resulting in SPUN DRY (D. Tourneur) having to be steadied. M. Vance was reprimanded and advised to take greater care when her mounts commence to shift ground in future.

SPUN DRY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: ALOHA THE MOVIE HANDICAP - 1200 metres

The start of this event was delayed approximately two minutes owing to DUCKWORTH proving difficult to load. Mr W. Clarken, acting on behalf of Trainer Mr J. O' Connor, was advised a warning had been placed on the gelding in relation to its barrier manners.

TRUPT (Z. Spain) jumped away very awkwardly, shifted in and tightened CHAMPAGNE JANE (E. Boyd) onto DUCKWORTH (S. Carr), which was taken in onto DARK IMAGE (D. Tourneur), resulting in CHAMPAGNE JANE and DARK IMAGE being hampered.

HOSTILE (M. Neilson) and ALCOBRO (J. Toeroek) over-raced in the early stages of the event.

Inside the 800 metres DARK IMAGE (D. Tourneur) raced keenly and became awkward on the heels of runners for a short distance.

At the entrance to the straight DUCKWORTH (S. Carr) had difficulty obtaining clear ground for a number of strides when racing behind FINAL ARROW (P. Gatt) and to the inside of AETHER (J. Maund).

In the vicinity of the 300 metres AETHER (J. Maund) laid in and shifted in onto FINAL ARROW (P. Gatt), which was inconvenienced and had to be steadied.

Approaching the 50 metres DARK IMAGE (D. Tourneur) improved onto the heels of CLAIR (J. Holder) shifted in to obtain clear running and contacted HOSTILE (M. Neilson), which was inconvenienced when taken in.

RACE 7: ALOHA THE MOVIE HANDICAP - 1200 metres (Cont'd)

- D. Tourneur, the rider of DARK IMAGE, was questioned regarding his use of the whip. D. Tourneur pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$200. He also pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in a forehand manner in consecutive strides prior to the 100 metres and was fined \$100.
- J. Toeroek, the rider of ALCOBRO, explained he had intended to take up a more forward position in running but owing to the pace in the event and the composition of the field, he was obliged to settle further back. He added the gelding had commenced to over-race, became a bit ungenerous during the middle stages of the event and finished the race off only fairly. ALCOBRO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

DUCKWORTH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

FINAL ARROW was examined by the Club's Veterinary Surgeon who reported no visible abnormalities

HOSTILE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8: DRINK DRIVING? GROW UP HANDCIAP - 1600 metres

CHU CHU CHARLIE (S. Cahill) pulled hard in the early stages of the event.

- S. Cahill, the rider of CHU CHU CHARLIE, explained his mount felt awkward in its action in the vicinity of the 600 metres and over the final 100 metres he felt that there was something amiss with the gelding and its action behind and for that reason did not persevere with his riding to the line. CHU CHARLIE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
- K. Bishop, the rider of MEADOW'S JOURNEY, was questioned regarding the use of her whip in the straight and advised to refrain from using the whip when her mounts are out of contention and showing no response.
- R. Hurdle, the rider of ZERPRISE JOURNEY, explained his instructions were to attempt to settle mid-field with cover. He stated that owing to his wide barrier and the pace in the early stages of the event, he elected to ride his mount in a quiet manner and settled back with cover rather than being trapped wide without cover mid-field.

BEAU'S MY BOY was examined by the Club's Veterinary Surgeon who reported an elevated heart rate.
