RACE 1 : HOLDFAST INSURANCE BROKERS HANDICAP - 1600 metres

EMMOOKI'S DASH (A. Herrmann) raced keenly in the early and middle stages of the event.

EMMOOKI'S DASH (A. Herrmann) became held up for clear running from in the vicinity of the 200 metres when racing behind GET PRONTO (K. Bishop), which commenced to weaken, and to the inside of FLOW METER (J. Holder), was only able to obtain clear running inside the 100 metres and had to shift to the outside of runners to improve.

Approaching the 100 metres ALIYANA (NZ) (H. Coffey) shifted in and away from ORATOR (IRE) (M. Neilson), as that horse improved to its outside, and brushed with FLOW METER (J. Holder).

J. Holder, the rider of FLOW METER, explained he was comfortable with the position obtained in running in the early and middle stages but when asked for an effort, the gelding failed to respond to his riding, raced flat and did not perform in the manner expected. FLOW METER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

EMMOOKI'S DASH and ALIYANA (NZ) were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : ADELAIDE PRODUCE MARKET TWO-YEAR-OLD MAIDEN PLATE - 1100 metres

The start of this race was delayed approximately one minute owing to HANDS UP, which brushed the rail en route to the start, being examined by the Club's Veterinary Surgeon who ruled the gelding fit to race. The start was also delayed owing to T. Pannell being dislodged from his mount ABU DHABI en route to the barriers. T. Pannell was examined by the First Care Medical personnel and ruled fit to fulfil his engagement. ABU DHABI was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

ROSELLI STING (J. Matthews) jumped away awkwardly.

ROYAL RUMBLE (J. Holder) was held up for clear running from in the vicinity of the 600 metres to the 400 metres.

In the vicinity of the 700 metres JACKSAY (S. Guymer) laid in and away from SPRINGFIELD LEW (B. Claridge) and on entering the straight continued to lay in and became awkward on the heels of SILENT SNIPER (Z. Spain) until the vicinity of the 200 metres when able to improve to the outside of that filly.

In the vicinity of the 100 metres ROSELLI STING (J. Matthews) improved onto the heels of HANDS UP (H. Coffey), which commenced to weaken, and had to be steadied. ROSELLI STING then became awkward between the heels of HANDS UP and ROYAL RUMBLE (J. Holder) for a number of strides.

JACKSAY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: BURNS CEILINGS & BUILDING SUPPLIES HANDICAP - 1050 metres

The start of this race was delayed approximately two minutes owing to TANSY requiring an adjustment to its tongue tie on arrival at the barriers. TANSY was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race. The start was also delayed owing to CASH IS COMING proving difficult to load. CASH IS COMING was examined by the Club's Veterinary Surgeon who ruled the mare fit to race.

CASH IS COMING (C. Jones) over-raced in the early stages of the event.

PISTOLIER lost its off hind plate during the event.

K. Bishop, the rider of OUR SNIPPY, was questioned regarding her riding of the gelding over the final stages of the race. K. Bishop pleaded guilty to a charge under AR137(b) in that she failed to ride the gelding out to the end of the race, in particular the final three strides, and was fined \$1000.

J. Toeroek, the rider of PISTOLIER, reported his mount laid in, in the straight. PISTOLIER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

E. Boyd, the rider of TOM'S LUCK, reported her mount made a respiratory noise during the event. TOM'S LUCK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CASH IS COMING was examined by the Club's Veterinary Surgeon who reported a small cut to the inside lower lip.

CLASSY JACK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : SCHWEPPE'S HANDICAP - 2500 metres

NOVIKOV (A. Herrmann) was slow to begin.

LENNYBE (E. Boyd) over-raced in the early and middle stages of the event.

FLYING CASINO (J. Holder) was held up for clear running from the vicinity of the 400 metres until approaching the 200 metres.

RACE 5 : OXFORD INSURANCE BROKERS HANDICAP - 2057 metres

CRUZ'N NOW (J. Frew) was slow to begin.

E. Boyd, the rider of DEVON, reported the gelding hung out throughout the event and as a consequence she had difficulty controlling her mount. She added inside the 1200 metres she elected to allow DEVON to stride freely to assist her in relation to its racing manners. DEVON was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. G. Young, the Trainer of DEVON, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

RACE 6 : ANTHONY SCOPELITIS MEMORIAL HANDICAP - 1100 metres

Ms. K. Mooney, the Trainer of GO'EN HOFF, advised Stewards she would instruct Apprentice K. Bishop to refrain from using her whip, as the gelding is better suited to be ridden in a hands and heels fashion.

GO'EN HOFF, which proved fractious and reared in its barrier stall after being loaded, dislodging its rider, was examined by the Club's Veterinary Surgeon who ruled the gelding unfit to race. Acting on that advice, Stewards withdrew GO'EN HOFF, at 3.05 pm. K. Bishop was examined by the First Care Medical personnel and ruled fit to fulfil her remaining engagement. Ms. K. Mooney, the Trainer of GO'EN HOFF, was advised the gelding would be required to prove tractable in the barriers in an Official Barrier Trial prior to accepting for a future race.

TIDY PROPHET (M. Neilson) began slowly and was slow into stride.

JETELLO (J. Holder) raced keenly in the early and middle stages of the event and in the vicinity of the 600 metres became awkwardly placed on the heels of KEL'S BLESSING (C. Jones) for a short distance. Thereafter, JETELLO had difficulty obtaining clear running when racing between the heels of KEL'S BLESSING and GRAND GALLOP (H. Coffey) and was only able to obtain clear running at the entrance to the straight.

SCANTY (E. Boyd) laid out in the straight. SCANTY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

M. Neilson, the rider of TIDY PROPHET, explained his instructions were to allow the mare to settle where comfortable. He stated that owing to TIDY PROPHET being slow to begin he raced from a position back in the field but added the mare was off the bit in the early and middle stages and finished the race off only fairly and in his opinion may be suited to racing over more ground.

J. Toeroek, the rider of WROCLAW, reported, in his opinion, the filly jarred up in running. WROCLAW was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the off foreleg. Mr. L. Kennewell, the Trainer of WROCLAW, was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

RACE 7 : PROJECTION GRAPHICS HANDICAP - 1100 metres

Mr. D. Jolly, the Trainer of MISTER ROCKSTAR, advised Stewards he would instruct Jockey S. Guymmer to attempt to settle mid-field with cover to enable it to finish the race off stronger.

The start of this race was delayed approximately two minutes owing to DUCKWORTH proving difficult to load. Mr. J. O'Connor, the Trainer of DUCKWORTH, was advised a warning had been placed on the gelding and should it perform in a similar manner in future, action may be taken against it.

TRUPT (H. Coffey) jumped away awkwardly and shifted in, tightening NORDIC ECLIPSE (M. Vance) onto FREEDOM SON (A. Darmanin). At the same time PENNY FOR A POUND (J. Maund) shifted out onto FREEDOM SON taking that gelding out onto NORDIC ECLIPSE, which was again tightened for galloping room. As a consequence FREEDOM SON and NORDIC ECLIPSE were severely hampered and TRUPT was obliged to be steadied for a number of strides when awkwardly placed on the heels of BAY ROAD (J. Toeroek).

Shortly after the start LIVE IN SANE (A. Herrmann) was obliged to be steadied to avoid the heels of MISS MARGARITA (E. Boyd) when racing in restricted room.

M. Vance, the rider of NORDIC ECLIPSE, reported that owing to her mount being interfered with at the start, she was unable to take up a forward position as intended.

MISTER ROCKSTAR was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mr. D. Jolly, the Trainer of MISTER ROCKSTAR, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

KING MAPOORA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

LUCKY FLIPPER lost its near fore plate during the event.

RACE 8 : NOCELLE FOODS HANDICAP - 1200 metres

Stewards granted permission for CREANCE to race equipped with a nose roll.

FINE APPROACH (C. Jones) jumped away awkwardly and was slow to begin, losing two to three lengths.

Inside the 200 metres CONSOLIDATED GLASS (C. Jokic) commenced to lay in and became awkwardly placed on the heels of USTINOV'S FURY (B. Claridge), which rolled out. As a consequence CONSOLIDATED GLASS raced in restricted room between the heels of USTINOV'S FURY and KNOXVILLE (J. Maund) for a number of strides and thereafter, over the concluding stages, C. Jokic was unable to ride her mount out fully when awkwardly placed between the heels of USTINOV'S FURY and KNOXVILLE. CONSOLIDATED GLASS was examined by the Club's Veterinary Surgeon who the gelding to be lame in the off hind leg. Mrs. S. Murphy, the Trainer of CONSOLIDATED GLASS, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

C. Jones, the rider of FINE APPROACH, explained that owing to her mount not jumping on terms, she was unable to take up a position mid-field as intended and was obliged to settle back in the field.

HEZA BARGAIN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
