**RACE 1 :DONNA'S ELECTRICAL BENCHMARK 72 HANDICAP- 1100 metres**

HARTIE'S SPIRIT (E. Creighton) jumped away awkwardly and shifted in bumping JIMASSI (A. Herrmann).

TICKET TO TOORAK, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 2 : TEYS AUSTRALIA / SABOIS TWO-YEAR-OLD & OVER MAIDEN PLATE - 1000 metres**

BOB'S GIFT, which was fractious in the barrier, was examined by the Club's Veterinary Surgeon who passed the gelding fit to race. Trainer Mr D. Dodson was advised a warning had been placed on the gelding's barrier manners.

ONE FOR MAX (J. Frew) stood flat footed and was very slow to begin, losing six lengths. Trainer Mr M. Kluske was advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial or Approval Jump Out prior to accepting for a future race.

ONE MORE DAISY (Z. Spain) was inclined to hang out throughout the event.

Rounding the home turn and in the home straight ONE MORE DAISY (Z. Spain) hung out severely and as a result Z. Spain was unable to fully test the filly to the finish. ONE MORE DAISY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Trainers, Mr W. Frances and Mr G. Kent were advised that ONE MORE DAISY would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

FINNTUITION (D. Caboche) was inclined to hang in under pressure in the home straight.

ONE FOR MAX (J. Frew) was inclined to race ungenerously throughout the event. ONE FOR MAX was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 3 : LOCAL TRAINERS / SABOIS TWO-YEAR-OLD & OVER MAIDEN PLATE -**  
**1430 metres**

OUTBACK STORY stood flat footed and was slow to begin.

BIANMAGIC stood flat footed and was very slow to begin. Mr. B. Olsen, representing Trainer Ms S. Murphy, was advised a warning had been placed on the gelding's starting manners.

BIANMAGIC (J. Frew) raced keenly in the early and middle stages of the event.

Inside the 400 metres BIANMAGIC (J. Frew) had to momentarily steady when racing on the heels of JUST POLITIC (B. Claridge).

**RACE 4 : LOCAL BOOKMAKERS RATING 0-58 HANDICAP - 1200 metres**

CALMALIST (C. Jokic) jumped away awkwardly and shifted out bumping DUKE OF EARL (J. Frew).

Following the running of this race, R. Mayers required medical treatment by the First Care Medical Personnel and as a result was transferred to hospital for observation.

**RACE 5 : GRAROCK PLUMBING BENCHAMRK 72 HANDICAP - 1430 metres**

HASTA LA SHAMER (M. Munday) and FORT CHAUVEL (D. Caboche) raced ungenerously in the early and middle stages of the event.

MIDNIGHT EXPRESS, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

AFFLECK, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 6 : TEYS AUSTRALIA RATING 0-68 HANDICAP - 2000 metres**

The start of this event was delayed approximately two minutes due to NOVEL IDEA proving fractious in the barriers and dislodged its rider E. Boyd. As E. Boyd was injured in this incident and was declared unfit by the First Care Medical Personnel to fulfil her engagement. Stewards withdrew NOVEL IDEA at 3.25 pm. As a result of E. Boyd requiring further medical attention and having to be transferred to hospital for observation, this race was re-scheduled to be run at 4.03 pm. Mr J. MacMillan, the Trainer of NOVEL IDEA was advised the filly would be required to perform to the Stewards satisfaction in an Official Barrier Trial or Approval Jump Out prior to accepting for a future race.

KIRVIC (H. McKechnie) raced ungenerously in the early and middle stages of the event.

From the vicinity of the 200 metres until the finish KIRVIC (H. McKechnie) was held up for clear running when racing on the heels of OPTICAL ILLUSION (E. Creighton) and to the inside of INSTANT CONVERT (A. Herrmann).

KIRVIC was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 7 : HAYNES ENGINEERING RATING 0-58 HANDICAP - 1430 metres**

The start of this event was rescheduled to be run at 4.42 pm due to the incident in Race 6.

KEETIMO (A. Doyle) was slow into stride.

In the vicinity of the 400 metres JACK'S JOURNEY (D. Caboche) was momentarily inconvenienced when racing tight to the inside of CAYNHAM (H. McKechnie).
