**RACE 1 : KBL SECURITY SABOIS MAIDEN PLATE - 1050 metres**

GRACE VONFIRE (D. Caboche) shifted out on jumping away inconveniencing THING OF NOTHING (IRE) (S. Guymer), which was tightened onto BEL SORBET (A. Herrmann).

THING OF NOTHING (IRE) (S. Guymer) raced keenly in the early and middle stages of the event.

FULL SWING (J. Holder) had difficulty in obtaining clear ground approaching the 300 metres and was obliged to ease to the outside of JESSIE'S OWN (T. Pannell) to obtain clear ground.

Inside the 200 metres GRACE VONFIRE (D. Caboche) rolled in under pressure onto YOUDINI (P. Gatt), which shifted in and away as it commenced to weaken, resulting in MUMMA'S BOY (L. Stojakovic) becoming awkwardly placed on that gelding's heels and was obliged to steady.

LOUDANZO (J. Toeroek) was inclined to lay in throughout the event. LOUDANZO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

YOUDINI, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 2 : BALAKLAVA TRANSPORT TWO-YEARS-OLD & OVER MAIDEN PLATE - 1400 metres**

On jumping away TASKMASTER (S. Guymer) and IT'S GOTTA BE HOT (M. Neilson) came together and bumped.

A LOTTA ROSIE (T. Zanker) was slow to begin.

**RACE 2 : BALAKLAVA TRANSPORT TWO-YEARS-OLD & OVER MAIDEN PLATE -**  
**1400 metres (Cont'd)**

Shortly after the start SPIRIT OF GOLD (S. Carr) shifted in and away from TURNER FATE (R. Bell), which rolled in, onto FREE FALL (D. Caboche), which shifted in and away onto RANSOM VALUE (L. Stojakovic), which lost its position when forced to steady off the heels of IT'S GOTTA BE HOT (M. Neilson).

MIDRADA (J. Frew) laid out from the vicinity of the 900 metres until the entrance to the straight.

R. Bell, the rider of TURNER FATE, which performed poorly, explained the filly had travelled only fairly in the early and middle stages of the event and when placed under pressure in the vicinity of the 700 metres, had failed to respond to his riding and had commenced to weaken from the event on its own accord. TURNER FATE was examined by the Club's Veterinary Surgeon who reported mild shin soreness.

**RACE 3 : MID NORTH PARTY HIRE/CLASSIC HITS 5CS + MAGIC 105.9/SABOIS 2 UP**  
**MAIDEN - 1600 metres**

MISS EEJAY (S. Guymer) shifted in on jumping away inconveniencing JAM WITH THE DUKE (P. Gatt).

In the vicinity of the 1400 metres PIPER'S WAIT (D. Caboche) lost its action and shifted out abruptly inconveniencing ROMULUS FLIGHT (J. Maund), which was taken wider. In losing its action PIPER'S WAIT also lost ground, resulting in JOCK'S GLEN (J. Bowditch), which was racing behind that filly, having to be steadied and JAM WITH THE DUKE (P. Gatt) having to be steadied off the heels off JOCK'S GLEN. JAM WITH THE DUKE and JOCK'S GLEN then over-raced until the vicinity of the 1000 metres.

In the vicinity of the 300 metres JAM WITH THE DUKE (P. Gatt) shifted out slightly to improve and in doing so inconvenienced WATCH THE WOLF (J. Holder), which had to be momentarily steadied and was obliged to alter course back to that gelding's inside to obtain clear ground. P. Gatt was reminded of his obligations when shifting ground.

JOCK'S GLEN (J. Bowditch) laid in under pressure in the straight. JOCK'S GLEN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

PIPER'S WAIT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 4 : PLAINS PRODUCER RATING 0-68 HANDICAP - 2204 metres**

CORNISH LAD (D. Caboche) shifted out abruptly on jumping away onto DUCHOVNY (Z. Spain), which was taken out onto ROBOCOP (S. Guymer), which was tightened onto WHINCUP (NZ) (J. Toeroek), which lost its position when taken out onto LAND OF THE FREE (A. Herrmann).

S. Guymer, rider of ROBOCOP, was questioned in relation to his use of the whip in this event. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$400.

**RACE 5 : WAREHOUSE MATRIX – KEEP RUNNING RATING 0-68 HANDICAP**  
**- 1600 metres**

CLUB MAHER J. Holder) was slow to begin.

DOWNUNDER PRINCE (S. Price) jumped away awkwardly and shifted out contacting SOME DO (A. Herrmann).

TIMELYINTERRUPTION (D. Tootell) and SOME DO (A. Herrmann) raced keenly in the early and middle stages of the event.

STANBOROUGH (D. Caboche) raced three wide without cover throughout the event.

Stewards questioned D. Caboche, rider of STANBOROUGH, into his whip use in this event. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$200. D. Caboche was also reprimanded under AR137A(4)(c) for using his whip when his horse was out of contention.

CANON DIABLO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

STANBOROUGH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

HAYLEE MAREE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 6 : AGFERT / K BRERETON JEWELLERS RATING 0-62 HANDICAP**  
**- 1400 metres**

SIR DYLAN (J. Holder) shifted in on jumping away onto CRIMSON CASH (S. Guymer), which lost its position when tightened onto DULCIE JANE (D. Caboche), which shifted out on jumping away.

PILOT'S LANE (J. Maund) was slow to begin.

RIGHT IDEA (J. Frew) raced keenly in the early stages of the event.

LADY BESS (D. Tootell) raced keenly in the middle stages of the event.

In the vicinity of the 300 metres MOON BRICKS (M. Neilson) shifted in when insufficiently clear of SPARKLING BELLA (A. Herrmann), which was forced to take hold when tightened onto STAR RECRUIT (S. Cahill). M. Neilson pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Saturday, 20 June and to conclude at midnight on Saturday, 27 June 2015 : a period of three (3) meetings.

K. Brooks, the rider of VACKER DAM, reported the filly was inclined to lay out under pressure in the straight.

CRIMSON CASH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 7 : MCCRACKEN FORD / SABOIS FILLIES AND MARES RATING 0-68**  
**HANDICAP - 1200 metres**

Shortly after the start FLYIN' FOR ME (P. Gatt) shifted in and away from SILVER SEBRING (A. Doyle) onto CANNES CONI (M. Neilson), which lost its position when tightened onto AZZCOOL (J. Toeroek), which had been taken out by KOODA DAWN (A. Herrmann).

ALYSIANA (S. Cahill) jumped away awkwardly.

KOODA DAWN (A. Herrmann) commenced to hang out severely from the vicinity of the 1000 metres onto CANNES CONI (M. Neilson), which was inconvenienced when taken out onto FAMOUS JAYNE (S. Guymer), which was hampered when taken extremely wide on the track. KOODA DAWN continued to hang out until the entrance to the straight. KOODA DAWN was examined by the Club's Veterinary Surgeon who reported the mare to have a quartered outside heel on off hind leg. Trainer Mr J. Dunn was advised that a warning had been placed on the mare in relation to it hanging out.

S. Guymer, the rider of FAMOUS JAYNE, accidentally dropped his whip inside the 200 metres and was reprimanded. He was also advised that future carelessness may result in a penalty being imposed.

Correct weight for this event was delayed to allow D. Caboche, rider of the second placegetter MOLLY THE SNIP and that mare's Trainer Mr K. Matson, to view the official photo image for first.

BOLDACIOUS GIRL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CANNES CONI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 8 : NEWMARKET GRANDWEST INSURANCE BROKERS CG&E RATING 0-62**  
**HANDICAP - 1610 metres**

ONEHUNDREDCLICKS (NZ) (P. Gatt) jumped away awkwardly and shifted out inconveniencing IRON FOCUS (J. Frew).

TEQUILA RED (S. Cahill) made the turn in the vicinity of the 800 metres awkwardly and shifted out inconveniencing IMPRESSIVE YEILD (S. Price), LUCKSA (J. Holder), SOCIAL LANE (C. Jones) and POP THE BUBBLE (K. Brooks) which were all taken wider.

In the vicinity of the 600 metres BIG WEEKEND (Z. Spain) was momentarily inconvenienced when racing in restricted room to the inside of IRON FOCUS (J. Frew).

TEQUILA RED (S. Cahill) had difficulty obtaining clear ground over the final 400 metres of the event.

Approaching the 200 metres TEQUILA RED (S. Cahill) shifted out in an attempt to improve and bumped LORD ASHFORD (D. Caboche).

Approaching the 100 metres SOUND ALIBI (A. Herrmann) had difficulty obtaining clear ground when awkwardly placed between the heels of NIGHT BREEZE (M. Neilson) and IRON FOCUS (J. Frew).

POP THE BUBBLE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

LUCKSA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
