RACE 1 : HUGHES CHAUFFEURED LIMOUSINES HANDICAP- 1250 metres

R. Hurdle, the rider of SEEK TO DESTROY was granted permission to ride the gelding only claiming one and a half kilograms.

MAIL IT IN (J. Holder) jumped away very awkwardly, shifted in and tightened SEEK TO DESTROY (R. Hurdle) onto DIVINE WEAVER (S. Carr), resulting in SEEK TO DESTROY and DIVINE WEAVER being inconvenienced and SEEK TO DESTROY being unable to maintain its position.

Inside the 1000 metres ROYAL RUMBLE (C. Lindop) became awkwardly placed on the heels of HAZY LANE (J. Toeroek) and when being restrained raced ungenerously for a short distance.

In the vicinity of the 900 metres DISCO (S. Guymer), when being restrained, got its head up and raced ungenerously for a short distance and was inclined to race greenly during the event.

Approaching the 200 metres HAZY LANE (J. Toeroek), which was inclined to lay in for a number of strides, became held up for clear running when awkwardly placed on the heels of DISCO (S. Guymer) and to the inside of MAIL IT IN (J. Holder).

RACE 1 : HUGHES CHAUFFEURED LIMOUSINES HANDICAP- 1250 metres

J. Toeroek, the rider of HAZY LANE, reported the filly laid in, in the straight. HAZY LANE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

SEEK TO DESTROY, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : IRISH RACE DAY 29TH AUGUST HANDICAP - 1950 metres

On arrival at the barriers THE BEAUTIFUL WIFE had to be re-saddled.

CRUZ'N NOW (P. Gatt) was slow to begin.

In the vicinity of the 500 metres THE BEAUTIFUL WIFE (S. Carr), which had commenced to weaken, became awkward for a number of strides inside POWER TO POSSESS (D. Tootell) as that horse rolled in marginally.

CRUZ'N NOW which lost its near fore plate during the event was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg.

RACE 3 : DRINK DRIVING? GROW UP THREE-YEAR-OLD MAIDEN PLATE - 1000 metres

The start of this event was delayed approximately two minutes owing to REEVANO'S HONOUR, TEMPTING FAITH and QUASAR proving difficult to load. Trainers Mr J. MacMillan, Mr A. Stra and Mr C. Graves were advised a warning had been placed on their respective runners in relation to their loading manners.

DEWANGSA (S. Guymer) and SEE ME ROLLIN' (J. Potter) both shifted ground and contacted at the start.

HOT DEMAND (S. Price) jumped away awkwardly, shifted out and was obliged to be steadied off the heels of REEVANO'S HONOUR (M. Neilson).

Shortly after the start QUASAR (K. Brooks) rolled out and away from runners and tightened LOCKDOWN JACK (J. Holder) onto JACK ATTACK (C. Jokic), resulting in LOCKDOWN JACK losing its position.

JUST DEMANDING was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the off hind leg. Trainer, Ms Leah Conlon was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

REEVANO'S HONOUR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

PRINCESS ASTRO was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the off fore leg. Trainer, Mr S. Burford was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

RACE 4 : CORPORATE EVENTS @ MORPHETTVILLE HANDICAP - 1400 metres

HOSTILE (S. Guymer) jumped away very awkwardly, shifted out and contacted GRAND BRITANNIA (J. Potter), which was tightened onto UNSPUN (J. Holder), which was taken out onto the heels of SPUN DRY (P. Gatt). As a result UNSPUN lost its position. As a further consequence SEBRING MAGIC (T. Pannell) became awkward on the heels of SPUN DRY, which shifted out and was unable to maintain a position between SPUN DRY and MOST HUSBANDS (R. Hurdle).

In the vicinity of the 900 metres MYWORDSAIDTHEBIRD (C. Jones) when being restrained became awkwardly placed on the heels of HOSTILE (S. Guymer) and as a consequence GRAND BRITANNIA (J. Potter), which was following had to be restrained and got its head up and raced ungenerously for a short distance.

Approaching the 200 metres GRAND BRITANNIA (J. Potter) was disappointed for clear running and was obliged to shift out to obtain clear ground.

S. Guymer, the rider of HOSTILE, explained his instructions and intentions were to lead the event, however, from in the vicinity of the 500 metres the gelding was under pressure and did not finish the event off in the manner he expected and was disappointing in its performance.

UNSPUN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : MOET & CHANDON HANDICAP - 1400 metres

FRIM AND FROME (J. Holder) was awkward to begin.

Approaching the 700 metres ASTRO DAMUS (R. Hurdle) shifted in and tightened IMAGING (J. Bowditch), which was taken in onto WISE JOURNEY (S. Carr), resulting in IMAGING racing in restricted room for a short distance and WISE JOURNEY having to be checked by its rider losing its position. R. Hurdle, the rider of ASTRO DAMUS pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 28 June, and to conclude at midnight on Sunday, 12 July 2015: a period of six (6) meetings.

RACE 6 : CAMPOLINA STUD HANDICAP - 1400 metres

Stewards acceded to a request by Trainer Mr L. Macdonald that R. Hurdle who was unable to make the weight on SATURDAY AFFAIR be replaced by J. Maund.

Inside the 1200 metres EDGE OF WAR (J. Bowditch) shifted in and tightened REDEEM BOUNTY (J. Toeroek), which had to be steadied for a number of strides to avoid the heels of EDGE OF WAR. J. Bowditch was found guilty of a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight Saturday, 27 June, and to conclude at midnight on Sunday, 5 July 2015: a period of four (4) meetings.

Inside the 400 metres IT AND A BIT (P. Gatt), which was inclined to lay out shifted out to improve and tightened HOUSE OF WAX (T. Pannell) onto SATURDAY AFFAIR (J. Maund), which maintained its line. As a consequence T. Pannell was obliged to take hold of his mount and lost his position. In considering the matter, Stewards were mindful that P. Gatt had made an attempt to straighten his mount once it commenced to shift out into the running line of HOUSE OF WAX and in the circumstances, severely reprimanded P. Gatt for shifting ground when insufficiently clear.

RACE 6 : CAMPOLINA STUD HANDICAP - 1400 metres (Cont'd)

SATURDAY AFFAIR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : WILLIAM HILL HANDICAP - 1300 metres

The start of this event was delayed approximately two minutes owing to DUANEO which lost its near fore plate having to be attended to by the Farrier on arrival at the barriers. DUANEO was examined by the Club's Veterinary Surgeon and passed fit to race.

PATCH HERO (Z. Spain) over-raced in the middle stages of the event and as a consequence was obliged to race wide without cover for a short distance.

DARK IMAGE (R. Hurdle) over-raced in the middle stages of the event.

LOQUETEUX (P. Gatt) raced in restricted room over the concluding stages between ALL SEWN UP (S. Guymer) and CLAIR (J. Holder)

PATCH HERO was examined by the Club's Veterinary Surgeon who reported minor abrasions to the filly's gum.

LOQUETEUX, ALCOBRO and CLAIR were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : MEDALLION HOMES HANDICAP - 1250 metres

TIPPERARY LIL which kicked a running rail on arrival at the barriers was examined by the Club's Veterinary Surgeon and passed fit to race.

MUCHOS RESPECTOS (NZ) (J. Toeroek) jumped away awkwardly.

MOONLIGHT FOREST (M. Neilson) over-raced in the early stages of the event.

I AM IN COMMAND (A. Doyle) raced wide without cover in the early and middle stages of the event.

MARBLE RYE (J. Holder) laid in from in the vicinity of the 700 metres.

Approaching the 400 metres MUCHOS RESPECTOS (NZ) (J. Toeroek) was held up for clear running for a number of strides.

MUCHOS RESPECTOS (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

TANGIER SUN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

I AM IN COMMAND was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in both hind legs. Mr G. Searle was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

MOONLIGHT FOREST was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

MARBLE RYE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 9 : SCHWEPPES HANDICAP - 1000 metres

Acting on confirmed advice from Trainer Mr R. Balfour that EL PRADO GOLD had a stone bruise to its off fore hoof. Stewards ordered the gelding to be a late scratching at 10.11 am.

R. Hurdle, the rider of CLASSY JACK was granted permission to ride the gelding only claiming a half a kilogram.

CLASSY JACK (R. Hurdle) jumped away awkwardly, shifted out and contacted MR GOOD CAT (J. Toeroek), which was inconvenienced.

OUR LITTLE TREASURE (J. Maund) jumped away awkwardly; shifted out and contacted LUCKY SYMBOL (P. Gatt) turning that horse's hindquarters.

JUSTIFY THAT (S. Carr) pulled hard in the early stages of the event.

LUCKY SYMBOL (P. Gatt) had difficulty obtaining clear running in the straight and was obliged to shift out to obtain clear ground in the vicinity of the 200 metres.

C. Jones, the rider of KARACATIS explained her instructions were that if the gelding jumped on terms to allow it to settle where comfortable and in the event she settled worse than midfield to attempt to obtain cover in a three wide position. She stated that the gelding began well but owing to her wide barrier and the early pace she was only able to obtain cover three wide behind CLASSY JACK (R. Hurdle) from in the vicinity of the 700 metres and thereafter in the vicinity of the 600 metres was able to obtain cover behind JUSTIFY THAT (S. Carr). She added that in the vicinity of the 600 metres the gelding was off the bit for a short distance but on straightening responded to her riding and finished the race off very well.

ALABAMA MISSILE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CLASSY JACK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

JENNYFROMTHEBLOCK lost its off fore plate during the event.

GENERAL:

Stewards advised that owing to R. Hurdle having had a number of recent offences under AR120(b) in relation to him not being able to either claim down to his minimum riding weight or having to be replaced, that his minimum riding weight would be increased from 53 kg to 54 kg with effect from Monday, 22 June 2015.
