Report on Race Meeting held at Murray Bridge Racecourse by the Murray Bridge Racing Club on Wednesday, 24 June 2015

RACE 1 : BOOK CARLTON DRAUGHT MARQUEE ONLINE / SABOIS THREE-YEAR-OLD MAIDEN PLATE – 1400 metres

SELDOM HOME (J. Holder) jumped away awkwardly, shifted in and brushed BUYMEBYCHANCE (R. Hurdle).

NORTHERN REVIEW (P. Gatt) raced keenly in the early and middle stages of the event.

BUYMEBYCHANCE (R. Hurdle) was held up when racing behind SUPER SWIFT (J. Toeroek) and inside COBBY GIRL (J. Potter) from the vicinity of the 200 metres and was untested to the line. R. Hurdle explained upon straightening he elected to follow SUPER SWIFT (J. Toeroek) into the race as he felt that the gelding would improve, however, in the vicinity of the 300 metres was of the belief that SUPER SWIFT commenced to give ground and felt it would be detrimental for him to ease his mount and attempt to improve to the outside of COBBY GIRL (J. Potter) at that stage of the race and for this reason continued to persist with his position in the hope that he could improve between SUPER SWIFT and COBBY GIRL. He added that a run never fully eventuated and that BUYMEBYCHANCE race greenly and was reluctant to improve into the restricted room between these two runners.

RACE 2 : WWW.RACINGMURRAYBRIDGE.COM / SABOIS MAIDEN PLATE - 900 metres

PRIOR TO THE FIRE (P. Gatt) was inclined to rear on jumping away.

ELECTRIC PUSSYCAT (T. Pannell) shifted out on jumping away contacting BANANA PANCAKES (S. Carr).

RACE 2: WWW.RACINGMURRAYBRIDGE.COM / SABOIS MAIDEN PLATE - 900 metres (Cont'd)

ELECTRIC PUSSYCAT (T. Pannell) had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 300 metres when able to ease out across the heels of KIM'S INTUITION (J. Holder) to obtain clear ground.

BANANA PANCAKES (S. Carr) was inclined to lay in under pressure in the straight. BANANA PANCAKES was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : CHRISTMAS CUP - 6 DECMBER / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 900 metres

AEROWULF (T. Pannell) and DE TWIGSTAR (C. Lindop) were slow to begin.

BRIMARVI EQUIADA (J. Frew) raced greenly and wide without cover throughout the event. BRIMARVI EQUIADA was examined by the Club's Veterinary Surgeon who reported mild tying up in both hindquarters. First Aid was administered.

RACE 4 : BOOK CROWN LAGER CLUBROOM ONLINE / SABOIS MAIDEN PLATE - 1200 metres

The start of this event was delayed approximately five minutes owing to SCARLET LETTER becoming fractious in its barrier stall after being loaded. SCARLET LETTER was examined by the Club's Veterinary Surgeon who ruled the mare unfit to race. SCARLET LETTER was a late scratching at 1.26 pm. Joe Bowditch, the rider of ZAARZOE, was struck by SCARLET LETTER when it became fractious and was examined by the First Care Medical Personnel who passed him fit to ride. Mr B. Bogarts, the Trainer of SCARLET LETTER was advised the mare would be required to be tractable in the barriers in an Official Barrier Trial prior to accepting for a future race.

DOWN THE AISLE (P. Gatt) was slow to begin.

TREME GIRL (J. Toeroek) shifted out abruptly on jumping away.

On jumping away QUICK BISCUIT (J. Potter) shifted out tightening BIRCHMORE BULL (B. Claridge), which was forced to lose its position, onto SOCIAL BANDIT (J. Maund).

In the vicinity of the 500 metres QUICK BISCUIT (J. Potter) improved onto the heels of SOCIAL BANDIT (J. Maund) and had to be steadied for a number of strides. As a consequence GOLDEN CLASS (T. Pannell), which was racing behind QUICK BISCUIT, was also steadied for a short distance.

In the vicinity of the 300 metres BELLOTTO'S SON (R. Bell) was forced to steady momentarily when tightened between BIRCHMORE BULL (B. Claridge), which shifted in slightly at the same time as SOCIAL BANDIT (J. Maund) rolled out.

BIRCHMORE BULL was inclined to lay in under pressure in the straight.

J. Maund, the rider of SOCIAL BANDIT, reported the gelding was inclined to shift about throughout the event. SOCIAL BANDIT was examined by the Club's Veterinary Surgeon who reported an abrasion and lameness in the near hind pastern.

RACE 4 : BOOK CROWN LAGER CLUBROOM ONLINE / SABOIS MAIDEN PLATE - 1200 metres (Cont'd)

PRINCESS COSTA was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

RACE 5 : HOSPITALITY-CROWN LAGER CLUBROOM MAIDEN/CLASS 1 PLATE - 2200 metres

The start of this event was delayed approximately four minutes owing to GOOD CALL BAD CALL being examined by the Club's veterinary Surgeon, on arrival at the start, who reported the gelding to be lame in the off hind leg and unfit to race. Acting on this advice Stewards ordered the withdrawal of GOOD CALL BAD CALL at 1.56 pm. Trainer Mr R. Wilkinson was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race. The start was further delayed owing to CLAREMONT KID losing a near fore plate en route to the barriers and requiring Farrier attention.

CLAREMONT KID (A. Doyle) shifted out on jumping away contacting NIC'S BUDDY (S. Carr).

LOCOMOTION LUCY (J. Holder) raced keenly in the early and middle stages of the event.

Approaching the 100 metres JAM WITH THE DUKE (S. Guymer) rolled in slightly onto COMMAND THE SUN (T. Zanker), which had to be momentarily steadied.

Correct Weight for this event was delayed to allow T. Zanker, the rider of the fourth placegetter COMMAND THE SUN to view the vision in the straight.

Stewards questioned S. Guymer, the rider of JAM WITH THE DUKE, in relation to his whip use in the event. After doing so, S. Guymer pleaded guilty to a charge under 137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$300.

RECHARGING TO WIN was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

RACE 6: MURRAY BRIDGE GOLD CUP – 14 OCTOBER CLASS 2 HANDICAP - 1200 metres

FRANK HEAVENS (R. Hurdle) jumped away awkwardly and shifted in contacting SWINGITLIKESAYERS (J. Potter).

In the vicinity of the 300 metres GEORDIE'S SECOND (B. Claridge) rolled in slightly onto LADY HEDERAJ (S. Carr), which shifted in and away inconveniencing SHELBY APPLES (J. Bowditch), which was taken in onto SUPREME RULER (S. Guymer), which was tightened for room and had to be steadied.

FRANK HEAVENS (R. Hurdle), which was racing behind GEORDIE'S SECOND (B. Claridge) had difficulty obtaining clear ground for a number of strides.

FRANK HEAVENS (R. Hurdle) laid in under pressure in the straight and in the vicinity of the 100 metres had to be steadied as MRS MARIELLA (P. Gatt) laid in under riding resulting in FRANK HEAVENS having to alter course to obtain clear ground.

RACE 6: MURRAY BRIDGE GOLD CUP – 14 OCTOBER CLASS 2 HANDICAP - 1200 metres (Cont'd)

R. Mayers, rider of THE LONE RANGA, reported the filly was reluctant to stretch out in the early stages of the event, however, from the vicinity of the 500 metres picked up the bit and finished the race off well. THE LONE RANGA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. LADY HEDERAJ, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: HOSPITALITY – CARLTON DRAUGHT MARQUEE RATING 0-62 HANDICAP - 1000 metres

AHEAD OF TIME (J. Holder) raced keenly in the early and middle stages of the event.

AHEAD OF TIME (J. Holder) laid in, in the early part of the straight resulting in J. Holder being forced to stop riding and straighten his mount on a number if occasions.

Inside the 200 metres J. Holder permitted his mount to shift in when insufficiently clear of EXALTED ROSE (C. Lindop), which was forced to take hold and alter course to avoid the heels of AHEAD OF TIME (J. Holder). J. Holder was found guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Saturday, 27 June and to conclude at midnight on Wednesday 8 July 2015: a period of five (5) meetings.

AHEAD OF TIME was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BRUGIA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : GOLD CUP HOSPITALITY NOW AVAILABLE ONLINE RATING 0-62 HANDICAP - 1400 metres

PILOT'S LANE (J. Potter) was slow to begin.

PILOT'S LANE (J. Potter) dipped approaching the 1000 metres for no apparent reason.

TOKEN ONE (D. Tootell) was inclined to lay in under pressure in the straight and in the vicinity of the 100 metres shifted in onto RED DAZZLE (J. Maund) resulting in D. Tootell having to stop riding and straighten his mount momentarily.

- K. Brooks, the rider of BARIGAN BOY, reported the gelding was inclined to lay out in the straight.
- S. Carr, the rider of LYDIARD, reported the gelding raced greenly in the straight.

TIDY PROPHET was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 9: CLASSICBET RATING 0-62 HANDICAP - 1400 metres

BENGAL TIGER (T. Pannell) reared on jumping away and was slow into stride.

RORY'S UNION (S. Carr) dipped on jumping away.

RACE 9: CLASSICBET RATING 0-62 HANDICAP - 1400 metres (Cont'd)

CREON (C. Jokic) raced keenly in the early and middle stages of the event resulting in DAMAGE CONTROL (P. Gatt), which was racing behind that gelding, becoming awkwardly placed on the heels of CREON on a number of occasions.

SIR DYLAN (J. Jolder) was inclined to lay in under pressure in the straight and in the vicinity of the 300 metres rolled in and brushed RORY'S UNION (S. Carr) on two occasions. SIR DYLAN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

S. Carr, the rider of RORY'S UNION, reported the gelding was inclined to hang out throughout the event and she became concerned with its action over the concluding stages and on pulling up. RORY'S UNION was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CHAT ME UP, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

GENERAL:

Apprentice D. Caboche was questioned in relation to him failing to present his winning ride book as directed by the Stewards. D. Caboche was reprimanded and advised that a future breach may result in a penalty being imposed.
