Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 4 July 2015

RACE 1 : HUGHES CHAFFEURED LIMOUSINES HANDICAP - 1300 metres

Mr P. Hardacre, the Trainer of THIS KID ROCKS, advised Stewards prior to the event that he would instruct his rider T. Pannell to attempt to obtain a more forward position in running.

The start of this event was delayed approximately two minutes owing initially to IXCATAN having to be re-saddled on arrival at the barriers and also owing to this gelding having sprung it's near fore plate shortly after being resaddled. IXCATAN was attended to by the Farrier, examined by the Club's Veterinary Surgeon and passed fit to race. The start was further delayed owing to an interstate delay.

MAIL IT IN (S. Carr) jumped away awkwardly, shifted out and contacted THIS KID ROCKS (T. Pannell).

HAZY LANE (J. Toeroek) jumped away awkwardly.

Shortly after the start THIS KID ROCKS (T. Pannell) and ON DUTY (B. Claridge) shifted in to obtain a position forward in running and in doing so THIS KID ROCKS crossed the running of MAIL IT IN (S. Carr), which became awkwardly placed on the heels of THIS KID ROCKS and when being restrained got its head up and raced ungenerously for a number of strides. B. Claridge, the rider of ON DUTY and T. Pannell, the rider of THIS KID ROCKS was shown the vision of the incident and advised to take greater care when shifting ground in future.

Approaching the 800 metres GALAXY GAZER (J. Childs) made the turn awkwardly, shifted out and contacted ON DUTY (B. Claridge).

ALSHIMA (S. Guymer) raced greenly during the event and raced wide rounding the home turn and into the straight.

B. Claridge, the rider of ON DUTY explained the filly pulled hard in the early stages, was off the bridle in the vicinity of the 500 metres and failed to finish the event off. ON DUTY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 1 : HUGHES CHAFFEURED LIMOUSINES HANDICAP - 1300 metres (Cont'd)

M. Neilson, the rider of LAHQA, reported his mount hung out in the straight. LAHQA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ALSHIMA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

IXCATAN was examined by the Club's Veterinary Surgeon who reported the gelding to be displaying signs of mild tying up in its hindquarters.

RACE 2 : SCHWEPPE HANDICAP - 1400 metres

RED ECLIPSE (C. Lindop) was slow to begin.

BORISTAR (E. Boyd) dipped for no apparent reason in the vicinity of the 600 metres.

Shortly after the entrance to the straight SPUN DRY (S. Guymer) was disappointed for clear running when attempting to improve between JUSTIFY THAT (S. Carr), which maintained its line and BORISTAR (E. Boyd), which commenced to roll in resulting in S. Guymer having to steady his mount for several strides before improving between these two runners.

P. Gatt pleaded guilty to a charge under 137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$100.

J. Toeroek, the rider of REDEEM BOUNTY explained he had intended to obtain a position one out one back and was comfortable with his position in running in the early stages, however, added that owing to the apparent lack of pace in the event, his mount commenced to over-race in the early and middle stages of the event and inside the half mile was unable to improve his position owing to the position of LITTLE AKIE (K. Bishop) to his outside. He stated that as a result of the position of LITTLE AKIE and the pace in the event, he was of the opinion that his horse's momentum was impacted and as a consequence he was outprinted in the finish. REDEEM BOUNTY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : MITTYS HANDICAP - 1950 metres

CRUZ'N NOW (P. Gatt) was slow to begin.

DANOULI (T. Pannell) hung out throughout the event.

CRUZ'N NOW (P. Gatt) was inclined to lay out from in the vicinity of the 500 metres.

S. Guymer, the rider of MISS WYNETTE reported the mare was disappointing in its performance. MISS WYNETTE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : MOET & CHANDON PLATE - 1000 metres

The start of this event was delayed approximately two minutes owing to RAHEEBA (M. Neilson) rearing behind the barriers dislodging M. Neilson and galloping for some distance prior to being captured near the 1800 metres. RAHEEBA was declared a late scratching by order of Stewards at 2.08 pm. M. Neilson was examined by the First Care Medical Personnel and declared fit to fulfil his remaining engagements. Mr C. Bieg was advised that in view of the gelding's behaviour it would now be required to prove tractable at the barriers in an Official Barrier Trial prior to being presented for a future race.

RACE 4 : MOET & CHANDON PLATE - 1000 metres (Cont'd)

COUNTER PULSE (C. Lindop) jumped away awkwardly, shifted in and contacted NINA BAY (S. Guymer), which was inconvenienced.

REGAL ROGUE (S. Carr) jumped away awkwardly.

In the vicinity of the 400 metres NINA BAY (S. Guymer) rolled out and contacted the hindquarters of KARLOVASI (J. Toeroek) resulting in NINA BAY becoming unbalanced for a number of strides.

S. Guymer, the rider of NINA BAY reported the filly laid in and felt sore and for that reason he did not persevere with his riding over the final 100 metres of the event.

ITZ INVINCIBLE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : WILLIAM HILL HANDICAP - 1300 metres

VIKING RANSOM (J. Childs) and BLACK CAESAR (S. Carr) were awkward to begin.

VIKING RANSOM (J. Childs) raced keenly in the early stages of the event and then raced wide without cover from in the vicinity of the 900 metres.

ZIP DELICIOUS (A. Doyle) was unable to obtain clear running from shortly after the entrance to the straight owing to the position of FLAMIN' MOGUL (M. Neilson). Thereafter in the vicinity of the 200 metres, as FLAMIN' MOGUL rolled out, a tight run developed to the inside of that horse but ZIP DELICIOUS was unable to improve into that run. As a consequence ZIP DELICIOUS became held up for clear running until in the vicinity of the 100 metres. A. Doyle explained that owing to the position of FLAMIN' MOGUL over the concluding stages, he was reluctant to improve to the inside of that horse over the final 100 metres.

SCHERZOSO (S. Guymer) laid in, in the straight.

NUTHERBOTTLEGONSKI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

VIKING RANSOM was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. Trainer Mr N. Blackiston was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

RACE 6 : DARLEY HANDICAP - 1000 metres

CAPTAIN PUNCH (P. Gatt) and BAY ROAD (J. Toeroek) were awkward to begin.

NORDIC ECLIPSE (S. Carr) was very awkward to begin.

CAPTAIN PUNCH (P. Gatt) over-raced in the early and middle stages of the event and in the vicinity of the 600 metres became awkward on the heels of ONE MORE DAISY (Z. Spain) and when being restrained rolled out onto I'M A FLYING STAR (C. Lindop) contacting that filly which was inconvenienced.

Mr R. Jolly, the Trainer of KHAPTIVATA, was advised that owing to this gelding proving fractious in its barrier stall, a warning had been placed on it, in relation to its barrier manners.

RACE 6 : DARLEY HANDICAP - 1000 metres (Cont'd)

S. Carr, the rider of NORDIC ECLIPSE explained that her instructions and intentions were to lead in this event but owing to the manner in which the gelding began, she was unable to take up a forward position and was obliged to settle back.

Correct weight for this event was delayed to allow Stewards to view the vision in relation to CAPTAIN PUNCH, BAY ROAD and NORDIC ECLIPSE at the start.

NORDIC ECLIPSE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Trainer Mr G. Richards was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

CASHED was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : EVRIGHT HANDICAP - 1000 metres

POITIER which had not raced since January 2014 was examined by the Club's Veterinary Surgeon prior to the event and passed fit to race.

OUTLANDISH LAD (E. Finnegan) stood flat footed as the gates were released and was slow to begin losing many lengths.

PRONTO PRONTO (S. Price) raced keenly in the early stages of the event.

TOM'S LUCK (S. Carr) was disappointed for clear ground at the entrance to the straight until approaching the 200 metres where she was obliged to alter course to the outside of runners to obtain clear running.

PISTOLIER (J. Toeroek) was held up for a number of strides at the entrance to the straight when racing between the heels of CLASSY JACK (P. Gatt) and ALABAMA MISSILE (E. Boyd).

ALABAMA MISSILE (E. Boyd) was inclined to lay out over the concluding stages and shifted out under pressure inconveniencing OUR SNIPPY (K. Bishop), which had to be steadied.

E. Boyd, the rider of ALABAMA MISSILE reported her saddle shifted sideways over the concluding stages of the event.

P. Gatt, the rider of CLASSY JACK reported his mount felt sore in the near foreleg. CLASSY JACK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

OUTLANDISH LAD was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

PRONTO PRONTO was examined by the Club's Veterinary Surgeon who reported a skin irritation. First aid was administered.

RACE 8 : DRINK DRIVING? GROW UP HANDICAP - 1300 metres

MYWORDSAIDTHEBIRD (J. Toeroek) over-raced in the early and middle stages of the event. J. Toeroek reported that as a consequence of his mount pulling hard in the early and middle stages of the event the gelding did not finish the race off.

RACE 8 : DRINK DRIVING? GROW UP HANDICAP - 1300 metres (Cont'd)

DAZZLING LILLY (S. Guymer) shifted out rounding the turn near the 900 metres taking WARATOR (E. Finnegan) wider on the track.

Approaching the 600 metres SECRETMENSBUSINESS (Z. Spain) raced in restricted room to the inside of MYWORDSAIDTHEBIRD (J. Toeroek), brushed the running rail and lost his position.

Z. Spain, the rider of SECRETMENSBUSINESS reported his mount hung out rounding the home turn.

At the entrance to the straight WISE JOURNEY (S. Carr) became held up for clear running when racing behind DAZZLING LILLY (S. Guymer) and MYWORDSAIDTHEBIRD (J. Toeroek) and was obliged to alter course to the outside of DAZZLING LILLY to obtain clear running in the vicinity of the 200 metres.

M. Neilson, the rider of TANGIER SUN explained his instructions were to either lead or obtain a position near the lead. He stated that shortly after the start he considered the position of ONEHUNDREDCLICKS (NZ) (P. Gatt) to his inside which was ridden aggressively in the early stages and elected to take the option of settling to the outside of this horse and allowing that horse to take the lead. He further added that the gelding travelled well until shortly after the entrance to the straight but when asked for an effort, failed to respond to his riding and finished the race off disappointingly. TANGIER SUN was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. Trainer J. O' Connor was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.
