Report on Race Meeting held at the Penola Racecourse
by the Penola Racing Club on Sunday, 12 July 2015

RACE 1 : PENOLA & DISTRICT COMMUNITY BANK / SABOIS TWO-YEAR-OLD & OVER MAIDEN PLATE - 1700 metres

The start of this event was delayed approximately four minutes owing to the First Care Medical vehicle becoming bogged down on the inner track.

GRAND FRENZY (M. Munday) shifted in on jumping away and brushed MONEYCANTBUYMELOVE (D. Dunn).

RACE 2 : ADRIAN THOMAS INDUSTRIAL / SABOIS TWO-YEAR-OLD & OVER MAIDEN PLATE - 1100 metres

MONTRE (M. Munday) knuckled on jumping away and was slow to begin.

GENEROUS GEORGE (C. Puls) shifted in on jumping away contacting LEGAL VEINE (J. Frew), which was hampered when tightened onto CLONMEL (C. Jones).

MONTRE (M. Munday) raced keenly in the early and middle stages of the event.

GODDESS OF FORTUNE (E. Finnegan) was inclined to lay in under pressure in the straight.

D. Dunn, the rider of MUDSLINGER, explained the gelding had travelled well in the early and middle stages of the event, however, when placed under pressure did not respond as he had anticipated and in his opinion, had not appreciated the track condition. MUDSLINGER was examined by the Club's Veterinary Surgeon who reported the gelding to be shin sore. Trainer, Ms S. Murphy, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

RACE 3 : FINNS FINE FOODS / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE - 1400 metres

BOULDERADA (D. Tootell) jumped away awkwardly and shifted in contacting FICKLE TIME (K. Bishop).

J. Maund, the rider of WHYCLASS, which performed poorly, explained the gelding had not travelled well at any stage during the event and when asked for an effort in the vicinity of the 1000 metres, had failed to respond to his riding and in his opinion did not handle the track condition. WHYCLASS examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

HASTA LA GERRY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Stewards questioned K. Bishop, the rider of FICKLE TIME in relation to her instructions in this event. K. Bishop explained the mare had been slow to begin at its most recent start, however, was advised if FICKLE TIME had begun well she should push forward and obtain a forward position. Trainer, Mr R. Gilchrist, confirmed these instructions and advised they were similar to those provided to riders in recent starts.

RACE 4 : KATNOOK ESTATE RATING 0-62 HANDICAP - 1100 metres

At the entrance to the straight MASTER BLACK (Z. Spain) was reluctant to improve into a tight run between the heels of SCHADUW (E. Finnegan) and HASTA LA GORBY (C. Jones) and was only able to obtain clear ground in the vicinity of the 100 metres.

From approaching the 400 metres until the entrance to the straight, HELANDY (C. Puls) was held up when racing behind HASTA LA GORBY (C. Jones) and inside KINGS LANDING (B. Claridge), which had commenced to weaken.

HASTA LA GORBY (C. Jones) was inclined to lay in under pressure in the straight.

RACE 5 : CLASSICBET BENCHMARK 72 HANDICAP - 1300 metres

HASTA LA SHAMER (B. Claridge) jumped away awkwardly and was slow into stride.

TELASNIP (C. Jokic) was slow to begin.

RACE 6 : RICHARD RAY INSURANCE BROKERS RATING 0-58 HANDICAP - 1400 metres

E. Finnegan replaced B. Claridge as the rider for SHE BE SMOKIN' as there was no senior rider available on course.

BIANMAGIC (J. Frew) stood flat footed and was slow to begin, missing the start several lengths.

CREON (C. Puls) and MISS WAIROA (M. Munday) were slow to begin.

MISS WAIROA (M. Munday) and QUAD (C. Jokic) raced keenly in the early and middle stages of the event.

JUST CALL ME BRUCE, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : RICHARD RAY INSURANCE BROKERS RATING 0-58 HANDICAP
- 1400 metres (Cont'd)

E. Boyd, the rider of LE MARO, which performed poorly, explained the gelding had travelled well in the early and middle stages of the event, however, had become awkward in the vicinity of the 400 metres and she became concerned with its action over the concluding stages. LE MARO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : COOPERS BREWERY RATING 0-68 HANDICAP - 1700 metres

The start of this event was delayed approximately two minutes owing to ANGEL SUEZ (D. Tootell) being examined by the Club's Veterinary Surgeon on arrival at the barriers after being contacted by DESDANE (B. Claridge) on leaving the mounting yard. ANGEL SUEZ was passed fit to race.

STREET BALL (M. Munday) shifted in on jumping away contacting KEETIMO (A. Doyle), which was inconvenienced.

LEATHAL'S LEGACY (J. Frew) raced wide without cover throughout the event.

In the vicinity of the 300 metres KEETIMO (A. Doyle) improved onto the heels of FREDICHEV (Z. Spain), which had commenced to give ground resulting in A. Doyle being forced to take hold to avoid that gelding's heels. A. Doyle, the rider of KEETIMO, explained he was aware that FREDICHEV had commenced to give ground and had anticipated the gelding would roll off the fence rounding the turn as it was weakening, however, as FREDICHEV held its line he became awkwardly placed on that gelding's heels and was forced to take hold. Stewards advised A. Doyle they thought he had erred in his judgement and in future should consider all options sooner than he had on this occasion.
