STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 18 July 2015

TRACK: Soft 6 (*Upgraded to a Soft 5 at 2.05 pm retrospective to Race 4*)

WEATHER: Overcast

RAIL: Out 2 metres entire Circuit. Sectional 602 metres

RACE 1 : SCHWEPES HANDICAP- 2400 metres

KING CADEL (E. Finnegan) got its head up and raced ungenerously for a short distance in the early stages when being restrained. As a consequence LENNYBE (T. Pannell), which was following was inconvenienced.

DOCTOR CARE (NZ) (B. Egan) over-raced in the early stages of the event.

J. Toeroek, the rider of HIOCTDANE, reported his mount hung out from in the vicinity of the 400 metres.

J. Holder, the rider of FLYING CASINO, explained that owing to the lack of pace in this event, when asked to quicken inside the 400 metres, FLYING CASINO was unable to sprint with the leaders in its usual manner. FLYING CASINO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Stewards inquired into the reason R. Hurdle was unable to make the weight on ARTFUL DIVA. R. Hurdle pleaded guilty to a charge under AR120(b) and was fined \$200. In addition Stewards ordered that R. Hurdle's minimum riding weight be increased from 54kg to 54.5kg effective midnight Saturday, 18 July 2015.

RACE 2 : HUGHES CHAUFFEURED LIMOSINES HANDICAP - 1400 metres

AL SHAMEEL (NZ) (B. Egan) shifted out shortly after the start and inconvenienced PEPPERMINT GREY (S. Price), which was taken wider on the track.

Approaching the 1000 metres SILENT ICE (P. Gatt) raced greenly, brushed the running rail and thereafter in the vicinity of the 900 metres was inconvenienced as HOUR OF POWER (S. Carr) rolled in slightly, contacted the running rail and when being restrained became awkward on the heels of HOUR OF POWER for several strides. As a consequence MAIL IT IN (C. Lindop), which was following, was obliged to be steadied, shifted out and raced wide without cover for the remainder of the event.

HOUR OF POWER (S. Carr) raced greenly inside the 800 metres for a short distance.

RACE 2 : HUGHES CHAUFFEURED LIMOSINES HANDICAP - 1400 metres (cont'd)

MAIL IT IN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

M. Neilson, the rider of ROBERTSON QUAY, reported the gelding felt awkward in its action during the event. ROBERTSON QUAY was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

RACE 3 : WILLIAM HILL HANDICAP - 1950 metres

MARYORE (B. Claridge) was slow to begin.

THING OF NOTHING (IRE) (J. Holder) and BUYMEBYCHANCE (S. Carr) brushed shortly after the start.

THING OF NOTHING (IRE) (J. Holder) got its head up and was inclined to lay out when being restrained near the 1800 metres and continued to race ungenerously for a short distance and in the vicinity of the 1700 metres when ZAHSPPEED (M. Neilson) crossed THING OF NOTHING (IRE) again got its head up when being restrained and raced very ungenerously making the turn awkwardly.

In the vicinity of the 300 metres WOLF CREEK (Z. Spain) shifted out to obtain clear running taking MOONIES CHOICE (T. Pannell) out resulting in MOONIES CHOICE being disappointed for clear ground between WOLF CREEK and METEORBOUND (NZ) (P. Gatt). As a consequence MOONIES CHOICE was obliged to alter course to the inside of WOLF CREEK approaching the 150 metres to obtain clear running. Z. Spain was reminded of his obligation when shifting ground in future.

J. Holder, the rider of THING OF NOTHING (IRE) explained his mount failed to settle in the early stages of the event and was inclined to race very ungenerously.

T. Pannell, the rider of MOONIES CHOICE, reported his mount was inclined to lay in, in the vicinity of the 500 metres and as a consequence, he was unable to improve to the outside of METEORBOUND (NZ) (P. Gatt). MOONIES CHOICE was examined by the Club's Veterinary Surgeon who reported the gelding had an irregular heartbeat. Trainer, Mr J. Smith was advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing to the satisfaction of Stewards in an Official Barrier Trial, after which it is to be auscultated by a Veterinary Surgeon.

B. Claridge, the rider of MARYORE, explained in his opinion the filly may have come to the end of its preparation and did not finish the race off as expected. MARYORE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : EVRIGHT HANDICAP - 1250 metres

MOLLY THE SNIP (J. Holder) raced wide without cover in the early and middle stages of the event.

TENERE (M. Neilson) was held up for clear running from inside the 500 metres until near the 300 metres where it was obliged to alter course to the outside of the field to obtain clear running.

RACE 4 : EVRIGHT HANDICAP - 1250 metres (Cont'd)

COUNTER SPIN (C. Lindop) was held up for clear running from inside the 500 metres until approaching the 150 metres where it was obliged to alter course to the inside of DAZZLING LILLY (S. Guymmer) to obtain clear ground.

Approaching the 200 metres CHICKAMAUGA (S. Carr), which commenced to weaken, rolled about and shifted out and inconvenienced IRON FOCUS (J. Toeroek), which was obliged to alter course to avoid that horses heels.

CHONDRA was examined by the Club's Veterinary Surgeon who reported a minor laceration to its gums.

COUNTER SPIN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Following the running of this event the track was upgraded to a Soft 5 at 2.05 pm retrospective to Race 4.

RACE 5 : FLAIR CURTAINS & BLINDS HANDICAP - 1250 metres

In the vicinity of the 700 metres EDIT (S. Price) rolled out and became awkward on the heels of ORANGE RIVER (W. Egan) and raced ungenerously for a number of strides.

Inside the 700 metres PATCH HERO (Z. Spain) improved to the inside of TURF CRUSHER (J. Holder) and shortly thereafter got its head up and commenced to hang out and made the turn in the vicinity of the 600 metres very awkwardly.

S. Carr, the rider of NICCELE, reported her mount raced greenly during the event and was inclined to lay out.

COOL HERO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

OUR PROSPECT lost its off hind plate during the event.

RACE 6 : MEDALLION HOMES HANDICAP - 1400 metres

STARKIATO which had not raced since May 2014 was examined by the Club's Veterinary Surgeon who passed the gelding fit to race.

RED ECLIPSE was examined on arrival at the barriers by the Club's Veterinary Surgeon who passed the gelding fit to race.

THEATREMAN (S. Price) over-raced in the early stages of the event.

In the vicinity of the 1000 metres WISE AND HAPPY (S. Carr) brushed the running rail and rolled out tightening SATURDAY AFFAIR (C. Lindop), which was taken out onto the heels of CREANCE (S. Cahill). As a consequence C. Lindop was obliged to steady her mount.

STARKIATO (Z. Spain) became awkward in its action for several strides in the vicinity of the 700 metres unbalancing its rider.

WISE AND HAPPY (S. Carr) was held up for clear running from in the vicinity of the 500 metres until near the 300 metres.

CREANCE (S. Cahill) was held up for clear running from in the vicinity of the 500 metres until near the 300 metres.

RACE 6 : MEDALLION HOMES HANDICAP - 1400 metres (Cont'd)

Z. Spain, the rider of STARKIATO, reported the gelding laid in during the event.

SATURDAY AFFAIR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : IRISH RACE DAY 29TH AUGUST HANDICAP - 1000 metres

PIONEER PRINCE (E. Boyd) jumped away awkwardly and was slow into stride.

PIONEER PRINCE (E. Boyd) raced keenly in the early and middle stages of the event and was inclined to lay out over the concluding 700 metres.

CASH IS COMING (C. Lindop) raced wide without cover throughout the event.

In the vicinity of the 300 metres ALABAMA MISSILE (R. Hurdle) was disappointed when attempting a run between the heels of DAUNTING DANCER (P. Gatt) and OUR SNIPPY (K. Bishop) and forced to alter course to the outside of OUR SNIPPY to obtain clear ground.

In the vicinity of the 200 metres READY SUNSHINE (C. Jones) was momentarily held up when attempting a tight run between CASH IS COMING (C. Lindop) and TOM'S LUCK (S. Carr).

READY SUNSHINE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

JENNYFROMTHEBLOCK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : DRINK DRIVING? GROW UP HANDICAP - 1400 metres

ONEHUNDREDCLICKS (NZ) which lost its near hind plate in the parade ring prior to proceeding to the mounting yard was attended to by the Farrier and examined by the Club's Veterinary Surgeon who passed the gelding fit to race, prior to proceeding to the barriers.

SILVER SEBRING which contacted the gate on leaving the mounting yard was examined by the Club's Veterinary Surgeon on arrival at the barriers and passed fit to race.

The start of this event was delayed approximately two minutes owing to COME FOLLOW ME becoming fractious in its barrier and rearing, getting its head over the front partition of its gate. COME FOLLOW ME was examined by the Club's Veterinary Surgeon who declared the mare unfit to race. Acting on this advice Stewards declared COME FOLLOW ME to be a late scratching at 4.35 pm. Trainer, Mr D. Jolly was advised a warning had been placed on the mare in relation to its barrier manners.

TANGIER SUN (S. Carr) and SILVER SEBRING (A. Doyle) were awkward to begin.

JACKTHEGIANTSLAYER (S. Cahill) knuckled at the start.

Shortly after the start MEADOWS ANGEL (K. Bishop) was tightened onto RAINBOW ROOM (S. Guymmer) by UNSPUN (C. Jones) as that horse shifted out.

Approaching the 1000 metres EMMOOKI'S STAR (T. Pannell) got its head up and raced ungenerously, shifted out onto ALYSIANA (M. Neilson), which was taken out onto BABITZIN (J. Toeroek). As a consequence UNSPUN (C. Jones), which was following became awkward on the heels of BABITZIN for a number of strides and shifted out taking MEADOWS ANGEL (K. Bishop) wider.

RACE 8 : DRINK DRIVING? GROW UP HANDICAP - 1400 metres (Cont'd)

S. Carr, the rider of TANGIER SUN, reported the gelding, whilst feeling normal in its action and normal in its breathing did not respond to her riding and failed to finish the race off as expected.

TANGIER SUN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

MEADOWS ANGEL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BABITZIN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
