THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Gawler Racecourse by the Gawler & Barossa Jockey Club on Sunday, 26 July 2015

RACE 1 : SANDERS FODDER / SABOIS DISTANCE MAIDEN PLATE - 2124 metres

Inside the 1900 metres ROMULUS FLIGHT (C. Lindop), which was over racing, shifted out and contacted THE BABY SITTER (L. Stojakovic).

SINAWEH (K. Bishop) stepped the crossing in the vicinity of the 1800 metres and then commenced to over race until the middle stages of the event.

MONICA'S MACHINE (J. Bowditch) raced fiercely in the early and middle stages of the event.

Rounding the home turn in the vicinity of the 300 metres PADLOT (IRE) (S. Guymer) shifted out when insufficiently clear of ROMULUS FLIGHT (C. Lindop), which was taken out and clipped the heels of MONICA'S MACHINE (J. Bowditch) resulting in ROMULUS FLIGHT falling, dislodging C. Lindop. SCOOTER HOOTER (S. Price) was unable to avoid the fallen horse and knuckled dislodging S. Price. THE BABY SITTER (L. Stojakovic) and DEHERE'S MOMENT (T. Pannell) were hampered in avoiding the fallen rider. S. Guymer pleaded guilty to a charge of Careless Riding under AR137(a) in that he allowed his mount to shift out when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 5 August and to conclude at midnight on Sunday, 30 August 2015: a period of eleven (11) meetings. Stewards ordered that this suspension be served cumulatively to the suspension S. Guymer received on Saturday, 25 July 2015. C. Lindop was examined by the First Care Medical Personnel and was stood down for the remainder of the day. S. Price was examined by the First Care Medical Personnel and was passed fit to fulfil his remaining engagements.

ROMULUS FLIGHT, SCOOTER HOOTER and PADLOT (IRE) were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2: PUBLICANS DAY 19 AUGUST / SABOIS MAIDEN PLATE - 1212 metres

KAPSCERO (B. Claridge) shifted in on jumping away and brushed WHITE JADE (D. Tourneur) and shortly after, shifted out bumping SUPER BONUS (M. Neilson).

MIDSOMER BARNABY (T. Zanker) shifted out on jumping away and brushed WILLANDER MISS (S. Price).

JUST DEMANDING (S. Carr) shifted in on jumping away onto LAST MOMENT (T. Pannell), which lost its position when tightened onto LISA'S GEM (K. Bishop).

JUST DEMANDING (S. Carr) raced wide without cover throughout the event.

MIDSOMER BARNABY (T. Zanker) laid in under pressure in the straight. MIDSOMER BARNABY was examined by the Club's Veterinary Surgeon who reported had a small abrasion to the left corner of the mouth.

JUST DEMANDING (S. Carr) shifted in approaching the finish and contacted KAPSCERO (B. Claridge).

M. Neilson, the rider of SUPER BONUS, which performed below expectations, explained the gelding had not travelled well throughout the event and when placed under pressure in the vicinity of the 800 metres had failed to respond to his riding and finished the event off poorly. SUPER BONUS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: WOLF BLASS GREY LABEL / SABOIS TWO-YEARS-OLD MAIDEN PLATE - 1200 metres

The start of this event was delayed approximately one minute to avoid a clash with an interstate race.

INCANTARE (M. Neilson) shifted in on jumping away and bumped REGAL VISION (D. Tootell).

On jumping away SINGLE BARREL (S. Cahill) shifted out and away from COLONEL CUSTER (NZ) (D. Tourneur) contacting SHE'S A STORM (S. Carr).

ALASKAN JADE (B. Claridge) jumped away awkwardly.

SHE'S A STORM (S. Carr) raced keenly in the early and middle stages of the event.

RED ORCHID (K. Bishop) raced wide without cover throughout the event. RED ORCHID was examined by the Club's Veterinary Surgeon who reported the filly had quartered the lateral bulb of the off hind heel. First aid administered.

ALASKAN JADE (B. Claridge) was inclined to lay in, in the straight and in the vicinity of the 200 metres shifted in slightly onto SILENT ICE (P. Gatt), which was inclined to lay in and away from that filly.

Approaching the finish COLONEL CUSTER (NZ) (D. Tourneur) shifted out and away from the winning post inconveniencing ALASKAN JADE (B. Claridge), which was taken wider.

RED ORCHID lost its near fore plate during the event.

RACE 4: GLENRAE STUD / SABOIS F&M MAIDEN PLATE - 1112 metres

Acting on confirmed advice from Mr D. Batters the Trainer of MOSTA CHARM, that the filly was lame and would be unfit to race, Stewards ordered the withdrawal of MOSTA CHARM at 8.08 am.

ULTIMATE THRILL (D. Tourneur) jumped away awkwardly and was slow to begin.

ACCIDENTAL JOURNEY (K. Bishop) was held up from the vicinity of the 600 metres until approaching the 200 metres when awkwardly placed on the heels of PIACENZA (S. Guymer).

JESSIE'S OWN (T. Pannell) lost its near fore plate during the event.

- T. Pannell, the rider of JESSIE'S OWN, reported that in his opinion the mare had not handled the track condition. JESSIE'S OWN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
- S. Guymer, the rider of PIACENZA, explained the filly had travelled well in the early and middle stages of the event, however, when placed under pressure at the entrance to the straight, failed to respond to his riding and had finished the event off poorly. PIACENZA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : COOPERS - VINTAGE BEER CLASS ONE HANDICAP - 1512 metres

On arrival at the barriers STREET GLASS was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the near foreleg and would be unfit to start. Acting on that advice Stewards withdrew STREET GLASS at 3.26 pm. Trainer Ms S. Murphy was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

RICCONE (S. Guymer) and TANE MAHOUTA (E. Boyd) raced keenly in the middle stages of the event.

HOST ESPRIT (J. Potter) had difficulty in obtaining clear ground at the entrance to the straight and approaching the 200 metres was obliged to alter course to the outside of BIG BOY BLEV (M. Neilson) to obtain clear ground.

Stewards questioned D. Tourneur, the rider of LUCKSA, into his riding of this gelding over the concluding stages. After doing do D. Tourneur pleaded guilty to a charge under AR137(b) in that he failed to ride his horse out to the end of the race and was fined \$500.

RACE 6: GAAWLER SOUTH BAKERY RATING 0-58 HANDICAP - 1712 metres

KOOMA BLAZE (B. Claridge) raced wide without cover throughout the event.

Approaching the 200 metres NOBLE ROMP (G. Willoughby) shifted out and contacted LYDIARD (S. Carr).

NOBLE ROMP lost its off fore plate during the event.

A. Doyle, the rider of WARRASIDE, explained that he had been instructed to lead on the gelding from a wide barrier, however, after obtaining the lead he had attempted to restrain the gelding so he did not extend his lead on the field. He stated that as WARRASIDE commenced to fight him and he formed the opinion that as the gelding was traveling well, he would allow it to stride. He added that WARRASIDE continued to travel well until the entrance to the straight where he placed the gelding under pressure.

RACE 7: SPORTSBET LIVE RACING RATING 0-62 HANDICAP - 1112 metres

ZANDERCAN (A. Doyle) shifted in on jumping away and bumped COMBAT DANCER (D. Caboche).

Shortly after the start RITZY DANE (T. Pannell) dipped when tightened onto HASTA LA GORBY (J. Potter) by ELECTRIC PUSSYCAT (M. Neilson), which shifted out on jumping away.

HEISENBERG (R. Hurdle) and HASTA LA GORBY (J. Potter) raced wide without cover throughout the event.

ZANDERCAN (A. Doyle) laid out under pressure in the straight.

- J. Maund, the rider of SHAVANO'S IMAGE, explained the mare had travelled well in the early and middle stages of the event, however, when placed under pressure in the vicinity of the 600 metres had failed to respond to his riding and finished the event off poorly. SHAVANO'S IMAGE was examined by the Club's Veterinary Surgeon who reported had an elevated heart rate.
- M. Neilson, the rider of ELECTRIC PUSSYCAT explained the mare had travelled well in the early stages, however, when placed under pressure, the mare had failed to respond to his riding and he had become concerned with its action over the concluding stages. ELECTRIC PUSSYCAT was examined by the Club's Veterinary Surgeon who reported an elevated heart rate.
