Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 1 August 2015

RACE 1: NICOLLE HARVEY HANDICAP - 1950 metres

Mr T. McEvoy, the Trainer of TIP RAT, advised Stewards prior to the event that he would instruct his rider, T. Pannell to attempt to be more positive in the early stages of the event.

TIDY PROPHET (M. Neilson) raced wide without cover in the middle stages of the event.

Approaching the 300 metres TIP RAT (T. Pannell) shifted out under riding tightening MOST HUSBANDS (J. Holder) onto KIORA (E. Finnegan), which rolled in marginally, resulting in J. Holder having to steady his mount and losing his position. T. Pannell, the rider of TIP RAT pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 5 August, and to conclude at midnight on Wednesday 12 August 2015: a period of three (3) meetings.

RACE 2: DAVID NASH HANDICAP - 1300 metres

On arrival at the barriers SILENT ICE, which contacted the running rail with its hindquarters was examined by the Club's Veterinary Surgeon and passed fit to race.

GLOBAL SQUIRE (S. Cahill) raced wide without cover throughout the event.

Approaching the 600 metres REGAL ROGUE (C. Lindop), which had commenced to race keenly, became awkward on the heels of FINKE (T. Pannell) for a short distance.

Over the concluding stages SILENT ICE (J. Holder) raced in restricted room between KARLOVASI (P. Gatt), which rolled out and ALASKAN JADE (B. Claridge), which shifted in.

Correct weight for this event was delayed to allow J. Holder, the rider of SILENT ICE, to view the vision in the straight.

J. Holder, the rider of SILENT ICE was questioned regarding the use of his whip prior to the 100 metres. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$100. J. Holder also pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in a forehand manner in consecutive strides prior to the 100 metres and was reprimanded.

RACE 2: DAVID NASH HANDICAP - 1300 metres (Cont'd)

P. Gatt, the rider of KARLOVASI, was questioned in regard to using his whip with an action that raised his arm above shoulder height over the concluding stages. P. Gatt was reprimanded and advised in future stronger action may be taken against him if he reoffends.

CELESTIAL STORY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

DELARUE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: JOCKEY CELEBRATION DAY HANDICAP - 2400 metres

The start of this event was delayed approximately two minutes owing to KING CADEL becoming fractious and having to be removed from its barrier stall. KING CADEL was examined by the Club's Veterinary Surgeon and passed fit to race.

ARTFUL DIVA (C. Lindop) lost its position at the start when tightened between FLYING CASINO (J. Holder) and SIR LASZLO (NZ) (J. Bowditch), which both shifted ground.

E. Finnegan, the rider of KING CADEL reported her mount felt lame on return to the mounting yard. KING CADEL was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mr R. Jolly was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

SIR LASZLO (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4: LYNETTE DAY HANDICAP - 1400 metres

USTINOV'S FURY (R. Hurdle) was awkward to begin.

TANKSTER (C. Jones) was awkward and slow to begin.

In the vicinity of the 600 metres USTINOV'S FURY (R. Hurdle), which had raced keenly became awkward between the heels of PRONTO PRONTO (J. Bowditch) and STREETCAR VALOUR (M. Neilson) and improved into a tight run between these two runners of its own accord and contacted the hindquarters of STREETCAR VALOUR, which became unbalanced.

SATURDAY AFFAIR (C. Lindop) was held up for clear running from inside the 350 metres when racing behind STREETCAR VALOUR (M. Neilson) and to the inside of USTINOV'S FURY (R. Hurdle) and was obliged to alter course to the outside of these runners to obtain clear running and was only able to obtain clear running inside the 200 metres.

C. Jones, the rider of TANKSTER, explained she intended to settle in the one-one position but owing to her mount being slow to begin she was obliged to settle a little further back than intended. She stated that notwithstanding this fact she was comfortable with her position in running but added the gelding did not finish the race off in the manner she expected. TANKSTER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : CRAIG CLOGG HANDICAP - 1250 metres

SUPER FUN (J. Holder) began awkwardly, shifted out and inconvenienced THE ULTIMATUM (D. Tourneur).

LORD ASHFORD (K. Bishop) was awkward to begin.

RACE 5 : CRAIG CLOGG HANDICAP - 1250 metres (Cont'd)

MARBLE RYE (Z. Spain) stood flat footed at the start and lost many lengths. Mr G. Richards, the Trainer of MARBLE RYE, was advised a warning had been placed on the gelding in relation to it beginning on terms with the field. MARBLE RYE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Trainer Mr G. Richards was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

Inside the 800 metres SUPER FUN (J. Holder) became awkward between the heels of CHONDRA (S. Price) and BARIGAN BOY (S. Cahill) for a short distance.

THE ULTIMATUM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6: ALLIE UMOFF HANDICAP - 1250 metres

IRONBANK which had not raced since August 2014 was examined by the Club's Veterinary Surgeon who passed the gelding fit to race.

HANK'S NEPHEW (C. Jones) raced keenly in the early and middle stages of the event.

Approaching the 900 metres KING'S PARDON (P. Gatt) became awkward on the heels of IRONBANK (C. Lindop), which when being restrained got its head up for a number of strides. As a consequence STRAYING TIGER (J. Potter), which was following shifted out and raced wide rounding the turn near the 900 metres. STRAYING TIGER (J. Potter) raced wide without cover for some distance thereafter. As a further result GOODFUN GIRL (R. Hurdle) became awkward on the heels of HANK'S NEPHEW (C. Jones), which had continued to over-race and became awkward inside the heels of IRONBANK for a number of strides.

- M. Neilson, the rider of UPBEAT, reported the gelding hung out in the straight. UPBEAT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
- S. Carr, the rider of NATURAL DISASTER, reported the mare hung out in the straight.

CLASSY JACK lost its off hind plate during the event.

KING'S PARDON lost its near hind plate during the event.

CLASSY JACK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: MICHAEL HANLON HANDICAP - 1250 metres

In the vicinity of the 200 metres SHADE OF GREEN (J. Bowditch) was tightened and obliged to be steadied when awkward between the heels of SHEEZ ON TOP (S. Price), which rolled in and away from SECRETMENSBUSINESS (Z. Spain), which laid in and SCHADUW (J. Potter), which shifted out to improve to the outside of LONGCHAMP BELLE (M. Neilson).

LONGCHAMP BELLE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ALABAMA MISSILE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8: NEIL DOHNT HANDICAP - 1400 metres

Stewards acceded to a request by Trainer Mr M. Hibbs, the trainer of TURF CRUSHER that the gelding be withdrawn from the race owing to the track downgrade. TURF CRUSHER was declared a late scratching by order of Stewards at 2.15 pm.

The start of this event was delayed approximately four minutes owing to GRANCABRIO refusing to proceed to the barriers despite the efforts of the Clerks of the Course. GRANCABRIO was declared a late scratching at 4.41pm by order of Stewards and was returned to the mounting enclosure. Mr L. Kennewell, the Trainer of GRANCABRIO, was advised that in view of the gelding's refusal to proceed to the barriers it is now suspended and must proceed without delay to the barriers in an Official Barrier Trial prior to accepting for a future race.

UNSPUN (P. Gatt) was slow to begin.

THEATREMAN (R. Hurdle) over-raced in the early stages of the event.

WISE JOURNEY (K. Bishop) raced keenly in the early stages of the event.

ALYSIANA (M. Neilson) hung out throughout in the straight.

Z. Spain, the rider of JACKTHEGIANTSLAYER, explained the gelding travelled well in the early stages but when placed under pressure in the vicinity of the 600 metres failed to respond to his riding and in his opinion was not suited by today's track conditions. JACKTHEGIANTSLAYER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
