# Report on Race Meeting held at Roxby Downs Racecourse by the Roxby Downs & District Racing Club on Saturday, 1 August 2015

#### RACE 1 : CANCER COUNCIL RELAY FOR LIFE BENCHMARK 54 HANDICAP - 1000 metres

# RACE 2 : TOLL NORTH / SABOIS MAIDEN PLATE - 1000 metres

MARRIED FOR MONEY (A. Doyle) jumped away awkwardly and shifted in onto TILLY GIRL (K. Brooks), which was unable to maintain its position when tightened onto SUPER HAPPY (R. Bell).

Approaching the 300 metres SUPER HAPPY (R. Bell) was obliged to shift out around the heels of NOTORIOUS PRINCESS (G. Willoughby), which had begun to weaken, and rolled in.

R. Bell, the rider of SUPER HAPPY, was reminded of his obligations in relation to riding his mounts out to the finish.

G. Willoughby, the rider of NOTORIOUS PRINCESS, reported the mare was inclined to shift around from in the vicinity of the 600 metres and in the straight. NOTORIOUS PRINCESS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

D. Caboche, the rider of RED JIAN, reported the mare travelled fairly until the vicinity of the 800 metres when placed under pressure and failed to respond to his riding. RED JIAN, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

# RACE 3 : KALARI PTY LTD BENCHMARK 64 HANDICAP - 1200 metres

FINNISS MOMENT (D. Caboche) stood flat footed and as a result was slow to begin.

L. Stojakovic, the rider of MUMSLAD, reported that from in the vicinity of the 800 metres the gelding commenced to give ground and she became concerned with its action and for this reason did not ride MUMSLAD out to the finish. MUMSLAD was examined by the Club's Veterinary Surgeon who reported the gelding to be making excessive upper respiratory noise. Mr. B. Lear, the Trainer of MUMSLAD, was advised the results of an endoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

# RACE 4 : AEM CONSOLIDATED BENCHMARK 54 HANDICAP - 1400 metres

YOU AND ME (M. Henderson) jumped away awkwardly and shifted in, contacting the running rail.

# RACE 4 : AEM CONSOLIDATED BENCHMARK 54 HANDICAP - 1400 metres (Cont'd)

D. Caboche, the rider of BENJIDDAH, reported the gelding travelled well until the 600 metres when placed under pressure, failed to respond to his riding and finished the race off poorly. BENJIDDAH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

# RACE 5 : BHP BILITON ROXBY DOWNS OUTBACK CUP - 1800 metres

ISLAND BAR (D. Caboche) jumped away awkwardly.

CAPTAIN PERCY (G. Willoughby) was slow to begin.

K. Brooks, the rider of CALLMEDAN, reported the gelding never felt comfortable with the track condition and when placed under pressure in the vicinity of the 800 metres, failed to respond to her riding. CALLMEDAN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

# RACE 6 : BLUESCOPE RATING 0-62 HANDICAP - 1600 metres

RUN RUBY RUN, which was fractious in its race day stall, was examined by the Club's Veterinary Surgeon who reported superficial abrasions to both hind legs. RUN RUBY RUN was ruled fit to race.

QUIET CHAT (D. Caboche) jumped away awkwardly and shifted in, taking RUN RUBY RUN (R. Bell) in onto MORE PLEASE (A. Doyle), which was unable to maintain its position when tightened onto ANOTHER ENEMY (M. Henderson).

In the vicinity of the 1500 metres RUN RUBY RUN (R. Bell) was obliged to be steadied to avoid the heels of QUIET CHAT (D. Caboche), which shifted in. D. Caboche was severely reprimanded and advised to take greater care when shifting ground in future.

Approaching the 300 metres MORE PLEASE (A. Doyle) rolled out and inconvenienced TINSLEY GREEN (L. Stojakovic).

D. Caboche, the rider of QUIET CHAT, reported after finding a forward positon in the early stages of the event the mare travelled well until placed under pressure in the vicinity of the 800 metres where it failed to respond to his riding and finished the race off poorly. QUIET CHAT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
