Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 29 August 2015

RACE 1 : PETER ELBERG FUNERALS HANDICAP - 1200 metres

LAST BULLET (E. Finnegan) jumped away awkwardly, shifted in and inconvenienced C'EST BEAU LA VIE (C. Lindop).

C'EST BEAU LA VIE (C. Lindop) raced in restricted room for a short distance inside the 100 metres as ECLAIR ATTACK (D. Tourneur) rolled in.

D. Tourneur, the rider of ECLAIR ATTACK, explained his instructions were to settle back in the field. He added after taking up a position as intended; the gelding was off the bridle for most of the event and when asked for an effort in the straight, initially sprinted but then flattened out on its run and in his opinion may be better suited racing over longer distances. ECLAIR ATTACK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Correct weight for this event was delayed to allow Stewards to view the vision over the concluding stages.

RACE 2 : WILLIAM HILL IRISH HURDLE - 3200 metres

QUIZMAN (NZ) (N. O'Shea) jumped the hurdle near the 2000 metres awkwardly.

After jumping the hurdle near the 1600 metres AGREEMENT (NZ) (S. Pateman) shifted in taking QUIZMAN (NZ) (N. O'Shea) in onto ANGELOLOGY (NZ) (P. Hamblin), which had to be steadied when tightened for galloping room.

ANGELOLOGY (NZ) (P. Hamblin) had difficulty obtaining clear running for a short distance inside the 1600 metres when racing in restricted room.

COMPELLED (NZ) (J. Burke) contacted the first of the double in the straight on the final occasion and landed awkwardly.

RACE 2 : WILLIAM HILL IRISH HURDLE - 3200 metres (Cont'd)

AGREEMENT (NZ) (S. Pateman) jumped the first of the double in the straight on the final occasion awkwardly, shifted in and inconvenienced ANGELOLOGY (NZ) (P. Hamblin) and shortly thereafter approaching the 200 metres, ANGELOLOGY (NZ) raced in restricted room when tightened by AGREEMENT (NZ), which rolled in forcing ANGELOLOGY (NZ) to race in restricted room for a short distance leading up to the final hurdle. As a consequence ANGELOLOGY (NZ) was obliged to be steadied before jumping the final hurdle to avoid the inside wing, contacted the hurdle and landed very awkwardly unbalancing P. Hamblin.

P. Hamblin, the rider of ANGELOLOGY (NZ), explained that rounding the home turn he had difficulty obtaining clear running and approaching the entrance to the straight, he had intended improving to the outside of AGREEMENT (NZ) (S. Pateman) but owing to that gelding shifting out at the entrance to the straight, he elected to alter course to the inside of AGREEMENT (NZ) to improve his position. He added after jumping the first of the double in the straight near the three hundred metres, and owing to AGREEMENT (NZ) jumping the hurdle awkwardly, he was inconvenienced and taken in and was obliged to race in restricted room to the inside of this horse. He added thereafter approaching the 200 metres he was obliged to race in restricted room as AGREEMENT (NZ) rolled in and remained in restricted room until approaching the final hurdle, where he was obliged to steady his mount to shift away from the running line of the inside wing and as a consequence contacted the hurdle, landed awkwardly and became unbalanced. When questioned about whether he could have taken the option of steadying and taking a run to the outside of AGREEMENT (NZ) after jumping the first of the double in the straight, P. Hamblin stated that owing to the position he had relative to AGREEMENT (NZ), this was not an option to him in the circumstances and he was obliged to maintain his position inside AGREEMENT (NZ). In the circumstances S. Pateman was severely reprimanded for allowing his horse to roll in near the 200 metres, which resulted in ANGELOLOGY (NZ) racing in restricted room leading up to the final hurdle. S. Pateman was advised in future he is to ensure he rides with due care and provide other riders rightful running room.

COMPELLED (NZ) was examined by the Club's Veterinary Surgeon who reported a small puncture wound to the off fore above its knee.

ANGELOLOGY (NZ) was examined by the Club's Veterinary Surgeon who reported a minor laceration to the off fore canon. First Aid was administered.

All other runners were by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: RTC GROUP HANDICAP - 1200 metres

The start of this event was delayed approximately one minute owing to an interstate delay.

DAYTONA GREY (J. Holder) over-raced in the early and middle stages of the event.

RED ECLIPSE (S. Carr) was held up for clear running for a short distance rounding the home turn. RED ECLIPSE was examined by the Club's Veterinary Surgeon who reported the gelding to be showing signs of tying up in its shoulders.

RACE 4 : WILLIAM HILL IRISH STEEPLE - 3500 metres *(Run on Morphetville Parks Track)*

All runners were examined by the Club's Veterinary Surgeon who reported no visible abnormalities except for ZATAGLIO (NZ) which had minor abrasions to the near fore shoulder.

RACE 5 : QUAYCLEAN HANDICAP - 1518 metres

SOARING HIGH (S. Carr) jumped away awkwardly and was slow to begin.

BELUGA BLUE (C. Lindop) jumped away awkwardly and was then inconvenienced by KARLOVASI (P. Gatt), which shifted in and away from ALBERDINI (J. Holder), which shifted in at the start.

BELUGA BLUE (C. Lindop) and SOARING HIGH (S. Carr) commenced to over-race in the vicinity of the 1400 metres and then raced ungenerously for some distance until approaching the 800 metres.

SILENT ICE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CELESTIAL STORY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : RONDO HANDICAP - 1600 metres

EMMOOKI'S DASH (R. Hurdle) was awkward and slow to begin.

RUSSIAN ROCKER (GB) (J. Kah) jumped away awkwardly.

ON A DREAM (C. Lindop) rolled out in the vicinity of the 200 metres taking LADY HEDERAJ (J. Toeroek) out across the running of WALES (J. Bowditch), which was inconvenienced.

WALES was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

STREETCAR VALOUR lost its off hind plate during the event.

RACE 7 : CSR GYPROCK HANDICAP - 1100 metres

On arrival at the barriers MISS ADELE was re-saddled.

DAUNTING DANCER (E. Boyd) was tightened at the start between COACHELLA (NZ) (E. Finnegan) and LIBERTY HILL (R. Bell), which both shifted ground.

LIBERTY HILL (R. Bell) got its head up and raced ungenerous for a short distance when being restrained in the vicinity of the 900 metres.

A. Doyle, the rider of OUR LITTLE TREASURE, reported that in his opinion the mare was not suited to today's track conditions. OUR LITTLE TREASURE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Correct weight was delayed to allow J. Holder, the rider of and Mr J. Hyam, the Trainer of MISS ADELE, to view the vision in the straight.

SUNSET ROCK was examined by the Club's Veterinary Surgeon who reported the mare to be exhibiting signs of mild thumps.

RACE 8 : AKEED MOFEED AT GOLDIN FARMS HANDICAP - 1800 metres

Mr G. Carter, the Trainer of BRIMMING advised Stewards prior to the event that he would instruct his rider C. Jones to attempt to settle back with cover.

RACE 8 : AKEED MOFEED AT GOLDIN FARMS HANDICAP - 1800 metres (Cont'd)

REAL MESSI (J. Bowditch) over-raced in the early stages of the event.

In the vicinity of the 1000 metres BIG BOY BLEV (J. Holder) shifted in abruptly of its own accord contacted BRIMMING (C. Jones), which was taken in and as a consequence brushed the inside running rail.

REAL MESSI lost it's of hind plate during the event.
