RACE 1 : SPORTSBET CASH CARD / SABOIS FILLIES & MARES MAIDEN PLATE - 1100 metres

SCRUM (J. Kah) which was fractious in its barrier stall prior to the gates being released, jumped away very awkwardly, shifted out and contacted LAUVASSA (Z. Spain), which jumped away awkwardly and shifted in.

DANZA MOMENT (J. Holder) jumped away awkwardly.

DANZA MOMENT (J. Holder) was held up for clear running from inside the 500 metres until in the vicinity of the 200 metres.

Z. Spain, the rider of LAUVASSA, explained it was his intention to settle forward of mid-field but owing to the manner in which the filly began and after suffering some interference shortly after the start, he was obliged to settle back with cover. LAUVASSA was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the off hind leg. Trainer Mr M. Buckley was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

RACE 2 : BUILDING CONTRACTS / HARNETT ENGINEERING / SABOIS MAIDEN PLATE - 1200 metres

COOBINA (D. Tourneur) jumped away awkwardly.

In the vicinity of the 700 metres SACRED MONARCH (J. Holder) shifted in and brushed BRIMARVI CUGAT (P. Gatt), which was taken in. Shortly thereafter RUFUS (C. Lindop) shifted out to improve to the outside of WARRASIDE EDDY (K. Brooks) and as a consequence, SELDOM HOME (J. Kah) shifted out and away from RUFUS taking WALKABOUTCREEK (M. Neilson) wider on the track.

RACE 2 : BUILDING CONTRACTS / HARNETT ENGINEERING / SABOIS MAIDEN PLATE - 1200 metres (cont'd)

In the vicinity of the 1000 metres JUST A DREAM (E. Finnegan) raced ungenerously for a short distance when awkwardly placed inside the heels of RUFUS (C. Lindop) as that gelding commenced to race greenly and shifted about.

RUFUS (C. Lindop) raced greenly throughout the event.

SACRED MONARCH (J. Holder) laid out in the straight. SACRED MONARCH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

D. Tourneur, the rider of COOBINA, explained he had no specific instructions other than to allow the colt to settle where comfortable with cover. He stated that after beginning awkwardly and owing to the composition of the field in the early stages of the event, he was obliged to race wide without cover. He added when asked for an effort in the straight, the colt failed to respond to his riding in a manner he expected and was disappointing in its performance. COOBINA was examined by the Club's Veterinary Surgeon who reported a slow post-race recovery.

RACE 3 : HUMPTY DOO HOTEL / SABOIS THREE-YEARS-OLD BENCHMARCK 64 HANDICAP - 1200 metres

BEAUTIFUL FLYER (J. Kah) was awkward to begin.

HOLY JUAN (K. Bishop) was slow to begin.

In the vicinity of the 1100 metres ASK ME HOW I KNOW (E. Finnegan) shifted out and brushed with SCHISM (C. Jones), which reacted and shifted out and away from that horse onto SPIRITED MATCH (T. Pannell), which was taken out onto BEAUTIFUL FLYER (J. Kah), which in turn was taken out onto PARTING SHOT (P. Gatt), resulting in these three runners being severely hampered when taken wider. Shortly thereafter PLATINUM SET (J. Maund), which raced greenly, shifted in and as a consequence PLATINUM SET and ASK ME HOW I KNOW (E. Finnegan) contacted on several occasions, unbalancing both riders.

SCHISM (C. Jones) was held up for clear running from inside the 600 metres until shortly after the entrance to the straight.

Prior to the winning post CRUSIN' KATE (J. Toeroek) rolled out and inconvenienced BEAUTIFUL FLYER (J. Kah).

J. Toeroek, the rider of CRUISIN' KATE, was questioned regarding his use of the whip over the concluding stages. He pleaded guilty to a charge under AR137A(4)(b) in that he used his whip in an action that raised his arm above shoulder height over the concluding stages and was fined \$400.

PARTING SHOT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : GAWLER SOUTH BAKERY / SABOIS MAIDEN PLATE THREE-YEAR-OLD AND UP - 1700 metres

Mr J. Cornell, acting on behalf of Mr T. McEvoy the Trainer of PRINCE OF PAGODA (NZ), advised Stewards prior to the event, he would instruct M. Neilson to attempt to settle midfield with cover.

RACE 4 : GAWLER SOUTH BAKERY / SABOIS MAIDEN PLATE THREE-YEAR-OLD AND UP - 1700 metres (cont'd)

PRINCE OF PAGODA (NZ) (M. Neilson) and GRAN SABANA (J. Toeroek) raced keenly in the early stages of the event.

GOLDEN MOULA (C. Lindop) raced wide without cover in the early and middle stages of the event.

CLAREMONT KID (Z. Spain) made the turn inside the 1400 metres awkwardly. When questioned regarding this gelding's racing manners, Z. Spain explained CLAREMONT KID changed stride inside the 1400 metres, shifted about and contacted the inside running rail.

CATCH ME LATAR (C. Jones) was held up for clear running from near the entrance to the straight when racing behind STRYKING GOLD (P. Gatt) and GRAN SABANA (J. Toeroek) until approaching the 200 metres.

GOLD INITIO (J. Kah) became held up on the heels of CENTRE DIVIDER (T. Pannell) shortly after the entrance to the straight and was obliged to be restrained and shifted out to obtain clear running.

J. Toeroek, the rider of GRAN SABANA explained it was his intention to settle forward of midfield and he was comfortable with the position obtained in running, however, when STRYKING GOLD (P. Gatt) improved to his outside rounding the home turn, his mount was inclined to lay in and away from that horse and only finished the race off fairly and was disappointing in its performance. GRAN SABANA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5: WOLF BLASS RED BENCHMARK 64 HANDICAP - 1700 metres

SELANTE (P. Gatt) was slow to begin.

P. Gatt, the rider of SELANTE, explained the mare was slow to begin, appeared to resent the tongue-tie and as a consequence he was unable to obtain a position midfield as intended. He added the mare failed to finish the race off as expected and was disappointing. SELANTE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

C. Lindop, the rider of COOMA MISS, reported in her opinion, the mare may have jarred up during the event.

WICKED TYCOON was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6: COOPERS PALE ALE RATING 0-68 HANDICAP - 2100 metres

On arrival at the barriers MILKWOOD had to be resaddled.

WHERE'S THAT (E. Finnegan) jumped away awkwardly, shifted out and contacted CLAY PAVER (D. Caboche).

RACE 7: CRABB SHELLGRIT SPRINT - 1100 metres

The start of this event was delayed approximately two minutes owing to a number of horses proving difficult to load.

RACE 7: CRABB SHELLGRIT SPRINT - 1100 metres (cont'd)

PERIDUKI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Following a submission by Trainer K. Mooney, on behalf of the connections of AREGEE MCLAREN, for E. Finnegan, a claiming apprentice, to be granted permission to ride this gelding in view of S. Price, the original rider being indisposed, Stewards acceded to the request.

RACE 8 : SCHWEPPES GAWLER CUP - 1500 metres

The start of this event was delayed approximately seven minutes, initially owing to GOODFUN GIRL requiring the attention of the Farrier, when it was discovered the mare lost its near fore plate on arrival at the barriers. GOODFUN GIRL was examined by the Club's Veterinary Surgeon and passed fit to race. The race was further delayed in order to allow coverage on Sky Channel 1.

STARKIATO (M. Neilson) and GOODFUN GIRL (E. Finnegan) raced wide without cover in the middle stages of the event.

RACE 9: METRO PROPERTY DEVELOPMENT RATING 0-58 HANDICAP - 1200 metres

OUR PROSPECT (J. Kah) knuckled at the start.

MASTER BLACK (P. Gatt) laid in severely in the straight, shifted in despite the efforts of its rider and inconvenienced TIMES LIKE THESE (NZ)(M. Neilson) in the vicinity of the 150 metres. Shortly thereafter OUR PROSPECT (J. Kah) improved into a run between CALL ME PENNY (T. O'Donnell) and TIMES LIKE THESE (NZ) (M. Neilson), resulting in TIMES LIKE THESE (NZ) being crowded for room and having to be steadied. Thereafter MASTER BLACK continued to lay in and shifted significant ground over the concluding stages and in the vicinity of the 50 metres, shifted towards the running line of OUR PROSPECT (J. Kah), which was inconvenienced when shifting in and away from that horse and brushing with CALL ME PENNY. MASTER BLACK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr W. Francis and Mr G. Kent, the Co-Trainers of MASTER BLACK were advised a warning had been placed on the gelding in relation to its racing manners.
