RACE 1 : JAMESTOWN CONCRETE / JAMESTOWN CONTAINER DEPOT / JAMESTOWN COUNTRY RETREAT CARAVAN PARK / KELLY TOYOTA BENCHMARK 64 HANDICAP - 1000 metres

ARTHURIAN LEGEND (G. Willoughby) reared as the start was effected, losing considerable ground and as a result the gelding took no competitive part in the event.

MAGNUSIFICENT (D. Caboche) was inclined to lay out rounding the home turn.

Correct weight for this event was delayed to allow Stewards to view the official footage of the start. After taking submissions from Mr S. Whittle, the Trainer and G. Willoughby, the rider of ARTHURIAN LEGEND and Mr M. Patton the Official Starter, Stewards deemed the gelding had been afforded a fair start and was declared a runner. Following the event G. Willoughby was examined by the First Care Medical Personnel and stood down from her remaining engagements. Trainer, Mr S. Whittle was advised the gelding would be required to perform to the Stewards satisfaction in an Approval to Race Jump Out or an Official barrier Trial before being presented for a future race. ARTHURIAN LEGEND was examined by the Club's Veterinary Surgeon who reported the gelding to have abrasions to the forehead and blood present in the off side nostril which was attributable to external trauma.

RACE 2 : CALTOWIE METAL FABRICATIONS / COMPLETE CHIROPRATIC KERIN LANDMARK RURAL / WILSON HIRE / SABOIS MAIDEN PLATE - 1000 metres

MIDRADA (M. Poon) was slow to begin.

DESERT ELSIE (D. Tootell) was inclined to lay in under pressure in the straight.

R. Bell, the rider of SNOWDUST, explained the gelding had momentarily lost its action near the 700 metres, however, quickly recovered its stride and finished the event off well. SNOWDUST was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: SUZLON ENERGY AUSTRALIA / MURRAY PEST CONTROL JAMESTOWN QUALITY LIVESTOCK 0-62 HANDICAP - 1340 metres

CRYSTAL ICON (R. Bell) began awkwardly,

MINDSTORMS (D. Caboche) was inclined to lay in under pressure in the straight and approaching the 200 metres CRYSTAL ICON (R. Bell) became awkwardly placed on that gelding's heels. D. Caboche was advised to exercise far greater care when his mounts commence to shift ground in future.

RACE 4: JAMESTOWN HOTEL / BUNDALEER WINES / REDDEN BROTHERS / RYNNES HARDWARE / WEBB'S TYRE SERVICE SABOIS MAIDEN PLATE - 1340 metres

MAPPINGA KING was examined by the Club's Veterinary Surgeon on arrival on course and passed fit to start.

Following the event MAPPINGA KING was examined by the Club's Veterinary Surgeon who reported the gelding had injured its near fore flexor tendon. First Aid was administered. Mr J. Dunn, the Trainer of MAPPINGA KING advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

RACE 5 : RAILWAY HOTEL / CARLTON UNITED BREWERY JAMESTOWN CUP - 1800 metres

BLAKELEY was a late withdrawal by order of Stewards at 2.45 pm, as there was no available rider. Stewards ordered that all monies invested on BLAKELEY be refunded and that all successful wagers prior to 2.45 pm be subject to the deductions of 7 cents in the dollar for a win and 7 cents in the dollar for a place.

PHOENIX EAGLE (NZ) (D. Tootell) began awkwardly.

After passing the winning post on the first occasion BEWARE THESTORM (M. Poon) was inclined to lay out and shifted out marginally taking KINGDOM OF WAR (D. Caboche) wider on the track.

In the vicinity of the 150 metres BEWARE THESTORM (M. Poon) rolled in inconveniencing ASSABOY (R. Bell), which had commenced to weaken. M. Poon was advised to exercise far greater care when his mounts commence to shift ground in future.

RACE 6 : SWAN PHARMACIES / WEBB'S TYRE SERVICE / CLARE QUARRY / JAMESTOWN ENGINEERING AND MANUFACTURING BENCHMARK 54 HANDICAP- 1200 metres

ACT OF FAITH was a late withdrawal by order of Stewards at 12.20 pm, as there was no available rider.

SILVER LEE was a late withdrawal by order of Stewards at 1.55 pm, as there was no available rider.

SHYSTA (K. Brooks) shifted out on jumping away taking BEARDED DRAGON (M. Poon) out onto FRILLY SKURT (J. Frew), which was tightened onto TONI'S CONNECTION (L. Stojakovic). As a result FRILLY SKURT was unable to maintain its position.

RACE 6: SWAN PHARMACIES / WEBB'S TYRE SERVICE / CLARE QUARRY / JAMESTOWN ENGINEERING AND MANUFACTURING BENCHMARK 54 HANDICAP- 1200 metres (Cont'd)

ALERTNESS (R. Bell) knuckled on jumping away.

KING RODNEY (D. Caboche) was inclined to lay out over the concluding stages inconveniencing BEARDED DRAGON (M. Poon), which was awkwardly placed on that gelding's heels. D. Caboche was advised to exercise greater care when his mounts commence to shift ground in future.

FRILLY SKURT (J. Frew) was held up and unable to be tested when awkwardly placed inside the heels of BRAWNY HUNTER (D. Tootell) from the 200 metres to the 100 metres.
