Report on Race Meeting held at the Penola Racecourse by the Penola Racing Club on Sunday, 11 October 2015

RACE 1 : GABRIEL ELECTRICAL CONTRACTORS / SABOIS MAIDEN PLATE - 1700 metres

KUTTARA (J. Frew) raced keenly in the early stages of the event.

BLINGALING (K. Walters) raced wide without cover in the early and middle stages of the event and thereafter laid out over the concluding stages.

DARING DOLLY (R. Booth) was inclined to lay out in the straight.

RACE 2 : GAMBIER EARTH MOVERS / SABOIS MAIDEN PLATE - 1400 metres

ANY GIVEN GLASS (C. Puls) and PLAYTHESPOONS (R. Booth) both began awkwardly and were slow to begin.

Approaching the 1200 metres SWEET DESIGN (J. Maund) shifted in and inconvenienced GOLDEN FLYER (K. Walters) for a number of strides, resulting in K. Walters having to steady her mount to avoid the heels of SWEET DESIGN. As a consequence JUST A DREAM (C. Jokic), which was following had to be steadied. J. Maund, the rider of SWEET DESIGN was severely reprimanded and advised to take greater care in future when shifting ground.

RACE 3 : PINKERTON, PALM, HAMLYN & STEEN BENCHMARK 72 HANDICAP - 1300 metres

CONIDEL (E. Finnegan) knuckled at the start.

SHARBO (NZ) (C. Jokic) was slow into stride.

Following the running of this event Apprentice E. Finnegan was examined by the First Care Medical Personnel and passed fit to fulfil her remaining engagements.

RACE 4: CLASSICBET / SABOIS MAIDEN PLATE- 1100 metres

MADAM DE POMPADOUR, the second emergency, which gained a start, was declared a late scratching at 1.41 pm by order of Stewards when no rider was available to ride this mare.

RACE 4: CLASSICBET / SABOIS MAIDEN PLATE- 1100 metres (Cont'd)

ONE FOR MAX (J. Potter) was slow to begin losing two to three lengths at the start.

SCARBELLY BUTCH (J. Frew) raced ungenerously in the early stages of the event.

In the vicinity of the 300 metres ONE FOR MAX (J. Potter) shifted out to improve and momentarily inconvenienced SCARBELLY BUTCH (J. Frew).

RACE 5: KALANGADOO HOTEL PATRONS 0-58 HANDICAP - 1700 metres

FICKLE TIME (K. Bishop) was slow to begin losing two to three lengths.

MISS WAIROA (E. Finnegan) was very slow to begin losing six to seven lengths at the start. Mr J. Searle, the Trainer of the mare was advised a warning had been placed on MISS WAIROA in relation to it jumping on terms with the field.

CRYSTAL WAVE (C. Jokic) pulled hard in the early stages and as a result the saddle shifted forward on this gelding, resulting in C. Jokic removing both her feet from the stirrup irons near the 1200 metres and steering the gelding wider on the track away from the field. As a consequence the gelding took no competitive part in the event.

RACE 6 : COOPERS BREWERY KALANGADOO CUP RATING 0-62 HANDICAP - 1100 metres

On arrival at the barriers HARRY'S HOT, which sprung its near fore plate, required the attention of the Farrier, was examined by the Club's Veterinary Surgeon and passed fit to race.

In the vicinity of the 200 metres WRIGHT CHOICE (P. Marks) shifted out to improve and tightened PHOENIX ARIZONA (NZ) (A. Doyle) onto NORTH BEACH (J. Frew), resulting in PHOENIX ARIZONA (NZ) having to be steadied and alter course to the inside of WRIGHT CHOICE. P. Marks was reminded of his obligations when shifting ground.

A Doyle, the rider of PHOENIX ARIZONA (NZ), reported the gelding made a breathing noise during the event. PHOENIX ARIZONA (NZ) was examined by the Club's Veterinary Surgeon who reported the gelding had a poor recovery and elevated heart rate.

J. Frew, the rider of NORTH BEACH, explained the gelding travelled well in the early stages of the event, had every opportunity but failed to finish the race off in the manner expected and was disappointing. NORTH BEACH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: PRINCE OF WALES HOTEL RATING 0-58 HANDICAP - 1400 metres

Acting on confirmed advice from Trainer Ms T. Pretlove, that ANGUS CAROLUS was exhibiting signs of stiffness in both forelegs, Stewards ordered the late withdrawal of this gelding at 8.20 am.

IT'S FINE NOW (J. Potter) jumped away awkwardly.

In the vicinity of the 300 metres KING CLUB (P. Marks) became awkwardly placed on the heels of IT'S FINE NOW (J. Potter) and WARRASIDE (A. Doyle) for a number of strides when tightened between KING CLUB, which rolled out and FULFORD ROAD (C. Jokic), which rolled in. As a consequence KING CLUB shifted out when being steadied and contacted the hindquarters of FULFORD ROAD (C. Jokic).
