RACE 1: BRIAN HARVEY AGENCIES / SABOIS MAIDEN PLATE - 1210 metres

S. Price, the rider of FILLY OF STEEL, which was dislodged on the way to the barriers, was examined by the First Care Medical Personnel and passed fit to fulfil his remaining engagements. Trainer Mr T. Montgomerie was advised a warning had been placed on that mare owing to its pre-race manners.

DESERT ELSIE (D. Tootell) and THE BABY SITTER (L. Stojakovic) jumped away awkwardly.

SNOWDUST (K. Brooks) and THE BABY SITTER (L. Stojakovic) bumped on a number of occasions shortly after the start.

DUTTON BAY (J. Kah) raced keenly in the early and middle stages of the event.

RACE 2 : CROWIES PAONTS & VALSPAR AUSTRALIA / SABOIS THREE-YEAR-OLD BENCHMARK 60 HANDICAP - 1000 metres

GUMVALE MISS (E. Finnegan) was slow into stride and was uncompetitive throughout the event.

GRAND MARTINI (Z. Spain) raced keenly in the early and middle stages of the event.

GUMVALE MISS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Trainer Mr B. Clarke was advised that the filly must perform satisfactorily in an Official Barrier Trial before being presented for a future race.

RACE 3: ECO CLEAN BENCHMARK 64 HANDICAP - 1390 metres

RACE 4: LEADER DISTRIBUTORS RATING 0-58 HANDICAP - 1390 metres

Mr D. Carrison, the Trainer of BOSSA NOVA (NZ), was questioned regarding his failure to produce the Thoroughbred Identification Card for the gelding as required by the Rules. As Stewards were able to confirm the identity of BOSSA NOVA (NZ) from records held by them and its microchip, the gelding was permitted to start and Mr Carrison was fined \$50 under AR59A.

HERO TO VILLIAN (T. O'Donnell) jumped away awkwardly.

In the vicinity of the 1200 metres BOURBONDETTA (R. Bell) had to momentarily steady off the heels of VASOJEVKA (T. Pannell) when shifting wider to improve around that mare.

RACE 4: LEADER DISTRIBUTORS RATING 0-58 HANDICAP - 1390 metres (Cont'd)

From the vicinity of the 600 metres to the entrance of the home straight HERO TO VILLIAN (T. O'Donnell) was held up for clear running when racing on the heels of JUST PURE FUN (J. Potter), which was beginning to weaken and to the inside of LAMU LAD (E. Boyd).

HERO TO VILLIAN, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

JUST PURE FUN, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : JP CABINETS FOUR-YEARS-OLD & OVER RATING 0-58 HANDICAP - 1000 metres

SWINGIN' DAZZLER (T. Zanker), BAITON (R. Bell) and TALE BLAZER (L. Stojakovic) were all inconvenienced at the start when DE VILLAINE (Z. Spain) jumped away awkwardly and shifted in and PERFECT YANK (T. O'Donnell) jumped away awkwardly and shifted out.

In the vicinity of the 800 metres BAITON (R. Bell), which was racing keenly, had to momentarily steady when SNIP IN TIME (T. Pannell) shifted in momentarily under pressure.

From the vicinity of the 400 metres to the vicinity of the 300 metres TALE BLAZER (L. Stojakovic) was held up for clear running when racing on the heels of ALL KRUPT (J. Kah).

Approaching the winning post TALE BLAZER (L. Stojakovic) was momentarily inconvenienced when racing in restricted room on the heels of SNIP IN TIME (T. Pannell) and to the inside of ALL KRUPT (J. Kah).

PERFECT YANK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : PORT LINCOLN GOURMET MEATS BENCHMARK 64 HANDICAP - 1210 metres

SPIRIT OF FLATLEY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

DAZZLING LILLY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : JUDY HARROW PROPERTY CONSULTING BENCHMARK 80 HANDICAP - 1000 metres

FAVEROCK (M. Poon) was slow into stride.

In the vicinity of the 400 metres GET PRONTO (Z. Spain) had to momentarily steady and lost its positon when racing tight to the inside of BRAWNY HUNTER (D. Tootell) for a short distance.
