RACE 1 : TRADIES DAY WEDNESDAY 18 NOVEMBER / SABOIS DISTANCE MAIDEN PLATE –
2100 metres

HENRY THE DOLPHIN (T. Zanker) – a post-race veterinary examination revealed a laceration to the off fore coronet. First Aid administered.

MONS ABILA (R. Hurdle) – hung out rounding the home turn and under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

ROMULUS FLIGHT (T. Pannell) – laid in under pressure in the straight.

STEALTH MODE (D. Caboche) – over-raced in early and middle stages of the event and raced wide without cover throughout.

GOLD INITIO (M. Neilson) – jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

BELLA GIULIETTA (J. Holder) – a post-race veterinary examination revealed no visible abnormalities.

RACE 2 : JOHN DEERE TRACTORS / SABOIS MAIDEN PLATE - 1100 metres

The start of this race was delayed approximately two minutes.

IMPORTANT (J. Bowditch) – contacted a perimeter fence in the mounting enclosure. A pre-race veterinary examination ruled the gelding fit to race. Raced keenly in early and middle stages of the event.

A LOTTA ROSIE (P. Denton) – slow to begin.

BITTER TWIST (P. Gatt) – slow to begin.

NADALIA (J. Toeroek) – contacted on jumping away and taken in. Rider reported the mare was inclined to hang in throughout the event and felt awkward in its action. A post-race veterinary examination revealed no visible abnormalities.

DENY DENY DENY (T. O'Donnell) – jumped away awkwardly.

RACE 2 : JOHN DEERE TRACTORS / SABOIS MAIDEN PLATE - 1100 metres (Cont'd)

STRICTLY MAMBO (A. Doyle) – jumped away awkwardly shifted in.

Following this race, Apprentice R. Hurdle was examined by the First Care Medical personnel who ruled him unfit to fulfil his remaining engagements.

RACE 3 : OAKS LADIES DAY FASHION ON THE FIELD / SABOIS F&M MAIDEN PLATE – 1200 metres

CHICA CALIENTE (D. Tourneur) – awkwardly placed on the heels of MOLTO VIVACE in the vicinity of the 600 metres and had difficulty obtaining clear ground at the entrance to the straight.

GOORAM MISS (Z. Spain) – shifted in inside the 1000m onto KASMARLAINE, which was hampered. Apprentice Z. Spain issued with a reprimand.

KASMARLAINE (S. Cahill) – hampered inside the 1000m.

COMPLETE CLASS (C. Lindop) – reared on jumping away and as a result was slow to begin. Raced keenly in the middle stages of the event.

SAVANETA – Acting on confirmed advice from Trainer, Miss E. Hubbard, that the filly had sustained a laceration to its near foreleg and was unfit to race, Stewards withdrew SAVANETA at 8.02 am.

RANSOM VALUE (T. Zanker) – slow into stride.

RAINBOW REFLECTION (W. Kerford) – bucked shortly after the start losing ground and saddle shifted placing W. Kerford at a disadvantage for the remainder of the event. Improved onto heels in the vicinity of the 1000m and raced keenly until the 600m when being restrained. Trainer Mr. J. O'Loughlin advised the mare now required to perform to Stewards' satisfaction in an Official Barrier Trial. A post-race veterinary examination revealed a laceration to the near side corner of the mouth.

RACE 4 : SPORTSBET RATING 0-58 HANDICAP - 1100 metres

BEGOR I'M SURE (E. Boyd) – hampered on jumping away when tightened between SPARTAN WARRIOR and SOUVLAKI. In the vicinity of the 200m had to be steadied. Apprentice E. Boyd reported the gelding may not have handled today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

SPARTAN WARRIOR (M. Neilson) – jumped away awkwardly. Lost off fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

SOUVLAKI (S. Price) – jumped away awkwardly.

PHOENIX ARIZONA (NZ) (A. Doyle) – jumped away awkwardly. Held up from the entrance to the straight until inside the 200m.

DE STARSANDCIRCLES (P. Gatt) – slow to begin. At the entrance to the straight had difficulty obtaining clear ground and shifted out in the vicinity of the 300m. In the vicinity of the 200m shifted out to improve onto BEGOR I'M SURE, which had to be steadied. Rider P. Gatt was issued with a reprimand.

RACE 5 : GOLDIN FARMS 0-62 HANDICAP - 2100 metres

RICCONE (M. Neilson) – a post-race veterinary examination revealed no visible abnormalities.

ARTEMISIA (D. Tourneur) – inclined to rear on jumping away and as a result was slow to begin. Raced wide without cover in the middle stages and inclined to hang out throughout the event. A post-race veterinary examination revealed no visible abnormalities. Rider D. Tourneur questioned into his conduct following this event prior to entering the mounting yard whilst dismounted from the mare. He pleaded guilty to a charge under AR83(a) in that he misconducted himself by striking the mare in the girth area with his knee and was fined \$500.

RACE 5 : GOLDIN FARMS 0-62 HANDICAP - 2100 metres (Cont'd)

MIGHTY MAHER (C. Lindop) – over-raced in the early and middle stages of the event.

SIR DYLAN (J. Holder) – hung out rounding the home turn.

FATE (D. Caboche) – a post-race veterinary examination revealed no visible abnormalities.

PERFECT BITE (NZ) (K. Bishop) – approaching the 400m had to be steadied off the heels of LAND OF THE FREE, which was weakening, and obliged to alter course.

PIERREMONT ROCKS (J. Potter) – rolled out at the entrance to the straight at the same time as MIGHTY MAHER rolled in and was inconvenienced.

RACE 6 : SCHWEPPE CLASS ONE HANDICAP - 1200 metres

FINAL ARROW (C. Jones) – a post-race veterinary examination revealed no visible abnormalities.

IMAHOFFA (K. Bishop) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

RACE 7 : COOPERS CLEAR / YELLOWGLEN CHAMPAGNE RATING 0-62 HANDICAP – 1500 metres

ZIPALANG (C. Jones) – clipped the heels of MR PORTER in the vicinity of the 800m.

CYCLONE THOMAS (P. Gatt) – shifted in under riding in the straight. Approaching the finish bumped GOLDEN BUCKLEBOO, which rolled out.

FULL SWING (S. Cahill) – inconvenienced in the vicinity of the 500m when SCARLET LETTER was weakening. Shortly after shifted in and bumped ROBOCOP. Rider S. Cahill was questioned regarding his riding of the gelding in the straight. After considering his explanation, he was advised to ride in a manner that does not invite question in future. A post-race veterinary examination revealed no visible abnormalities.

ROBOCOP (J. Potter) – had to be steadied at the entrance to the straight.

GOLDEN BUCKLEBOO (J. Toeroek) – rider reprimanded under AR137(d) for slowing the pace approaching the 800m. Rolled out under pressure approaching the finish and bumped CYCLONE THOMAS.

INDIGO SUN (E. Boyd) – slow to begin.

MR PORTER (J. Holder) – taken out in the vicinity of the 800m by SUPER SILKS (NZ). A post-race veterinary examination revealed minor abrasions to the off hind leg.

SUPER SILKS (NZ) (K. Brooks) – inclined to race keenly in the early and middle stages. Shifted out in the vicinity of the 800m, when insufficiently clear, onto MR PORTER, which was taken out into the running line of ZIPALANG, which clipped the heels of that gelding when tightened onto THE FASTNET. Apprentice K. Brooks pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Wednesday, 11 November and to conclude at midnight on Wednesday, 18 November 2015; a period of three (3) meetings.

PARTING SHOT (A. Doyle) – had to be steadied to avoid the heels of GOLDEN BUCKLEBOO when the pace eased approaching the 800m.

SCARLET LETTER (D. Tootell) – weakened from in the vicinity of the 500m.

Correct Weight delayed to allow P. Gatt (CYCLONE THOMAS), placed second, to view the official footage in the straight. After doing so, P. Gatt lodged an objection against GOLDEN BUCKLEBOO (J. Toeroek) being declared the winner on the grounds of alleged interference in the straight. Objection *dismissed*.

REGAL SPUR - Trainer Mr. R. Balfour reported on return to his stable the gelding had bruising to the near fore heel.
