**RACE 1 : GRAHAM BACCHUS / SABOIS MAIDEN PLATE - 1390 metres**

**IN HIS DREAMS** (T. Zanker) – reared as the start was effected and was slow to begin. Warning issued. A post-race veterinary examination revealed the gelding to have superficial abrasions to its head.

**OUTLAW** (A. Doyle) – raced wide without cover throughout.

**ECHINACEA** (D. Tootell) - A pre-race veterinary examination of the mare (had not raced for over 12 months) – ruled fit to race.

**RACE 2 : NT & DA DICKSON / WEST COAST BITUMEN / SABOIS MAIDENPLATE**  
**- 1000 metres**

The start of this event was delayed approximately six minutes owing to R. Hurdle, the rider of MAGICAL MUSICIAN proceeding to the barriers without his safety vest.

**DOWN'S AFTER DARK** (L. Stojakovic) – hung out when placed under pressure over the concluding stages.

**I'M OUT** (S. Price) - a post-race veterinary examination revealed no visible abnormalities.

**MAGICAL MUSICIAN** (R. Hurdle) – Rider questioned as to why he rode the gelding to the barriers without wearing an approved safety vest, which resulted in the start of the race being significantly delayed due to R. Hurdle having to be re-weighed. R Hurdle pleaded guilty to a charge under AR175(k) in that his actions in not wearing a safety vest was negligent and could have led to a more significant breach of the rules and was fined \$500. Hung in when placed under pressure in the straight.

**PATRIOT CODE** (T. Pannell) – hampered at the start.

**SPINNING CROWN** (G. Willoughby) – underwent a pre-race veterinary examination after being fractious in the gates and was passed fit to race. Slow to begin. Rounding the home turn and in the entrance to the straight hung out.

**RACE 2 : NT & DA DICKSON / WEST COAST BITUMEN / SABOIS MAIDENPLATE**  
**- 1000 metres (Cont'd)**

**WHITE JADE** (K. Bishop) – A post-race veterinary examination revealed the gelding to be suffering from mild myositis.

**SUPER HULA** (S. Carr) – shifted out on jumping, contacting SHAZZAMATTAZ

**BAZILLION** (T. O' Donnell) – begun awkwardly and shifted in, contacting PATRIOT CODE.

**SHAZZAMATTAZ** (T. Zanker) - hampered shortly after the start.

After the running of the event T. Zanker was stood down from her remaining engagements.

**RACE 3 : DEL GIORNOS CAFÉ RESTAURANT BENCHMARK 58 HANDICAP - 1390 metres**

**VALIK** (E. Boyd) – was slow to begin.

**HARD AT IT** (S. Cahill) – hung in when placed under pressure over the concluding stages.

**TRESETTE** (T. Pannell) – hampered at the start.

**CRAYZED** (Z. Spain) – began awkwardly and shifted in, contacting TRESETTE. Raced wide throughout. Hung out rounding the home turn.

**STRAWPEDO** (D. Tootell) – over-raced in the vicinity of the 800 metres.

**RACE 4 : ROSSAIR CHARTERS BENCHMARK 58 HANDICAP - 1390 metres**

**SWINGIN' DAZZLER** (L. Stokjakovic) - a post-race veterinary examination revealed no visible abnormalities.

**HERO TO VILLIAN** (J. Potter) – when passing the 700 metres shied at the running rail and bound in the air.

**ALERT THE WORLD** (D. Tootell) – reared as the start was effected and was slow to begin.

**KOODA DAWN** (Z. Spain) – over-raced in the early and middle stages.

**RACE 5 : NEXT PAYMENTS ATM / GRAND TASMAN HOTEL BENCHMARK 54 HANDICAP**  
**- 1210 metres**

**MILOS** (T. Pannell) - A post-race veterinary examination revealed no visible abnormalities.

**JESTWIN** (Z. Spain) – was hampered passing the 1100 metres.

**NOBLE ROMP** (G. Willoughby) – as Stewards were able to identify the gelding from records held by them when the Thoroughbred Identification Card was not available for inspection, they permitted it to start. Trainer Mr C. Cox was fined \$50 under AR59A. Hung in throughout the early and middle stages of the event.

**MYORA** (J. Kah) – passing the 900 metres had to be restrained to avoid the heels of LEWIS STREET (D. Tootell) and BELUGA GOLD (S. Carr). Riders D. Tootell and S. Carr were both severely reprimanded for shifting ground when insufficiently clear. A post-race veterinary examination revealed a poor recovery.

**RACE 6 : MOGAS MORTLOCK SERVICE STATION / BENCHMARK 54 HANDICAP**  
**- 1210 metres**

**ALL KRUPT** (Z. Spain) – began awkwardly, shifted in and contacted WOTZINTHEBAG.

**POINT DRUMMOND** (S. Cahill) – was momentarily held up for clear running at the entrance to the straight.

**RACE 6 : MOGAS MORTLOCK SERVICE STATION / BENCHMARK 54 HANDICAP**  
**- 1210 metres (Cont'd)**

**WOTZINTHEBAG** (R. Hurdle) – hampered at the start.

**RICH PRIDE** (S. Price) – began awkwardly.

**LONCAY** (E. Boyd) – raced wide without cover throughout.

**RACE 7 : LINCOLN ESTATE WINES BENCHMARK 72 HANDICAP - 1750 metres**

**LITTLE AUDREY** (E. Boyd) – over-raced in the early stages of the event.

**PHOENIX EAGLE (NZ)** (Z. Spain) - as Stewards were able to identify the gelding from records held by them when the Thoroughbred Identification Card was not available for inspection, they permitted it to start. Trainer Mr S. Drewitt was fined \$50 under AR59A.

**SACHIN** (K. Bishop) – over-raced in the early stages and passing the 1400 metres ran wide on the track.

**RACE 8 : EUROPCAR PORT LINCOLN / ROSSAIR CHARTERS BENCHMARK 80 HANDICAP - 1390 metres**

**REVENGEFUL** (T. O' Donnell) – hampered at the start.

**AKBAR MAHAL** (Z. Spain) – began awkwardly, shifted in and contacted REVENGEFUL. over-raced in the early and middle stages of the event.

**RACE 9 : PORT LINCOLN GOURMET MEATS BENCHMARK 64 HANDICAP - 1000 metres**

The start of this event was delayed approximately two minutes owing to SOUND OF VICTORY proving difficult to load. Trainer Mr R. Wilkins was advised that the gelding would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

**TINTAGEL ROCKER** (R. Hurdle) – over-raced in the middle stages of the event.

**SOUND OF VICTORY** (S. Carr) – began awkwardly and shifted in contacting NORTHSIDE STAR. lost its near fore plate during the event.

**NORTHSIDE STAR** (A. Doyle) – hampered at the start.

**HURRICANE ANDY** (E. Boyd) – was hampered passing the 70 metres.

**MY BOY BRANDO** (Z. Spain) – stood flat-footed on jumping away,

**RACE 10 : DELACOLLINE ESATE WINES BENCHMARK 80 HANDICAP - 1210 metres**

**HANK'S NEPHEW** (R. Hurdle) – was held up for clear running rounding the home turn.

**THE HEADLINER** (S. Carr) – knuckled on jumping away.

**ARTHURIAN LEGEND** (J. Kah) – slow to begin.

**SPIRIT OF FLATLEY** (D. Tootell) – held up for clear running in the straight and was unable to be fully tested over the concluding stages.

**RACE 11 : BOSTON BAY WINES BENCHMARK 64 HANDICAP - 1210 metres**

**CELEBRITY TYCOON** (E. Boyd) – A pre-race veterinary examination ruled the gelding (not raced for over 12 months) – ruled fit to race.

**GEORDIE’S SECOND** (J Potter) – slow to begin. Hung in under pressure inside the 200 metres and tightened HEZAFRAAR in onto SUPERBAD. J Potter was issued with a severe reprimand.

**SUPERBAD** (R Hurdle) – Raced in restricted room passing the 200m and had to be severely checked when crowded, clipping heels and blundered badly which resulted in its rider being dislodged. A post-race veterinary examination revealed the gelding to be lame in the near fore leg. Veterinary Certificate of Fitness required prior to trial or race.

**KOODA DUCHESS** (K BISHOP) – Attempted to buck shortly after the start. Trainer J Dunn was advised that the mare would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race. A post-race vet examination of KOODA DUCHESS revealed no significant abnormalities.

**TRINKET LADY** (J Kah) - Shifted out in the vicinity of the 200m, when insufficiently clear of SUPERBAD which clipped the heels of that mare resulting in the rider of SUPERBAD being dislodged. J. Kah pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Sunday, 15 November and to conclude at midnight on Friday, 27 November 2015; a period of six (6) meetings.

Hurdle – Fined \$200 – AR120(b) – Overweight and having to be replaced on NANNA KNOWS BEST. Race 5 – Mr C. Cox – Fined \$50 – AR59A – Failing to produce TIC for NOBLE ROMP. Race 7 – Mr S. Drewitt – Fined \$50 - AR59A – Failing to produce TIC for PHOENIX EAGLE (NZ).

Race 11 - KOODA DUCHESS - Suspended – Required to perform to the satisfaction of the Stewards in an Official barrier Trial prior to accepting for a race – Bucked at the start. Race 11 – SUPERBAD – Not to race – Vet Cert of Fitness required prior to accepting for a future trial or race – lame near foreleg.
