THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 21 November 2015

TRACK: Good 4 (Upgraded to Good 3 @ 1.00 pm, retrospective to Race 1) WEATHER: Fine

RAIL: Out 6 metres 1000m to Winning Post, 3 metres remainder.

RACE 1: WILLIAM HILL MAIDEN PLATE - 1000 metres

LOCKDOWN JACK (P. Gatt) – raced keenly in the early and middle stages of the event. Made the turn in the vicinity of the 700m awkwardly and shifted wider on the track.

REGAL SPUR (T. Pannell) – jumped away awkwardly.

MR ROADSTAR (J. Holder) - a post-race veterinary examination revealed a puncture wound on the medial aspect of the off hock. First Aid was administered.

CHINA TOWN (Z. Spain) – jumped away awkwardly and was slow to begin.

RACE 2: ADELAIDE GALVANISING HANDICAP - 1250 metres

HAZY LANE (J. Toeroek) - rolled out inside the 1000m and contacted ENCHANTING BEAUTY.

ENCHANTING BEAUTY (C. Lindop) – raced wide without cover throughout the event. Inside the 1000m inconvenienced when contacted by HAZY LANE, which rolled out. Rider reported the filly had not travelled throughout the event. A post-race veterinary examination revealed the filly to be lame in the near foreleg. Veterinary Certificate of Fitness required.

KESAN (P. Gatt) – reared on jumping away. Rider reported the gelding had only travelled for approximately 400m and then was off the bit and failed to respond to his riding. He added, in his opinion KESAN may have choked down. A post-race veterinary examination revealed a poor recovery.

VALIDATE (M. Neilson) – rider reported the filly put in an awkward stride in the straight and felt sore on pulling up. He added, on further examination, the filly had turned its near fore plate and for that reason he dismounted prior to returning to the mounting enclosure. A post-race veterinary examination confirmed the filly had turned its near fore plate.

CRUSIN' KATE (J. Holder) – a post-race veterinary examination revealed the filly had tied up, particularly in the off hind.

RACE 3: THE WELLINGTON FAMILY HANDICAP - 1250 metres

HOOK ME UP (C. Jokic) – raced wide without cover throughout the event. Had to be steadied in the vicinity of the 50m when tightened between REDENTES EDGE (Z. Spain), which rolled in at the same time as SCRATCHY LASS (J. Holder) shifted out after being accidentally contacted by the whip of J. Cartwright (ILGATTINO).

RACE 3: THE WELLINGTON FAMILY HANDICAP - 1250 metres (Cont'd)

ILGATTINO (J. Cartwright) – shifted in and contacted the running rail for a short distance in the vicinity of the 700 metres.

SCRATCHY LASS (J. Holder) – held up from in the vicinity of the 400m until approaching the 200m. Accidentally struck over the head by the whip of J. Cartwright (ILGATTINO) in the vicinity of the 50m.

OUR PARADIGM (T. Pannell) – lost its position shortly after the start when tightened between MARCO POLO and REDENTES EDGE, which both shifted ground slightly. A post-race veterinary examination revealed no visible abnormalities.

ASTRO DAMUS (D. Tourneur) – held up from the entrance to the straight until near the 300 metres where it was obliged to alter course to the inside of SCRATCHY LASS to obtain clear ground. Lost off hind plate during event.

PEPPER THE PIN (C. Lindop) – a post-race veterinary examination revealed no visible abnormalities.

RACE 4: HAIGH'S CHOCOLATE HANDICAP - 1950 metres

CELTIC PRINCE (NZ) (J. Cartwright) - contacted on jumping away by BEAU'S MY BOY.

OKAHU BAY (E. Finnegan) – a post-race veterinary examination revealed no visible abnormalities.

YOU ROCK (D. Caboche) – rider reported the gelding travelled well in the early and middle stages of the event, however, in the vicinity of the 700m, dropped the bit and was reluctant to improve into the race despite his efforts. A post-race veterinary examination revealed a lower than expected heart rate.

MARTIAN (IRE) (M. Neilson) – lost its near fore plate during the event.

BEAU'S MY BOY (J. Holder) – laid in under pressure in the straight and in the vicinity of the 50m had to be momentarily steadied when NOT A ZERPRISE (C. Lindop) rolled out slightly under pressure. A post-race veterinary examination revealed no visible abnormalities.

SANDHILL STAR (J. Potter) – improved onto heels in the vicinity of the 1200 metres and raced keenly for a short distance.

EXALTED JOURNEY (P. Gatt) – Trainer Mr. S. Schrader, advised Stewards he would instruct his jockey to attempt to settle on pace with cover if possible.

RACE 5: ALF GARD MEMORIAL HANDICAP - 1000 metres

WHITLAM (E. Finnegan) – tightened inside the 100m.

MOSS'N TIME (P. Denton) – had to be steadied inside the 100m when tightened onto WHITLAM by I AM GYPSY, which shifted out under pressure.

JENNYFROMTHEBLOCK (Z. Spain) - raced wide without cover throughout the event.

I AM GYPSY (D. Tourneur) – reared on jumping away and shifted out onto SILENT WHISPER. Shifted out under pressure in the straight onto MOSS'N TIME. A post-race veterinary examination revealed no visible abnormalities.

SILENT WHISPER (T. Pannell) – inconvenienced on jumping away. Raced wide without cover throughout the event. Rolled in inside the 100 metres onto WHITLAM.

RACE 6: PETER ELBERG FUNERALS HANDICAP - 1550 metres

DIRE WARNING (E. Boyd) – rider forced to take hold on jumping away. Raced keenly in the early and middle stages of the event.

IZENASHARK (J. Toeroek) – taken out over the concluding 200m.

RACE 6: PETER ELBERG FUNERALS HANDICAP - 1550 metres (Cont'd)

FREE THE WIND (D. Caboche) – shifted in on jumping away onto DOOMSDAY PREPPER, which lost its position when tightened onto DIRE WARNING, which was forced to be steadied.

SAGAPUSS (D. Tourneur) – rider explained the mare travelled well in the early and middle stages, however, when placed under pressure at the entrance to the straight, became awkward in its action and for that reason he did not ride SAGAPUSS out in his normal manner over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

AMICONI ORIGINALE (M. Neilson) – laid in under pressure in the straight. Rider reported he had become concerned with the gelding's action over the concluding stages and on pulling up. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Veterinary Certificate required.

VICTORY DOWNS (J. Holder) – hung out under pressure over the concluding 200m taking IZENASHARK wider on the track. A post-race veterinary examination revealed no visible abnormalities.

DOOMSDAY PREPPER (E. Finnegan) – lost position on jumping away.

RACE 7: CHRISTMAS IN VEGAS @ MORPHETTVILLE HANDICAP - 1400 metres

CHESTNUT CHARLIE (S. Carr) – jumped away awkwardly. Over-raced in the early and middle stages of the event.

TILDY LAD (J. Maund) – laid out in the early and middle stages of the event. Rider reported he had become concerned with the gelding's action over the concluding 600m. A post-race veterinary examination revealed no visible abnormalities.

EMCEECEE (J. Potter) – slow to begin.

RACE 8 : SCHWEPPES HANDICAP - 1000 metres

JONJONNY (J. Potter) – a pre-race veterinary examination revealed a minor abrasion to the off hind cannon - ruled fit to start. Dipped shortly after jumping away and lost ground. A post-race veterinary examination revealed excess upper respiratory noise. Results of laryngoscopic examination and Veterinary Certificate of Fitness required.

ROUSSANE (M. Neilson) – rider reported he became concerned with the mare's action over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

HEIRDOM (D. Tourneur) – a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Veterinary Certificate of Fitness required.

NUTHERBOTTLEGONSKI (J. Toeroek) - hampered when tightened inside the 800m.

BOLDACIOUS GIRL (J. Cartwright) – raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

WRITE NO MORE (S. Price) – Trainer fined \$50 AR59A for failing to produce the Thoroughbred Identification Card. Shifted out inside the 800m tightening NUTHERBOTTLEGONSKI onto HEIRDOM.

KICKSTARTER (C. Lindop) – a post-race veterinary examination revealed no visible abnormalities.
