<u>Report on Race Meeting held at Morphettville Racecourse</u> by the South Australian Jockey Club on Saturday, 28 November 2015

RACE 1 : DALZIEL RACING TWO-YEAR-OLD PLATE - 1050 metres

The start of this event was delayed approximately seven minutes owing to Jake Toeroek, the rider of MORVADA, being kicked by the colt when attempting to mount up. J. Toeroek was examined by the First Care Medical personnel and ruled unfit to fulfil this engagement.

BLUE TYCOON (M. Neilson) – rider dislodged on arrival at the barriers. M. Neilson was examined by the First Care Medical personnel and ruled fit to fulfil his engagements.

GERONIMO'S SON (J. Potter) – a pre-race veterinary examination ruled the gelding fit to race.

INSTANT ACTION (J. Holder) – a post-race veterinary examination revealed no visible abnormalities.

MORVADA (C. Lindop) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

CROSS WITNESS (J. Kah) – jumped away awkwardly and slow to begin. Trainer Mr. W. Francis reported on Monday, 30 November 2015, on return to stable the filly was found to be sore in the near foreleg.

SPORTAGE (Z. Spain) – hung out from the vicinity of the 600m to the 400m.

Following the running of this race, J. Toeroek was re-examined by the First Care Medical personnel and ruled unfit to fulfil his remaining engagements.

RACE 2 : TONKIN CONSULTING HANDICAP - 1100 metres

THIS KID ROCKS (C. Lindop) – awkwardly placed on the heels of HEARTZ ABLAZE from inside the 600m until approaching the 400m.

RACE 2 : TONKIN CONSULTING HANDICAP - 1100 metres (Cont'd)

COBBER (T. Pannell) – slow to begin. Shortly after the start inconvenienced between HEARTZ ABLAZE and EVIL DREAMS, which both shifted ground slightly. Raced greenly in the straight.

HEARTZ ABLAZE (J. Holder) – a post-race veterinary examination revealed the filly had quartered its near fore medial heel bulb. First Aid was administered.

RACE 3 : PLUMBING & PIPELINE SOLUTIONS HANDICAP- 1530 metres

The start of this event was delayed approximately one minute owing to the tongue tie on COMPRENDE having to be replaced on arrival at the barriers.

HUSHEEN (J. Kah) – performed below expectations. Trainer, Mr. D. Clarken, advised the filly will now be spelled.

JEST FOR THE ROAD (J. Holder) – shifted out on jumping away onto RUBY FOR HENRY, which was taken out onto LIFE'S ZERPRISE, which was inconvenienced.

RACE 4 : ROADSIDE SERVICES & SOLUTIONS HANDICAP - 2500 metres

CELTIC PRINCE (NZ) (D. Caboche) – lost near hind plate during the event.

DISTILLATION (J. Kah) – Trainer Mr. N. Smart advised he would instruct his rider to attempt to settle back.

NOMIS (NZ) (Z. Spain) – rider explained the gelding travelled well until in the vicinity of the 800m, and was then off the bridle before running on strongly over the concluding stages.

RACE 5 : ACTION LINEMARKING HANDICAP - 1200 metres

READY SUNSHINE (T. Pannell) – raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

SEGREGATION (D. Tourneur) – a post-race veterinary examination revealed a poor respiratory and cardiac recovery.

RACE 6 : PRIME TRAFFIC SOLUTIONS HANDICAP - 1100 metres

PERFECT PAUSE (S. Cahill) – acting on confirmed advice from Trainer Ms. L. Lefoe that the mare had swelling and was lame in the near hind leg, PERFECT PAUSE was withdrawn by Stewards at 8.13 am.

MOLLY THE SNIP (J. Holder) – raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

BELLE MELBA (J. Kah) – had tongue tie replaced on arrival at the barriers.

MISS WORLD (T. Pannell) – a pre-race veterinary examination ruled the mare fit to race. Lost both fore plates during the event. A post-race veterinary examination revealed the mare to be lame in both forelegs. First Aid administered. Veterinary Certificate of Fitness required.

BOLDACIOUS GIRL (S. Carr) – had to be re-saddled on arrival at the barriers.

RACE 7 : DAIMLER TRUCKS ADELAIDE HANDICAP - 1600 metres

EASY DRAMA (D. Caboche) – jumped away awkwardly.

ROD'S OPINION (J. Holder) – jumped away awkwardly and slow to begin. Rider reported the gelding raced flat and felt sore in the near foreleg during the event and as a consequence he did not persist with his riding over the concluding stages. A post-race veterinary examination revealed a lower than expected heart rate.

RACE 7 : DAIMLER TRUCKS ADELAIDE HANDICAP - 1600 metres (Cont'd)

BOYS GETAROUND HIM (S. Cahill) – held up for clear running for a short distance approaching the 400m. Inconvenienced in vicinity of the 200m.

SAVANERO (NZ) (D. Tourneur) – inconvenienced in vicinity of the 200m.

SUPERHEIST (S. Carr) – slow to begin. Rider reported there may have been something amiss with the gelding during the event. A post-race veterinary examination revealed no visible abnormalities.

FORTRUS DANCER (C. Lindop) – rolled in approaching the 200m and brushed with BOYS GETAROUND HIM, which had its hindquarters turned and rolled out, taking FORTRUS DANCER out onto SAVANERO (NZ), resulting in FORTRUS DANCER being buffeted between SAVANERO (NZ) and BOYS GETAROUND HIM inside the 200m and all three horses being inconvenienced for a number of strides.

RACE 8 : DELNORTH HANDICAP - 1200 metres

PURRFECT PARAGON (C. Jones) – in the vicinity of the 600m commenced to race very keenly and had to be checked to avoid the heels of BALZAC, when taken out by SOLID BULLET, and lost its position. Rider reported the gelding commenced to hang out approaching the 600m placing her at a disadvantage as she was unable to fully steer her mount. She added, after losing her position and having regard for the gelding's racing manners, she did not persist with her riding in the straight. A post-race veterinary examination revealed no visible abnormalities.

BALZAC (S. Cahill) – knuckled on jumping away. Rider reported, as a consequence of the manner in which the gelding began, he was unable to take up a position forward of mid-field as intended. He added thereafter the gelding did not finish the race off as expected. Trainer Mr. T. Snelling reported on Monday, 30 November 2015, on return to stable the gelding was found to have a quartered off fore heel.

SAMZERO (A. Doyle) – rider reported the mare began better than expected and as a consequence he shared the lead in the early stages, which was not his intention.

SAGABELLA (J. Potter) – got its head up and raced keenly for a short distance in the vicinity of the 800m and was unable to obtain cover.

MOLASMO JET (J. Maund) – slipped over in race day stall on arrival on course. A pre-race veterinary examination ruled the gelding fit to race. On arrival at the barriers rider reported he was concerned with its action. A further veterinary examination revealed the gelding to be lame in the off foreleg and off hind leg. Acting on this advice, Stewards withdrew MOLASMO JET at 5.38 pm. Veterinary Certificate of Fitness required.

SOLID BULLET (D. Tourneur) – jumped away awkwardly and slow to begin. In the vicinity of the 600m became very awkward on the heels of COOL MAVERICK and shifted out abruptly taking PURRFECT PARAGON out onto the heels of BALZAC.

IN TAIPEI (T. Pannell) – had difficulty obtaining clear running in the vicinity of the 200m when racing between SAGABELLA and URBAN BOURBON, which rolled in.
