RACE 1 : TAYLOR'S WINES / SABOIS DISTANCE MAIDEN PLATE - 1800 metres

GANGSTER'S RUN (E. Finnegan) – inconvenienced on jumping away when taken wider.

SOCIAL SET (C. Jones) – in the vicinity of the 400 metres to the vicinity of the 150 metres was held up for clear running.

THE BRIGHTONIAN (A. Doyle) – hung out and raced greenly throughout the event. A post-race veterinary examination revealed a significant split in the corner of the right side of the mouth.

UNLEASH ONE MORE (J. Potter) - jumped away awkwardly.

CHAMPAGNE KRIS (J. Maund) – in the vicinity of the 1700 metres was momentarily inconvenienced when tightened between runners.

ZIP HOP (Z. Spain) - in the vicinity of the 1700 metres was momentarily inconvenienced when tightened between runners.

RACE 2 : UBET / SABOIS FILLIES AND MARES MAIDEN PLATE - 1100 metres

CRYSTAL MOMENT (O. Ridge) – jumped away awkwardly.

ELVESINTHSTREAM (D. Caboche) – tailed the field throughout the event. Uncompetitive. A post-race veterinary examination revealed no visible abnormalities. Warning issued.

KASMARLAINE (S. Cahill) - jumped away awkwardly.

MISS WEREWOLF (E. Finnegan) – stood flat-footed, refused to jump and took no part in the event. Trainer advised the mare would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

MOSTA CHARM (K. Bishop) - a post-race veterinary examination revealed acute heat stress. First aid administered.

RACE 2 : UBET / SABOIS FILLIES AND MARES MAIDEN PLATE - 1100 metres (Cont'd)

Correct weight for this event was delayed to allow Stewards to view the official footage of the start in relation to MISS WEREWOLF.

RACE 3 : AIRMASTER / SABOIS MAIDEN PLATE – 1200 metres

JUST WALLY (S. Cahill) – lost its off side front plate during the event. A post-race veterinary examination revealed no visible abnormalities.

VAN PERSIE (J. Potter) - jumped away awkwardly.

EDGE OF CHAOS (T. Pannell) – raced keenly in the early and middle stages of the event.

JUST DEMANDING (E. Finnegan) - jumped away awkwardly.

**RACE 4 : HILL RIVER CLARE ESTATE SEDUIRE RATING 0- 58 HANDICAP
– 1800 metres**

MUMBLE BEE (J. Potter) – a pre-race veterinary examination on arrival on course as injured in the stalls and ruled the mare fit to race.

CRYSTAL ICON (Z. Spain) - trainer fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. jumped away awkwardly and raced ungenerously in the early and middle stages of the event.

RACE 5 : MAGIC FM / 5CS RATING 0-58 HANDICAP - 1100 metres

SEMAPHORE (S. Cahill) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

PHOENIX ARIZONA (NZ) (A. Doyle) – stood flat-footed and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

JACK OF CLUBS (M. Poon) - jumped away awkwardly.

DIAMOND GLEN (E. Finnegan) - a post-race veterinary examination revealed the mare to be slightly dehydrated. First aid administered.

MAGISUE (O. Ridge) – raced ungenerously in the early and middle stages of the event.

RACE 6 : TAMINGA HOTEL CLARE VALLEY CUP - 1800 metres

SANDHILL CHIEF (M. Poon) – apprentice M. Poon pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in a forehand manner in consecutive strides prior to the 100 metres and was reprimanded.

NOT A ZERPRISE (E. Finnegan) – performed below expectations. A post-race veterinary examination revealed elevated heart rate.

RACE 7 : JIM BARRY WINES BENCHMARK 64 HANDICAP - 1200 metres

ARTHURIAN LEGEND (J. Kah) – reared on jumping away and was very slow to begin.

MERRY CHRISTMAS (J. Maund) - laid in under pressure in the straight.

Correct weight for this event was delayed to allow Stewards to view the official footage of the start in relation to ARTHURIAN LEGEND.
