**RACE 1 : PHIL STEVENS & ASSOCIATES / MIDDLETON SECURITIES BENCHMARK 54**  
**HANDICAP - 1200 metres**

**PHOENIX MISS** (L. Stojakovic) – rider reported her mount failed to handle the going. A post-race veterinary examination revealed the mare to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

**THE HEADMISTRESS** (B. Griffiths) – hung out throughout and shifted out making the home turn.

**FACE LEICA STAR** (R. Vigar) – bumped on jumping away by WOTZINTHEBAG, which shifted out.

Correct weight for this event was delayed to allow Stewards to confirm the Judge's placing's as the photo finish equipment had malfunctioned during the event. This failure was rectified prior to the next event.

**RACE 2 : FLINDERS PORTS / SABOIS MAIDEN PLATE - 1000 metres**

**DINNER CAMP** (B. Griffiths) – very slow to begin and lost considerable ground. Warning issued.

**BAZILLION** (M. Poon) – the mare underwent a pre-race veterinary examination as it had struck the running rail en route to the barriers and was passed fit to race. Raced greenly in the straight.

**DECANTRUM** (R. Vigar) – raced in restricted room over the concluding stages.

**SHAZZAMATTAZ** (L. Stojakovic) – late withdrawal at 1.09 pm on Veterinary advice after colliding with the barriers on a number of occasions. Stewards ordered that all monies invested on SHAZZAMATTAZ be refunded and that all successful wagers placed prior to 1.09 pm to be subject to the deductions of 4 cents in the dollar for the win and 5 cents in the dollar for the place. Mr T. Haddy was reprimanded under LR18.7 for declaring W. Kerford as the rider of the mare without a firm engagement,

**RACE 3 : CEDUNA FOODLAND CHRISTMAS HANDICAP - 1000 metres**

**EXALTED OMEGA** (G. Willoughby) – late withdrawal on Veterinary advice at 1.40 pm. Stewards ordered that all monies invested on EXALTED OMEGA be refunded and that all successful wagers placed prior to 1.40 pm be subject to the deductions of 19 cents in the dollar for the win.

**GOT TO HURRY** (M. Poon) – hung out rounding the home turn.

**RACE 4 : VITERRA / GLENCORE GRAIN THEVENARD CUP - 1600 metres**

**EBONY ROCK** (Jemma Frew) – Jemma Frew pleaded guilty to charges under AR137A(5)(a)(i) and AR137A(5)(a)(ii) in that she used her whip in consecutive strides and on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed the gelding to be lame in near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

**RACE 4 : VITERRA / GLENCORE GRAIN THEVENARD CUP - 1600 metres (Cont'd)**

**TESTATE** (T. O' Donnell) – raced keenly in the early and middle stage of the event.

**RACE 5 : CEDUNA HOME TIMBER & HARDWARE BENCHMARK 54 HANDICAP - 1600 metres**

**COSTLY ARGUMENT** (G. Willoughby) – inclined to lay in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**HERO TO VILLIAM** (R. Vigar) – R. Vigar pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**WILLY THE RABBIT** (M. Poon) – slow to begin.
