### Report on Race Meeting held at Gawler Racecourse by the Gawler & Barossa Jockey Club on Wednesday, 9 December 2015

### RACE 1 : HI BEAM CAR & PET WASH GAWLER / SABOIS DSITANCE MAIDEN PLATE - 2115 metres

**DAPPER ROSSA** (E. Finnegan) – laid in from in the vicinity of the 800 metres.

**HENRY THE DOLPHIN** (T. Zanker) - raced wide without cover throughout the event and was inconvenienced approaching the 400 metres.

**ROMULUS FLIGHT** (T. Pannell) –approaching the 400 metres rolled out onto BELLA SPOSA, which was tightened onto HENRY THE DOLPHIN which was taken out onto CUPID'S ROZE, resulting in both these runners being inconvenienced.

**THE BRIGHTONIAN** (A. Doyle) – began awkwardly, shifted out and inconvenienced CUPID'S ROZE and thereafter was obliged to be steadied in the vicinity of the 1200 metres when crossed. Rider reported that after being crossed his mount got its head up and raced keenly for a short distance.

**EXPRESSEN** (M. Nielson) – was eased out of the event in the vicinity of the 600 metres. Rider explained the gelding began well but felt short in its action throughout the event and when placed under pressure in the vicinity of the 800 metres shortened its stride, was off the bridle and stopped quickly and for that reason he eased his mount out of the event and did not ride it out to the finish in his normal manner. A post-race veterinary examination revealed a lower than expected heart rate.

BELLA SPOSA (J. Holder) – tightened approaching the 400 metres.

**CHIAZZA** (J. Toeroek) – shifted in, in the vicinity of the 1200 metres and crossed THE BRIGHTONIAN when insufficiently clear. J. Toeroek was severely reprimanded.

**CUPID'S ROZE** (K. Bishop) – was inconvenienced at the start and tightened approaching the 400 metres.

### RACE 2 : FOUR WAYS FRESH PRODUCE /CG&E MAIDEN PLATE - 1111 metres

**BEL SORBET** (C. Lindop) – began awkwardly, shifted in onto BACKSTAGE PASS (Z. Spain), which was taken in onto HINCREDIBLE, resulting in contact between these two horses.

**DYFIELD** (A. Doyle) – began awkwardly. Raced wide without cover in the early stages. Laid out from inside the 800 metres and raced greenly in the straight.

**BOGGOMS** (E. Finnegan) – raced greenly over the concluding stages of the event and shifted out near the winning post. Lost its off fore plate during the event.

### RACE 2 : FOUR WAYS FRESH PRODUCE /CG&E MAIDEN PLATE - 1111 metres (Cont'd)

**GENERAL WITNESS** (T. Pannell) – slow to begin. Raced wide without cover in the early stages of the event.

**HINCREDIBLE** (J. Kah) - inconvenienced at the start. A post-race veterinary examination revealed no visible abnormalities.

**BACKSTAGE PASS** (Z. Spain) – inconvenienced at the start.

### RACE 3 : ELDERS REAL ESTATE GAWLER / ULTRATUNE GAWLER / SABOIS F&M MAIDEN PLATE – 1111 metres

The start of this event was delayed approximately two minutes.

**CREPE VOLANT** (W. Kerford) – rolled in, in the vicinity of the 500 metres and inconvenienced ANABELLA, which had to be momentarily steadied.

**GOLDEN CLASS** (M. Neilson) – proved difficult to load. Raced keenly in the early stages of the event.

**HOT DEMAND** (J. Kah) – proved fractious in the mounting yard, underwent a pre-race veterinary examination on arrival at the barriers and passed fit to race. Lost its off fore plate during the event.

PRINCESS ASTRO (T. Pannell) - began awkwardly and inconvenienced ANABELLA.

SEDUCING (J. Maund) - stumbled for no apparent reason in the vicinity of the 800 metres.

ALEXIS JET (Jemma Frew) – awkward to begin.

**ANABELLA** (J. Toeroek) – inconvenienced at the start and again thereafter in the vicinity of the 500 metres. A post-race veterinary examination revealed no visible abnormalities.

**COMPLIMENT** (M. Poon) – M. Poon pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in consecutive strides prior to the 100 metres and was reprimanded. He also pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**SILENT SINNER** (D. Caboche) – laid in, in the straight. Rider was dislodged from his mount after the winning post and was uninjured in the incident. A post-race veterinary examination revealed no visible abnormalities.

### RACE 4 : SPORTSBET CASH CARD RATING 0-62 HANDICAP- 1715 metres

**INDIGO SUN** (S. Cahill) - A post-race veterinary examination revealed no visible abnormalities.

**LIZANA** (E. Finnegan) – pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

**MADAM KAFOOPS** (M. Poon) – laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**WITCHFIRE** (E. Boyd) – raced keenly in the early stages of the event. Trainer fined \$100 under AR59A for failing to produce Thoroughbred Identification Card. The filly was permitted to start – identified from records held by Stewards. As this was the second offence for breach of the same rule, Trainer Mr McMillan was advised the filly would not be allowed to be entered to race until he produces the Thoroughbred Identification Card.

## <u>RACE 5 : DENIS (FATHER) O'MALLEY MEMORIAL BUNG FRITZ CUP RATING 0-62 HANDICAP</u> - 2115 metres

**DITCHED** (A. Doyle) – raced wide without cover in the early and middle stages of the event.

LAND OF THE FREE (M. Neilson) - A post-race veterinary examination revealed no visible abnormalities.

**IT'S LUMSDEN** (J. Maund) – awkward to begin. A post-race veterinary examination revealed no visible abnormalities.

### RACE 6 : KINGSFORD / LYNDOCH HOTEL RATING 0-62 HANDICAP - 1111 metres

The start of this event was delayed approximately one minute.

**CARDINAL MISSION** (T. Pannell) - A post-race veterinary examination revealed no visible abnormalities.

**SOCIAL LANE** (J. Kah) - A post-race veterinary examination revealed no visible abnormalities.

**BALLET TIME** (A. Doyle) - A pre-race veterinary examination revealed minor abrasions to its near hind leg, passed fit to race. Awkward to begin.

### RACE 7 : GOLDIN FARMS-AKEED MOFEED CLASS TWO HANDICAP - 1511 metres

**CYCLONE THOMAS** (M. Neilson) – rider explained his instructions were to allow the gelding to settle where comfortable, however, having regard for his and the Trainer's assessment and the likely pace in the event, they anticipated the gelding might be able to settle in a position mid-field. He added Mr Kent, Co-Trainer of CYCLONE THOMAS, instructed he should avoid racing on the fence as it was his view the ground on the fence may be inferior and to ensure he maintained the horse's momentum throughout the event as the gelding would be unlikely to finish the race off in the best possible fashion when ridden in a stop-start manner. M. Neilson stated the gelding did not begin on terms and as a consequence he was obliged to settle a little further back then intended. He maintained a position off the fence but in the vicinity of the 700 metres was off the bridle and despite encouragement the gelding only finished the race off fairly. Mr Kent confirmed the instructions provided and added the stable was confident about the gelding's chances in this event. A post-race veterinary examination revealed no visible abnormalities. Mr Kent advised the gelding would now be going for a spell.

**MR PORTER** (J. Holder) - A post-race veterinary examination revealed no visible abnormalities.

### RACE 8 : COOPERS CARLSBERG CLASS TWO HANDICAP – 1211 metres

**AKKACAN** (A. Doyle) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities. Rider explained the gelding raced like a tired horse and did not finish the race off as he expected.

**BRIMARVI CUGAT** (E. Finnegan) - A post-race veterinary examination revealed no visible abnormalities.

**NOTHERBOTTLEGONSKI** (T. Pannell) – tightened for a number of strides in the vicinity of the 800 metres.

**COMMANDING DIVA** (S. Cahill) – laid in approaching the 800 metres, shifted in near the 800 metres and tightened NOTHERBOTTLEGONSKI and continued to lay in for the remainder of the event.

**EXPORT QUALITY** (E. Boyd) – obliged to steady shortly after the start when SERBIAN CROWN rolled out.

**MAGGIE'S CALL** (D. Caboche) – shifted in approaching the 800 metres. Took the running of BAND PRACTICE, which became awkward on this gelding's heels and had to be restrained losing its position. D. Caboche pleaded guilty to a charge of Careless riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 12 December and to conclude at midnight on Friday, 18 December 2015, a period of three (3) meetings

### RACE 8 : COOPERS CARLSBERG CLASS TWO HANDICAP – 1211 metres (Cont'd)

WANA DECISION (J. Maund) - held for clear running for a short distance approaching the 400 metres.

**SERBIAN CROWN** (C. Lindop) – shifted out shortly after the start.
