STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at the Port Lincoln Racecourse
by the Port Lincoln Racing Club on Friday, 11 December 2015

RACE 1 : BARBADOS @ DUCATOON PARK STUD / SABOIS TWO-YEAR-OLD MAIDEN PLATE
- 1000 metres

The start of this event was delayed approximately two minutes owing to K. Bishop becoming dislodged from COMEDY ROAD and being examined by the First Care Medical Personnel who passed her fit to fulfill her remaining engagements.

CAPTAIN OASIS (S. Cahill) - a post-race veterinary examination revealed minor lacerations to the near hind pastern. Trainer advised the gelding would now be spelled.

CYCLONE STRYKER (T. Pannell) - a discrepancy was found regarding the brands listed on the Thoroughbred Identification Card of CYCLONE STRYKER and nose physically on the gelding prior to the start of the event. As Stewards were not able to confirm the identity of the gelding, CYCLONE STRYKER was declared a late scratching by order of Stewards at 3.01 pm. Trainer, Mr S. Drewitt was reprimanded under AR59(2) for failing to identify the horse properly on its arrival at his stable.

ARTFUL RAMBLER (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

COMEDY ROAD (K. Bishop) – shortly after the start lost its position when tightened between LOCKS WELL and KID ME. Disappointed for a run inside the 100 metres between KID ME, which rolled out and GOLDPHON. As a result COMEDY ROAD was untested to the line.

DAY SPA (M. Neilson) – Trainer fined \$50 under AR59A for failing to produce the Thoroughbred Identification Card. The filly was permitted to start – identified form records held by Stewards.

GOLDPHON (T. O'Donnell) - a post-race veterinary examination revealed no visible abnormalities.

HALLS BAY (Z. Spain) – raced greenly throughout the event.

LOCKS WELL (J. Kah) - in the vicinity of the 300 metres was obliged to be eased as HALLS BAY, which was racing greenly, rolled in.

ROCKY VALLEY (C. Jones) – raced greenly throughout the event.

RACE 2 : MGA INSURANCE / SABOIS MAIDEN PLATE - 1000 metres

ACE OF SPADES (E. Boyd) – inclined to hang out in from the vicinity of the 700 metres for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

PATRIOT CODE (K. Bishop) - a post-race veterinary examination revealed no visible abnormalities.

WHITE JADE (M. Neilson) – was a late scratching at 3.40 pm on Veterinary advice.

LOS RIOS (T. O' Donnell) – brushed with PIERREMONT MAGIC shortly after the start.

PIERREMONT MAGIC (Z. Spain) – brushed with LOS RIOS shortly after the start.

RACE 3 : LOWE & REDDING DESIGN / SABOIS MAIDEN PLATE - 1390 metres

CARBON STORM (S. Cahill) – jumped away awkwardly and was slow to begin.

OUTLAW (A. Doyle) – inclined to rear on jumping away.

THAT COOL TIGER (K. Bishop) – over-raced in the early and middle stages of the event.

VANQUISH CHOISE (M. Neilson) – raced wide without cover throughout the event. Inclined to hang in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

BUTTERFLY TATTOO (J. Potter) – inclined to hang out throughout the event. A post-race veterinary examination revealed minor abrasions to the near side of the mouth.

Correct weight for this event was delayed to allow Stewards to view the official footage in the straight.

RACE 4 : LAWSON REAL ESTATE RATING 0-62 HANDICAP - 1210 metres

SWINGIN' DAZZLER (E. Boyd) – in the vicinity of the 150 metres shifted in. Rider issued a reprimand.

TINSLEY GREEN (L. Stojakovic) – in the vicinity of the 150 metres rolled out.

HEZA HUSSLER (D. Tootell) – inconvenienced in the vicinity of the 150 metres as SWINGIN' DAZZLER shifted in and TINSLEY GREEN rolled out.

SANDHILL JET (A. Doyle) - A post-race veterinary examination revealed the gelding to be lame in near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

MAGICAL MUSICIAN (K. Bishop) – raced wide without cover throughout the event.

ALL KRUPT (Z. Spain) – shifted in under pressure in the straight.

BELUGA GOLD (T. Pannell) – held up for clear running from in the vicinity of the 400 metres until in the vicinity of the 100 metres behind HEAVENS FLIGHT and inside GEORDIES'S SECOND.

TRINKET LADY (J. Kah) – lost both front plates during the event.

RACE 5 : AVIS PORT LINCOLN BENCHMARK 64 HANDICAP - 1000 metres

FATHER TONY (A. Doyle) - jumped away awkwardly.

IMPERIAL FURY (J. Kah) – contacted on jumping away. A post-race veterinary examination revealed no visible abnormalities.

DOWNS AFTER DARK (L. Stojakovic) - a post-race veterinary examination revealed a speedy cut to the off hind pastern and abrasions to the off side of the mouth.

GOOD CONDUCT (K. Bishop) - jumped away awkwardly and shifted out contacting IMPERIAL FURY.

SUTANOC (Z. Spain) – pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

RACE 6 : RSM BENCHMARK 64 HANDICAP - 1750 metres

BOSSA NOVA (NZ) (J. Kah) – raced wide without cover throughout the event.

CATCH HIM (J. Potter) – held up for clear running from in the vicinity of the 400 metres until the entrance to the straight when racing behind WILLY THE RABBIT and inside PHOENIX EAGLE (NZ).

EMAIL (L. Stojakovic) – over-raced in the early and middle stages of the event and got its head up on a number of occasions when being restrained. A post-race veterinary examination revealed no visible abnormalities.

RACE 6 : RSM BENCHMARK 64 HANDICAP - 1750 metres (Cont'd)

HERO TO VILLAN (A. Doyle) – slow to begin.

RACE 7 : JOHN MARMION MEMORIAL BENCHMARK 80 HANDICAP - 1390 metres

PROPSHAFT (J. Potter) – rolled in approaching the 100 metres. Rider issued a reprimand.

MOON DEVIL (A. Doyle) – held up from the 400 metres until the entrance to the straight. Approaching the 100 metres had to be steadied as PROPSHAFT rolled in.

DIRE WARNING (E. Boyd) - slow to begin. Difficulty obtaining clear ground from inside the 200 metres until the finish line.

FORESHORE MAK (L. Stojakovic) – turned its head into the adjoining barrier as the start was affected, missed the start losing several lengths and was uncompetitive during the event. A post-race veterinary examination revealed no visible abnormalities.

Correct weight for this event was delayed to allow L. Stojakovic, the rider of FORESHORE MAK and Mr B. Cozamanis (Jnr), that gelding’s Trainer to view the official footage at the start. After viewing the footage L. Stojakovic and Mr B Cozamanis (Jnr) made a submission to Stewards that FORESHORE MAK was denied a fair start as the gelding turned its head into the adjoining barrier as the start was affected. After viewing the footage, acting on their own observations and considering the evidence tendered Stewards deemed FORESHORE MAK was not denied a fair start and declared the horse to be a runner.

RACE 8 : THE CUSTOM KITCHEN COMPANY RATING 0-62 HANDICAP - 1390 metres

MORCHOWIE MISS (T. O'Donnell) – slow to begin. Was held up from the 400 metres until approaching the 200 metres when racing behind MOLTO VIVACE and inside WAADOO.

LAMU LAD (Z. Spain) – rider reported the gelding felt awkward in its action during the event. A post-race veterinary examination revealed no visible abnormalities.

STRAWPEDO (K. Bishop) – had difficulty obtaining clear ground for a short distance at the entrance to the straight.
