RACE 1: RUSTIK COVE / SABOIS MAIDEN PLATE - 1210 metres

The start of this event was delayed approximately two minutes.

CARBON STORM (S. Cahill) –was taken out and tightened onto JUNIOR MAC on jumping away and lost its position. Eased in the vicinity of the 200 metres when SCHOONER WON shifted out.

JUNIOR MAC (T. Pannell) - A post-race veterinary examination revealed no visible abnormalities.

SCHOONER WON (Z. Spain) - jumped away awkwardly, shifted out contacting CARBON STORM. Shifted out in the vicinity of the 200 metres inconveniencing CARBON STORM. Rider was issued a reprimand.

THAT COOL TIGER (D. Caboche) – approaching the 1000 metres shifted in tightening MAPPINGA QUEEN, which was racing greenly, onto EXALTED FEATURES. D. Caboche was severely reprimanded.

CELLULOID (T. Zanker) – inconvenienced at the start when tightened between JIRIKI and JUNIOR MAC.

ECHINACEA (D. Tootell) – on arrival at the barriers reared and dislodged D. Tootell. Underwent a prerace veterinary examination ruled the mare fit to race. D. Tootell was examined by the First Care Medical Personnel and ruled unfit to fulfill his remaining engagements. Acting on this advice Stewards withdrew ECHINACEA at 12.19 pm. Warning issued.

RACE 1 : RUSTIK COVE / SABOIS MAIDEN PLATE - 1210 metres (Cont'd)

EXALTED FEATURES (E. Boyd) - jumped away awkwardly and shifted in. Inclined to race greenly throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MAPPINGA QUEEN (B. Griffiths) – raced greenly and hung out throughout the event. Approaching the 1000 metres tightened onto EXALTED FEATURES. Rider, B. Griffiths who was dislodged on return to scale was examined by the First Care Medical Personnel and passed fit to fulfill his remaining engagements. A post-race veterinary examination revealed no visible abnormalities. Warning issued.

COMPLIMENT (J. Kah) – on arrival on course underwent a pre-race veterinary examination due to an incident in the float en route to the course and ruled the filly unfit to race. Acting on this advice Stewards withdrew COMPLIMENT at 10.52 am.

JIRIKI (L. Stojakovic) – inconvenienced at the start when tightened onto CELLULOID as EXALTED FEATURES shifted in.

RACE 2: SHEDS FOR EYRE RATING 0-58 HANDICAP - 1390 metres

JESTWIN (Z. Spain) - jumped away awkwardly and shifted in tightening STRAWPEDO onto NOBLE ROMP. Laid in under pressure in the straight.

STRAWPEDO (L. Stojakovic) – lost position at the start when tightened onto NOBLE ROMP as JESTWIN shifted in.

NANNA KNOWS BEST (D. Caboche) – had difficulty obtaining clear running from in the vicinity of the 400 metres and was untested to the line. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: SCHWEPPES RATING 0-58 HANDICAP - 1390 metres

The start of this event was delayed approximately three minutes owing to avoid a clash with an interstate race and STRAVINSKA being fractious in the barriers.

HEZA HUSSLER (T. Pannell) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

COSTLY ARGUMENT (T. O'Donnell) – over-raced throughout the event. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

STRAVINSKA (E. Boyd) – became fractious in its barriers and reared up after being loaded. A pre-race veterinary examination ruled the mare fit to race. Knuckled on jumping away.

BOURBONDETTA (W. Kerford) – laid in under pressure in the straight. W. Kerford pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

WOTZINTHEBAG (D. Caboche) - slow to begin.

RACE 4: RSM BENCHMARK 64 HANDICAP - 1390 metres

OCSMEPOP (Z. Spain) – slow to begin.

PERUVIAN POWER (T. Zanker) - jumped away awkwardly. Inclined to lay in under pressure in the straight.

RACE 5: LIBERTY RURAL / LOGICOIL PORT LINCILN RATING 0-58 HANDICAP - 1000 metres

MY BOY BRANDO (T. Zanker) – slow to begin.

RACE 5 : LIBERTY RURAL / LOGICOIL PORT LINCILN RATING 0-58 HANDICAP - 1000 metres (Cont'd)

ALL KRUPT (Z. Spain) - jumped away awkwardly and shifted in contacting SCENIC MINT. Rider reported inclined to hang in under pressure in the straight.

ICELANDIC STAR (S. Cahill) – S. Cahill pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in consecutive strides prior to the 100 metres and was reprimanded. He also pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

MR ROADSTAR (E. Boyd) – Rider reported saddle slipped shortly after the start placing her at a disadvantage for the remainder of the event.

SCENIC MINT (W. Kerford) - jumped away awkwardly contacting ALL KRUPT.

BAZILLION (M. Poon) – raced greenly in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: SHIELD SECURITY BENCHMARK 80 HANDICAP - 1000 metres

SPIRIT OF FLATLEY (W. Kerford) - A post-race veterinary examination revealed no visible abnormalities.

RACE 7: KEMP REAL ESTATE BENCHMARK 58 HANDICAP - 1750 metres

CATCH HIM (Z. Spain) –shifted in contacting TRESETTE shortly after the start. Laid in under pressure in the straight.

MORCHOWIE MISS (T. O'Donnell) - inconvenienced in the vicinity of the 1400 metres.

PHOENIX EAGLE (T. Pannell) – held up from the 400 metres until approaching the finish when racing behind ROCK SPEED (L. Stojakovic) and to the inside of DO TELLE (NZ). A post-race veterinary examination revealed no visible abnormalities.

TRESETTE (B. Griffiths) – unbalanced shortly after the start as CATCH HIM shifted in.

ALERT THE WORLD – A late scratching at 3.30 pm by order of Stewards as there was no available rider on course.

HERO TO VILLIAN (T. Zanker) – in the vicinity of the 1400 metres was obliged to be eased off the heels of WILLY THE RABBIT, which rolled in.

WILLY THE RABBIT (M. Poon) – in the vicinity of the 1400 metres rolled in tightening HERO TO VILLIAN onto MORCHOWIE MISS for several strides. Rider issued a severe reprimand.

RACE 8: MGA INSURANCE BROKERS PORT LINCOLN BENCHMARK 80 HANDICAP - 1750 metres

DIRE WARNING (E. Boyd) - raced in restricted room at the entrance to the straight between JAPAN and PRIMAL INSTINCT for a short distance.

NEW WAVE (T. Zanker) – raced wide without cover in the early and middle stages of the event.

FORESHORE MAK (L. Stojakovic) – rider reported did not feel comfortable in its action over the concluding stages. A post-race veterinary examination revealed strained off fore flexor tendon. First Aid administered. Veterinary Certificate of Fitness required prior to trial or race.

RACE 9: AVIS PORT LINCOLN BENCHMARK 64 HANDICAP - 1210 metres

The start of this event was delayed approximately one minute.

DESTONY HAWK (M. Poon) – raced wide without cover throughout the event.

RACE 9: AVIS PORT LINCOLN BENCHMARK 64 HANDICAP - 1210 metres (Cont'd)

GEORDIE'S SECOND (J. Kah) – late scratching by order of Stewards at 5.11 pm owing to the gelding being reluctant to proceed to the start. Trainer, Mrs A. Harder was advised that the gelding would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

HEZAFRAAR (T. Pannell) – rolled in inside the 200 metres.

HEAVENS FLIGHT (S. Cahill) – rider granted permission to ride 1kg overweight as there was no other rider available on course. He pleaded guilty to a charge under AR120(b) for being overweight and was fined \$100.

ARJAE (B. Griffiths) – Rider reported the mare was reluctant to stretch out shortly after the start and did not feel comfortable in its action during the event. A post-race veterinary examination revealed no visible abnormalities.

SUTANOC (Z. Spain) – inside the 200 metres was inconvenienced when tightened onto THE HEADMISTRESS when HEZAFRAAR rolled in.
