RACE 1: WOLF BLASS GREY LABEL / SABOIS & MAIDEN / CLASS ONE PLATE - 2100 metres

ANURADHA (J. Frew) – slow to begin. Passing the crossing at the 2000 metres became awkward in its stride and over-raced for some distance.

MANOSA (NZ) (M. Neilson) - a post-race veterinary examination revealed no visible abnormalities.

DAPPER ROSSA (D. Tourneur) – hung in throughout and in the vicinity of the 300 metres had to take hold of his mount when crowded for room. A post-race veterinary examination revealed no visible abnormalities.

CHAMPAGNE KRIS (J. Maund) – passing the crossing at the 2000 metres became awkward in its stride and over-raced for some distance.

ULTIMATE THRILL (D. Caboche) – D. Caboche pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Thursday, 31 December 2015, and to conclude at midnight on Wednesday, 6 January 2016: a period of four (4) meetings.

RACE 2 : ADELAIDE GALVANISING INDUSTRIES / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1500metres

SILENT ICE (D. Tourneur) – rider reported his mount laid out throughout the event.

SPIEGEL GROVE (J. Maund) - slow to begin.

LEMON ZEST (Z. Spain) – slow to begin.

VINTAGE DISH (M. Poon) – raced wide without cover throughout the event.

RACE 3: SCHWEPPES MIXERS / SABOIS MAIDEN PLATE - 1100 metres

KAPSCERO (A. Doyle) - jumped away awkwardly and shifted out abruptly. Over-raced in the middle stages. A post-race veterinary examination revealed no visible abnormalities.

SAVING WINSTON (E. Finnegan) – hampered on jumping.

SNIPETRON (J. Holder) – raced greenly when placed under pressure over the concluding stages.

STATEYOURBUSINESS – Late scratching on Veterinary advice at 9.03 am.

REGAL ROGUE (C. Lindop) – in the vicinity of the 1000 metres had to be restrained to avoid the heels of SEE ME ROLLIN', which was carried in by COBBY GIRL, despite the efforts of its rider.

RACE 3: SCHWEPPES MIXERS / SABOIS MAIDEN PLATE - 1100 metres (Cont'd)

TORCIDA (D. Tourneur) – hampered at the start and was slow to begin. Held up at the entrance to the straight.

RACE 4 : SPORTSBET CASH CARD FOUR-YEARS-OLD & OVER CLASS 1 HANDICAP - 1500 metres

NUTHERBOTTLEGONSKI (J. Bowditch) - J. Bowditch pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

ONE FOR MAX (J. Holder) – was hampered in the vicinity of the 200 metres.

KARADOC KID (S. Cahill) – raced wide without cover throughout the event.

THING OF NOTHING (IRE) (T. Pannell) – in the vicinity of the 100 metres had to be restrained when crowded for room.

BAND PRACTICE (Z. Spain) – raced greenly when placed under pressure in the straight.

EXONERATION (A Doyle) – over-raced throughout the early and middle stages.

RACE 5 : COOPERS PALE ALE MARES BENCHMARK 64 HANDICAP - 1500 metres

COMMANDING DIVA (S. Cahill) – hung in when placed under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

LIZANA (J. Toeroek) – slow to begin.

DEEP POCKETS (C. Lindop) – had difficulty obtaining clear running from the vicinity of the 400 metres until the entrance to the straight.

RACE 6: SANDERS FODDER RATING 0-62 HANDICAP - 1100 metres

BALZAC (T. Zanker) – raced wide without cover throughout the event. T. Zanker pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

GO'EN HOFF (D. Caboche) - A post-race veterinary examination revealed no visible abnormalities.

GALAXY GLAZER – a late scratching on Veterinary advice at 3.56 pm after becoming fractious in the barriers, breaking free and galloping a considerable distance before being restrained. Warning issued.

VEEJAY KISS (J. Holder) – slow to begin.

RACE 7: GOLDIN FARMS-AKEED MOFEED BENCHMARK 64 HANDICAP - 1200 metres

PRESIDIUM (E. Boyd) – over-raced after improving onto the heels of CARASHAN GIRL in the vicinity of the 1100 metres. A post-race veterinary examination revealed no visible abnormalities.

MAVERICKS (D. Caboche) - A post-race veterinary examination revealed no visible abnormalities.

ROUSSANNE (S. Cahill) – raced in restricted room over the concluding stages and could not be fully tested to the line.

URBAN BOURBON (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: FAMILY FUN DAY 6 JAN BENCHMARK 64 HANDICAP - 1500 metres

SET ON STONE (T. O'Donnell) – slow to begin and raced wide without cover throughout the event.

BAIKAL (Z. Spain) – momentarily held up for clear running at the entrance to the straight.
