THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 2 January 2016

TRACK: Good 4 (Upgraded to a Good 3 @ 11.40 am)

(Upgraded to Firm 2 @ 4.15 pm retrospective to Race 6)

WEATHER: Fine

RAIL: Out 5 metres 1200 metres to 400 metres, 3 metres remainder. Sectional 605 metres.

RACE 1 : SCHWEPPES TWO-YEAR-OLD PLATE - 1050 metres

BENZ (J. Toeroek) – was slow to begin. Galloped on the hindquarters of GOLDPHON when shifting in near the 900 metres, made heavy contact with the running rail in that vicinity and again near the 800 metres. Trainer, Mr G. Richards was advised that the gelding would be required to be tractable in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed speedy cuts to its off side hock.

TIME OUT (C. Jones) - was slow to begin.

FIRE 'N' VICE (J. Kah) - a post-race veterinary examination revealed a poor respiratory recovery.

SMART MANOEUVRE (D. Tourneur) - was slow to begin. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

WITH A BIT OF DASH (J. Holder) - was slow to begin.

GOLDPHON (E. Boyd) - was slow to begin. Galloped on near the 900 metres and lost ground. Rider reported the saddle shifted to the off side in this vicinity placing her at a disadvantage for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: UBET ADELAIDE CUP 14 MARCH HANDICAP - 2018 metres

RIVER'S LANE (T. Pannell) – Stewards questioned T. Pannell in relation to not electing to use his whip over the concluding 100 metres. T. Pannell explained that he had used the whip on four occasions prior to the 100 metres but did not make any ground on the leader and when placing the gelding under hand and heels pressure in the vicinity of the 100 metres, felt that RIVER'S LANE had responded better and for this reason had elected to continue to ride in this manner to the finish.

EIGELSTEIN (GB) (K. Brooks) – raced keenly in the early and middle stages of the event. Inclined to lay out under pressure in the straight.

WHERE'S TIM (J. Holder) – was inclined to shift about under pressure in the straight. Rider reported that in his opinion, the gelding may not have appreciated the firm track. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: SEATON HOTEL THREE-YEAR-OLD MAIDEN PLATE - 1100 metres

DOIN' IT SOLO (S. Cahill) – laid in severely over the concluding 100 metres. A post-race veterinary examination revealed no visible abnormalities.

IXCATAN (J. Cartwright) - A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Veterinary Certificate of Fitness required prior to trial or race.

RACE 3: SEATON HOTEL THREE-YEAR-OLD MAIDEN PLATE - 1100 metres (Cont'd)

SEEK TO DESTROY (J. Maund) – laid in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

WATCH THE WOLF (C. Lindop) – kicked by another runner behind the barriers. A pre-race veterinary examination ruled the gelding fit to race.

WISH LIST (J. Holder) - jumped away awkwardly and was slow to begin.

RACE 4: PROJECTION GRAPHICS HANDICAP - 1800 metres

OUR UNCLE ARCHIE (J. Toeroek) - Trainer fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards. Rider reported the gelding had not travelled well throughout the event and was under pressure from the vicinity of the 1000 metres. He added, in his opinion, the gelding had resented the tongue tie. A post-race veterinary examination revealed no visible abnormalities.

SOLID BULLET (J. Bowditch) - a post-race veterinary examination revealed lower back and hindquarter soreness. Veterinary Certificate of Fitness required prior to trial or race.

INDIGO SUN (C. Lindop) – raced keenly in the early and middle stages of the event.

ANURADHA (Z. Spain) – Trainer advised he had instructed Z. Spain to attempt to obtain a more forward position in today's event, if possible. Jumped away awkwardly and was slow to begin. Laid out under pressures in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: CAMPOLINA STUD HANDICAP - 1515 metres

POWDERWORKS (Z. Spain) – slow to begin and shifted in contacting ALASKAN JADE. Laid in under pressure in the straight and in the vicinity of the 300 metres shifted in inconveniencing KIRONA. Rider reported the filly laid out until the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

HAZY LANE (J. Toeroek) – unable to obtain clear ground from the vicinity of the 600 metres until near the 300 metres.

TZAREVNA (E. Boyd) – laid out over the concluding 1000 metres and in the vicinity of the 900 metres shifted out inconveniencing FRENCH AMOUR, which was taken wider on the track. A post-race veterinary examination revealed no visible abnormalities.

ALASKAN JADE (J. Maund) – was contacted on jumping away.

FRENCH AMOUR (C. Lindop) - was slow to begin. 900 metres inconvenienced when taken wider. A post-race veterinary examination revealed no visible abnormalities.

BLONDE VOYAGE (J. Bowditch) – rider reported the filly raced keenly in the early stages and when placed under pressure in the 600 metres had failed to respond to his riding and had finished the event off poorly. He added, in his opinion, the filly had not run the trip out. A post-race veterinary examination revealed the filly to be lame in off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

KIRONA (T. Pannell) – inconvenienced near the 300 metres.

RACE 6: HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1200 metres

DUBAWI GOLD (J. Cartwright) – in the vicinity of the 800 metres shifted in when insufficiently clear onto COOL MAVERICK, which was forced to take hold. Rider found guilty of a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 9 January and to conclude at midnight on Saturday, 16 January 2016: a period of three (3) meetings.

RACE 6: HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1200 metres (Cont'd)

SHIP'S CAPTAIN - A post-race veterinary examination revealed no visible abnormalities.

TIPPERARY LIL (S. Cahill) – obliged to take hold in the vicinity of the 800 metres.

RACE 7: QUAYCLEAN HANDICAP - 1600 metres

HIOCTDANE (C. Jones) - A post-race veterinary examination revealed no visible abnormalities.

DEFIANT ANGEL (E. Finnegan) – raced wide without cover throughout the event.

CAPODECINA (C. Lindop) – slow to begin. Raced keenly in the early and middle stages of the event.

WHAT'S IN A NAME (J. Bowditch) – raced keenly in the early and middle stages of the event.

GENEROUS BEAU (T. Pannell) – raced keenly in the early and middle stages of the event.

RACE 8: MAC DRINK DRIVING? GROW UP HANDICAP - 1100 metres

MISTER ROCKSTAR (C. Jones) – shifted out on jumping away contacting WAPPING, which was inconvenienced when tightened onto TANGIER SUN.

ESSENTIAL ELEMENT (P. Denton) - jumped away awkwardly and was slow to begin.

TANGIER SUN (J. Cartwright) – lost its position on jumping away when contacted by WAPPING and taken out onto ROCK OUT. Contacted HUSSON'S SHOUT at the entrance to the straight to obtain clear ground.

WAPPING (J. Kah) – rider reported in her opinion, the gelding may not have appreciated the firm ground. A post-race veterinary examination revealed the gelding to be lame in both forelegs. Veterinary Certificate of Fitness required prior to trial or race.

BABITZIN (E. Finnegan) - a post-race veterinary examination revealed a small overreach injury to heel on near foreleg.

HUSSON'S SHOUT (D. Tourneur) – contacted at entrance to straight.

ABU DHABI (J. Bowditch) – bumped with ROCK OUT at entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

MISS WORLD – underwent a pre-race veterinary examination at the barriers which ruled the mare unfit to race. Declared a late scratching at 5.19 pm by order of Stewards.

ROCK OUT (Z. Spain) – bumped with ABU DHABI at the entrance to the straight.

LOPE DE CAPIO (J. Toeroek) - A post-race veterinary examination revealed the gelding to be lame in off foreleg. Veterinary Certificate of Fitness required prior to trial or race.
