**RACE 1 :UBET / SABOIS MAIDEN PLATE - 1008 metres**

**MIDNIGHT MOON** (J. Bowditch) - A post-race veterinary examination revealed no visible abnormalities.

**ACCIDENTAL JOURNEY** (K. Brooks) – bumped at the start. Shifted out approaching the 800 metres when awkwardly placed on the heels of LAUVASSA. Inclined to race greenly under pressure in the straight.

**BANANA PANCAKES** (J. Potter) – slow into stride.

**THE CASTLE KAT** (R. Hurdle) – approaching the 800 metres became awkwardly placed on the heels of ACCIDENTAL JOURNEY, which shifted out and thereafter was inclined to race keenly.

**LAUVASSA** (T. Pannell) – jumped away awkwardly, shifted in and bumped ACCIDENTAL JOURNEY.

**RED ORBIT** (P. Gatt) – shifted out under pressure in the straight.

**RACE 2 : WESLO SECURITY BENCHMARK 60 HANDICAP - 1008 metres**

**BATTISTONI** (J. Potter) – A post-race veterinary examination revealed minor lacerations to the near hind cannon. Trainer advised the gelding would now be spelled.

**AHEAD OF TIME** (Z. Spain) – raced keenly in the early and middle stages of the event.

**ALPHABETIC** (K. Brooks) – held up for clear running from in the vicinity of the 300 metres until the 200 metres when racing behind HURRICANE ANDY and to the inside of VILLE DE BERNE.

**HURRICANE ANDY** (J. Kah) – dipped on jumping away.

**RACE 3 : HYGAIN FEEDS / SABOIS MAIDEN PLATE - 1358 metres**

**DENY DENY DENY** (J. Kah) – held up for clear running rounding the home turn until entering the straight when racing behind CORONA SHAW and to the inside of BANGARANG.

**SOCIAL SET** (E. Finnegan) – approaching the 800 metres became awkwardly placed on the heels of SHAKAMBER, which had to be restrained off the heels of COCO RHYTHM. As a result SOCIAL SET was obliged to be steadied and lost its position.

**SURE GONE** (D. Caboche) - jumped away awkwardly.

**COCO RHYTHM** (C. Lindop) – in the vicinity of the 900 metres had to be restrained when awkwardly placed on the heels of CORONA SHAW and WHISPERING WILLOW.

**SHAKAMBER** (Z. Spain) - in the vicinity of the 900 metres was awkwardly placed on the heels of COCO RHYTHM and was obliged to be restrained for a short distance.

#### **RACE 4 : G & J EAST STRATHALBYN / SABOIS MAIDEN PLATE – 1608 metres**

**BELL CHOISIR** (S. Cahill) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

**PARENTIVE** (P. Gatt) - in the vicinity of the 300 metres dipped for no apparent reason. A post-race veterinary examination revealed no visible abnormalities. Trainer advised the gelding would now be spelled.

**SILENT SINNER** (D. Caboche) - jumped away awkwardly.

**SKILLZ THAT KILLZ** (J. Bowditch) - in the vicinity of the 1400 metres shifted in onto FLY HIGH FOR FRED. Rider reprimanded.

**FLY HIGH FOR FRED** (E. Finnegan) – over-raced in the early and middle stages of the event and in the vicinity of the 1400 metres was obliged to be eased as SKILLZ THAT KILLZ shifted in.

#### **RACE 5 : BETTS SHOE STORES / SABOIS PLUS MAIDEN / CLASS ONE PLATE - 2062 metres**

**CATCH ME LATAR** (C. Jones) – laid in under pressure in the straight.

**ARTEMISIA** (D. Tourneur) – had difficulty obtaining clear ground in the vicinity of the 400 metres for a short distance.

**ROMULUS FLIGHT** (T. Pannell) - raced wide without cover throughout the event.

**REGAL ROGUE** (C. Lindop) – raced keenly throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**SHEANNA** (J. Kah) - A post-race veterinary examination revealed no visible abnormalities.

#### **RACE 6 : PURE ENVY JEWELLERY RATING 0-58 HANDICAP - 1208 metres**

**HIGHLAND HENRY** (J. Holder) – pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

**SEARAVEN** (T. Pannell) – bumped at the start with ATOMIC HERO.

**ATOMIC HERO** (Z. Spain) - jumped away awkwardly, shifted out and bumped SEARAVEN.

**SHE'S DELICIOUS** (D. Tourneur) – A post-race veterinary examination revealed no visible abnormalities.

**BOLD JAZZ** (R. Hurdle) – raced keenly in the early and middle stages of the event.

**BALLET TIME** (A. Doyle) – slow into stride.

#### **RACE 7 : 24<sup>TH</sup> FEBRUARY RACE MEET BENCHMARK 60 HANDICAP - 1608 metres**

The start of this event was delayed approximately two minutes.

**FRANK THE RIPPER** (W. Kerford) – raced keenly in the early and middle stages of the event. Raced wide without cover in the middle stages of the event.

**FLIRTY GERTY** (J. Toeroek) – rider reported the mare was inclined to lay in under pressure in the straight.

**DOWNUNDER PRINCE** (P. Gatt) - A post-race veterinary examination revealed no visible abnormalities.

**RACE 7 : 24<sup>TH</sup> FEBRUARY RACE MEET BENCHMARK 60 HANDICAP - 1608 metres (Cont'd)**

**SWEDISH BITTERS** (J. Kah) – became fractious in its barrier stall after being loaded. Underwent a pre-race veterinary examination and passed fit to race. Held up from in the vicinity of the 300 metres until in the vicinity of the 150 metres when racing behind **RIGHT AND READY** and to the inside of **BEST OF MINX**.

**BEST OF MINX** (T. Zanker) – raced wide without cover throughout the event.

**CHRISTOPHERSON** (M. Neilson) - slow to begin.

**YEN** (R. Hurdle) – over-raced throughout the event.

**OUR UNCLE ARCHIE** (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 8 : BREMERTON WINES BENCHMARK 60 HANDICAP – 1358 metres**

**STRAYING TIGER** (J. Potter) – bumped at the start as **SHOWVIZ** was taken out. A post-race veterinary examination revealed an elevated heart rate.

**REWIND TIME** (M. Neilson) – raced keenly in the early stages of the event. Approaching the 200 metres rolled out.

**CLASSY DIAMOND** (E. Finnegan) – had difficulty obtaining clear ground in the straight.

**COPPER COAST RAIDA** (J. Toeroek) – dipped shortly after the start for no apparent reason.

**RANSOM VALUE** (T. Zanker) - was slow to begin. Approaching the 200 metres became awkwardly placed and was obliged to be steadied off the heels of **REWIND TIME**, which rolled out and **SHOWVIZ**, which rolled in.

**SHOWVIZ** (Z. Spain) – bumped at the start and taken out as **SPIRITED MATCH** jumped away awkwardly and shifted out. Approaching the 200 metres rolled in.

**SPIRITED MATCH** (D. Caboche) - jumped away awkwardly and shifted out bumping **SHOWVIZ**, which was taken out.
