Report on Race Meeting held at the Naracoorte Racecourse by the Naracoorte Racing Club on Sunday, 14 February 2016

RACE 1: PPH&S SABOIS MAIDEN PLATE - 1430 metres

NEW YORK MONTY (K. Maskiell) – in the vicinity of the 1200 metres rider allowed his mount to shift in when insufficiently clear of THE GREEN SASH. Rider was reprimanded and advised to take greater care when shifting ground in future.

OAKBANK REIGN (M. Neilson) – in the vicinity of the 1200 metres was crowded in onto SMASHING TYCOON by THE GREEN SASH, which was crowded in by NEW YORK MONTY.

SPIN FOR LUCK (C. Hall) – hung out throughout the event.

THE GREEN SASH (E. Finnegan) - in the vicinity of the 1200 metres was hampered when crowded in onto OAKBANK REIGN by NEW YORK MONTY, which shifted in when insufficiently clear.

SMASHING TYCOON (C. Puls) - in the vicinity of the 1200 metres was crowded and had to be restrained to avoid the heels of OAKBANK REIGN, which was carried in by THE GREEN SASH.

FRENZIE – a late scratching on veterinary advice at 1.00 pm after the mare flipped over in the mounting enclosure. Trainer advised the mare would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

SILENT ARROW (D. Tourneur) – hung out when placed under pressure over the concluding stages.

RACE 2: NARACOORTE RACING CLUB PRESIDENTS / SABOIS MAIDEN PLATE - 1000 metres

SIR EIFFEL (J. Cartwright) - a post-race veterinary examination revealed a sprain to the off side flexor tendon. Veterinary Certificate of Fitness required prior to trial or race.

SUBJECT TO CHANGE (D. Tourneur) - in the vicinity of the 300 metres was momentarily crowded when racing tight to the inside of CHERAX.

COURT RANGER (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

PELINA (C. Hall) – reared on jumping away and was slow to begin. A post-race veterinary examination revealed speedy cuts to both hind legs.

RACE 3: COOPERS CLEAR BENCHMARK 80 HANDICAP - 1200 metres

SANDHILL WARRIOR (M. Poon) – slow into stride.

MORNIN' SAM (P. Marks) – slow to begin.

RACE 4: THE MIDFIELD GROUP BENCHMARK 64 HANDICAP- 1000 metres

SPOILSPOT (S. Cahill) – began awkwardly, shifted out and bumped GATUM EXPRESS. When questioned regarding the performance of the gelding, the rider explained that despite beginning awkwardly his mount travelled comfortably in the early and middle stages while racing outside the leader. He added approaching the 300 metres, when placing the gelding under pressure, failed to respond to his vigorous urging and in his opinion was disappointed in its finishing effort. A post-race veterinary examination revealed no visible abnormalities.

SHE'S ALL POWER (M. Poon) – slow to begin. Raced greenly when placed under pressure in the straight.

MAGNUS REWARD (E. Finnegan) - in the vicinity of the 100 metres was hampered when carried wider on the track by SHE'S ALL POWER.

GATUM EXPRESS (C. Puls) – bumped on jumping away.

RACE 5: MARANA PARK BENCHMARK 60 HANDICAP - 2000 metres

VALENTINIAN (USA) (M. Poon) - a post-race veterinary examination revealed no visible abnormalities.

VEGAS BOUND (K. Maskiell) - a post-race veterinary examination revealed speedy cuts.

INDIGO SUN (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

YET ANOTHER TIME (E. Boyd) – over-raced in the early and middle stages of the event.

MR LAMBORGHINI (P. Marks) - held up for clear running at the entrance to the straight.

RACE 6: BARRETT PETROLEUM BENCHMARK 60 HANDICAP - 1200 metres

The start of this event was delayed approximately two minutes owing to remedial work to the running rail.

ANY GIVEN GLASS (M. Neilson) - began awkwardly, shifted out and bumped LADY JUBILEE.

LADY JUBILEE (C. Puls) – bumped at the start.

DADDY'S LITTLELADY (J. Potter) – held up for clear running at the entrance to the straight.

DEEP POCKETS (D. Tourneur) - underwent a pre-race veterinary examination and passed fit to race. Permission was granted for a boot to be applied to the near hind leg.

RACE 7: MINI JUMBUK NARACOORTE CUP - 2000 metres

EVENMOREACTION (G. Cartwright) – rider reported she was instructed to find cover, however, after beginning well was trapped three wide without cover in the early stages of the event. She added in the vicinity of the 1000m her mount began to over-race after she attempted to restrain her mount to find cover. She added she elected to race three wide rather than place her mount under pressure early in the race and push forward to lead. G Cartwright added after placing her mount under pressure approaching the 500m, it failed to respond to her vigorous urgings and was disappointing in its run to the finish. A post-race veterinary examination revealed no visible abnormalities.

SANDHILL CHIEF (M. Poon) – knuckled on jumping away.

PRACTISED (Z. Spain) - A post-race veterinary examination revealed no visible abnormalities.

ZAYAK – a late scratching on veterinary advice at 8.55 am.

HADDA COUPLE (D. Tourneur) – rider reported in the vicinity of the 800 metres elected to place his mount under pressure in an attempt to gain a greater leading margin as he was of the opinion that the speed of the race was slow.

RACE 8: SOUTH EAST MOTOR COMPANY BENCHMARK 64 HANDICAP - 1430 metres

BACK ON TRACK (M. Poon) – shifted out when placed under pressure over the concluding stages, momentarily crowding KIRVIC. Rider reminded of his obligation when shifting ground in future.

SHADE OF GREEN (D. Tourneur) – over-raced in the early and middle stages of the event.

DULCIE JANE - a late scratching on veterinary advice at 8.55 am.

KIRVIC (G. Cartwright) – had to be steadied to avoid the heels of BACK ON TRACK in the vicinity of the 50 metres.

MONTANA MOON (E. Boyd) - underwent a pre-race veterinary examination and passed fit to race.
