**RACE 1 : MITAVITE AND SANDERS FODDER / SABOIS FILLIES & MARES MAIDEN PLATE**  
- 1111 metres

**SOLSTICE** (K. Brooks) – momentarily inconvenienced in the vicinity of the 500 metres.

**ZAZIPZOOM** (Jemma Frew) – jumped away awkwardly and got its head up striking Jemma Frew in the vicinity of her face, unbalancing that rider.

**ANNIEFROMTHECREEK** (A. Doyle) - jumped away awkwardly.

**AUGUSTA BELLE** (D. Caboche) – laid in under pressure in the straight. In the vicinity of the 50 metres shifted in onto WICKED AFFAIR. Rider reminded of his obligations when shifting ground in future.

**EVIL MISS** (E. Finnegan) – shifted out near the 500 metres inconveniencing SOLSTICE. A post-race veterinary examination revealed no visible abnormalities. Lost its near fore plate during the event.

**NIPPY LIPPY** (J. Bowditch) – raced in restricted room over the concluding 50 metres. A post-race veterinary examination revealed no visible abnormalities.

**WICKED AFFAIR** (J. Holder) – taken in onto NIPPY LIPPY over the concluding 50 metres.

**RACE 2 : HAPPY BIRTHDAY 'BIG AL' SABOIS MAIDEN LATE - 1511 metres**

**CARSON (NZ)** (D. Tourneur) – became awkward for a number of strides near the 1100 metres when inconvenienced by BANGARANG.

**GOODBYE GOOD LUCK** (J. Maund) – momentarily held up at the entrance to the straight then shifted out onto BANGARANG. Rider reprimanded.

**SIMON THE LIKEABLE** (J. Toeroek) - near the 1100 metres shifted in onto BANGARANG. Rider reminded of his obligations when shifting ground in future. Had to be steadied at the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

**BANGARANG** (P. Gatt) – taken in near the 1100 metres by SIMON THE LIKEABLE. Tightened at the entrance to the straight and taken out onto GOODBYE GOOD LUCK.

**RAINBOW REFLECTION** (W. Kerford) - A post-race veterinary examination revealed the mare to be lame in near hind leg. Veterinary Certificate of Fitness required prior to trial or race. First aid administered.

### **RACE 2 : HAPPY BIRTHDAY 'BIG AL' SABOIS MAIDEN LATE - 1511 metres (Cont'd)**

**SINGLE PRINCESS** (S. Cahill) - jumped away awkwardly. Rider explained the mare travelled well in the early and middle stages of the event but failed to respond to his riding when placed under pressure inside the 600 metres. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 3 : SCHWEPPE PEPSI / SABOIS MAIDEN PLATE – 1211 metres**

**SCHOONER** (R. Hurdle) – hampered on jumping away. Raced fiercely in the early and middle stages of the event.

**KINGSTONIAN** (A. Doyle) - A post-race veterinary examination revealed no visible abnormalities.

**LORD NICCONI** (M. Neilson) - was slow to begin. Rider explained the gelding had not stretched out at any stage during the event. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Veterinary Certificate of Fitness required prior to trial or race.

**PAYDAYZ** (J. Cartwright) - jumped away awkwardly and shifted out onto SWEET SCHILLY.

**ROAD TO REIMS** (C. Lindop) – held up from the vicinity of the 500 metres until near the 400 metres. A post-race veterinary examination revealed no visible abnormalities.

**SWEET SCHILLY** (D. Caboche) – inconvenienced on jumping away.

**RECHARGING TO WIN** (W. Kerford) - jumped away awkwardly and shifted out onto SCHOONER.

### **RACE 4 : GAWLER SOUTH BAKERY BENCHMARK 60 HANDICAP - 1111 metres**

**LOCKDOWN JACK** (J. Holder) – stood flat-footed and missed the start several lengths. Warning issued. Laid in under pressure in the straight.

**URBAN BOURBON** (R. Hurdle) – taken in near the 100 metres by LOCKDOWN JACK.

**INVINCIBLE JULES** (P. Gatt) – poor performance. A post-race veterinary examination revealed no visible abnormalities.

**SHARK MIRAGE** (J. Cartwright) – reared on jumping away.

**MAPPINGA QUEEN** (T. O' Donnell) – raced fiercely throughout the event and was inclined to lay out rounding the turns.

**SPARKLING VIXEN** (K. Brooks) – eased and obliged to alter course near the 100 metres when WILD RUN shifted in and away from URBAN BOURBON.

**WILD RUN** (D. Caboche) – shifted in and away from URBAN BOURBON near the 100 metres.

### **RACE 5 : SPORTSBET – CASH CARD BENCHMARK 60 HANDICAP - 1722 metres**

**DANOULI** (J. Holder) – hung out severely over the concluding 400 metres, resulting in its rider not being able to test the gelding. A post-race veterinary examination revealed no visible abnormalities.

**MOOSEM** (J. Cartwright) – laid in under pressure in the straight.

**KAPSCERO** (A. Doyle) – rider explained he had been instructed to lead, however, in the early stages when he became aware that ROOBOY appeared to be single minded in leading, he had attempted to restrain the gelding to allow ROOBOY to cross. However, his mount had commenced to race fiercely and he was only able to get the gelding to respond near the 1200 metres.

**BOOGIEDAYZ** (P. Gatt) – poor performance. A post-race veterinary examination revealed no visible abnormalities.

**DOWNUNDER PRINCE** (J. Potter) - A post-race veterinary examination revealed the gelding to be lame in both forelegs. Veterinary Certificate of Fitness required prior to trial or race.

**RACE 6 : GOLDIN FARMS-AKEED MOFEED BENCHMARK 64 HANDICAP - 2122 metres**

**NOMIS (NZ)** (P. Gatt) – rider reported the gelding had not travelled at any stage throughout the event. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

**NISHIAZABU** (Jemma Frew) – rider reported the gelding wanted to lay out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**BAKLAVA BOY (NZ)** (D. Tourneur) - jumped away awkwardly and shifted in bumping BEST OF MINX.

**BEST OF MINX** (T. Zanker) – contacted on jumping away.

**RACE 7 : BRENDAN HOWARD MEMORIAL CLASS 2 HANDICAP - 1211 metres**

The start of this event was delayed approximately three minutes.

**BABITZIN** (E. Finnegan) – rider pleaded guilty to a charge under AR137A(c) in that she made a celebratory gesture prior to the finish of the race and was fined \$200. Contacted in the vicinity of the 400 metres.

**LOPE DE CAPIO** (K. Kah) – broke through the barrier after being loaded and was quickly recaptured by its rider. Underwent a pre-race veterinary examination and passed fit to race. Rider examined by the First Care Medical Personnel and passed fit to ride.

**GALAXY GAZER** (C. Lindop) – reared after being loaded. Underwent a pre-race veterinary examination that revealed a laceration to the head and was ruled unfit to race. First aid administered. Late scratching by order of Stewards at 4.43 pm. Warning issued.

**GO THE JOURNEY** (M. Poon) – rolled out near the 400 metres and bumped BABITZIN.

**RACE 8 : COOPERS CLEAR BENCHMARK 64 HANDICAP - 1511 metres**

**FORCE OF THREE** (J. Kah) – raced fiercely in the middle stages of the event.

**HEREFORD** (P. Denton) – slow to begin.

**NUTHERBOTTLEGONSKI** (M. Neilson) – bucked shortly after the start and lost significant ground. Trainer advised that the gelding would be required to perform tractably in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

**MIKAELA** (W. Kerford) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

Race 6 – NOMIS (NZ) - Vet Cert of Fitness required for future trial or race – Lameness near foreleg. Race 7 – GALAXY GAZER – Warned – Fractious in barrier. Race 8 – NUTHERBOTTLEGONSKI – Suspended – Required to perform tractably in an Official Barrier Trial prior to future race – Bucked.
