RACE 1 : SCHWEPPES HANDICAP - 1000 metres

SIGNOR GAETANO (Z. Spain) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$300.

POINT DRUMMOND (R. Hurdle) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$200.

RACE 2: UBET HANDICAP - 1550 metres

ASK ME HOW I KNOW (E. Finnegan) - contacted on jumping away.

HAZY LANE (E. Boyd) – shifted out on jumping away contacting ASK ME HOW I KNOW.

TIMES PAST (P. Gatt) – raced keenly in the early and middle stages.

MAIL IT IN (J. Holder) – laid in under pressure in the straight.

SHEANNA (T. Pannell) – raced keenly in the early and middle stages.

RACE 3: HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1000 metres

CALIANCO (J. Cartwright) – reared on jumping away.

SNIP OF MAGIC (T. O'Donnell) - a post-race veterinary examination revealed no visible abnormalities.

HIGHEST NOTE (J. Kah) – rider's whip became caught in her gear in the vicinity of the 200 metres.

RACE 4: UBET ADELAIDE CUP 14TH MARCH HANDICAP - 1250 metres

DUCKWORTH (J. Cartwright) – raced keenly in the early and middle stages. Rider accidentally dropped his whip in vicinity of the 200m and was issued a reprimand.

RACE 4: UBET ADELAIDE CUP 14TH MARCH HANDICAP - 1250 metres (Cont'd)

BAY ROAD (C. Jones) – jumped away awkwardly and slow into stride. Raced keenly in the early and middle stages. Inclined to lay in under pressure in the straight.

CARASHAN GIRL (J. Bowditch) - a post-race veterinary examination revealed no visible abnormalities.

RACE 5: CHAD HANCOCK CANCER FOUNDATION HANDICAP - 2400 metres

The start of this race was delayed approximately one minute to avoid a clash with an interstate race.

STIMULATTE (J. Cartwright) - a post-race veterinary examination revealed a lower than expected heart rate.

TUNES (D. Tourneur) – laid out under pressure in the straight.

WARRIOR OF FIRE (C. Lindop) – raced keenly in the early and middle stages of the event.

HOYLAKE (NZ) (J. Bowditch) - a post-race veterinary examination revealed no visible abnormalities.

ROBOCOP (J. Potter) – jumped away awkwardly.

NISOS (J. Kah) – jumped away awkwardly.

RACE 6: MEDALLION HOMES HANDICAP - 1200 metres (Run on Morphettville track)

ESSAY RAIDER (C. Lindop) – contacted on jumping away and tightened onto RIZIZ. Raced in restricted room in the straight between the heels of BRIMARVI PRINCE and TRUENO. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Co-Trainers Mr. L Macdonald and Mr. A. Gluyas were advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RED ECLIPSE (J. Holder) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer Mr. G. Young was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

BRIMARVI PRINCE (J. Toeroek) – shifted out on jumping away and bumped ESSAY RAIDER.

TRUENO (T. Pannell) – lost near fore plate during the event.

<u>RACE 7 : HOLDFAST INSURANCE BIRTHDAY CUP</u> - 2000 metres (Run on Morphettville track)

KUSHADASI (P. Gatt) – near the 100m improved onto the heels of SATURDAY SORCERER, which had commenced to give ground, and had to be steadied for a number of strides when LUCKY LUCKY LUCKY improved to its outside. A post-race veterinary examination revealed no visible abnormalities.

LUCKY LUCKY (T. Pannell) – lost its position on jumping away when tightened onto CAPADECINA by GRAVITATIONAL.

GRAVITATIONAL (D. Tourneur) – shifted out and away from TIDY PROPHET on jumping away onto LUCKY LUCKY LUCKY.

RIVER'S LANE (D. Caboche) – Trainer Mr. R. Balfour advised he would instruct D. Caboche to ride the gelding more patiently today and settle further back than at its previous start if possible.

WHAT'S IN A NAME (J. Bowditch) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7: HOLDFAST INSURANCE BIRTHDAY CUP - 2000 metres (Cont'd) (Run on Morphettville track)

CAPADECINA (J. Toeroek) – improved onto the heels of LUCKY LUCKY LUCKY near the 600m and had to be steadied.

TIDY PROPHET (C. Jones) – shifted out on jumping away.

RACE 8: MAC DRINK DRIVING? GROW UP HANDICAP - 1550 metres

THE NEW BOY (J. Cartwright) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$100.

BOYS GETAROUND HIM (M. Neilson) – rider reported his mount wanted to lay out under pressure in the straight.

IT'S FRED (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

WALTZING TO WIN (J. Toeroek) - a post-race veterinary examination revealed a small amount of mucous in the right nostril. First Aid was administered.

PURREAL (R. Hurdle) – rider questioned regarding a report from the Clerk of Scales that he had changed his boots after weighing out. After considering his evidence, Stewards did not proceed with a charge, however, he was advised of his obligations in accordance with AR118A.
