# RACE 1: PPH&S BENCHMARK 72 HANDICAP - 1200 metres

KILL BILL (D. Tourneur) – jumped away awkwardly and shifted out abruptly.

**HELANDY** (M. Neilson) – rider reported the gelding did not feel comfortable in its action at any stage. A post-race veterinary examination revealed no visible abnormalities.

## RACE 2: LANDMARK BENCHMARK 60 HANDICAP - 1000 metres

**BETTER JOURNEY** (J. Maund) – over-raced in the early stages.

**SEE IT MY WAY** (J. Potter) – over-raced in the early stages. Held up for clear running rounding the home turn. Raced in restricted room in the vicinity of the 300m.

SHE'S ALL POWER (M. Poon) – slow to begin.

VISUAL IMAGE (D. Tourneur) – hung out when placed under pressure over the concluding stages.

## RACE 3: COMBINED LIVESTOCK CARRIERS / SABOIS MAIDEN PLATE - 1430 metres

The start of this race was delayed approximately three minutes.

**DAWN'S BOY** (M. Neilson) – refused to load. Withdrawn by Stewards at 2.25 pm. Trainer Mr. P. Preusker was advised the gelding would be required to load without delay in an Approval to Race Jump Out or Official Barrier Trial prior to accepting for a future race.

**HADFIELD** (E. Finnegan) – reared in barriers after being loaded. A pre-race veterinary examination ruled the gelding unfit to race. Acting on that advice, Stewards withdrew HADFIELD at 2.25 pm. Trainer Mr. R. Daniel was advised a warning had been placed on the gelding in relation to its barrier manners.

**SUDDEN IMPULSE** (S. Cahill) – a pre-race veterinary examination ruled the gelding fit to race. Rider reported he was concerned with the gelding's action and it made an audible noise throughout the race. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr. R. Daniel undertook to provide a veterinary clearance, including the results of an endoscopic examination, prior to presenting SUDDEN IMPULSE for a future trial or race as he was of the opinion the gelding was lame.

## RACE 3: COMBINED LIVESTOCK CARRIERS / SABOIS MAIDEN PLATE - 1430 metres (Cont'd)

**THE HUNT IS ON** (J. Maund) – raced keenly in the early stages of the event.

**SHORTLY MISS** (C. Puls) – rider failed to weigh in as required under the Rules following the race and was reprimanded under AR144.

#### RACE 4: HAPPY BIRTHDAY BRUCE JAENSCH / SABOIS MAIDEN PLATE - 1100 metres

**IAMTHEKEY** (S. Cahill) – slow to begin.

**PELLIANTIC** (C. Hall) – over-raced in the early stages of the event.

**SHOOSHKABOB** (M. Neilson) – raced greenly when placed under pressure over the concluding stages.

**SMASHING TYCOON** (M. Poon) – rider reported his saddle slipped to the off side on jumping away placing him at a disadvantage for the remainder of the race.

**COURT RANGER** (E. Boyd) – proved difficult to proceed to the start. Trainer Mr. D. O'Leary was advised a warning had been placed on the mare in relation to its pre-race manners. Rider explained that in the vicinity of the 700m her saddle shifted backwards placing her at a disadvantage over the concluding stages.

#### RACE 5: GM HARFIELD MEMORIAL RATING 0-58 HANDICAP - 1200 metres

**LUCKY DEJA VU** – withdrawn by Stewards at 12.48 pm acting under LR20.9.2. Trainer Ms. J. Gow-Whyte pleaded guilty to a charge under LR20.9.2 in that she accepted for a race without the bona fides for the gelding being correct and was fined \$300.

**NIGHT NEWS** (M. Poon) – jumped away awkwardly and shifted out, hampering DADDY'S LITTLELADY.

**DADDY'S LITTLELADY** (J. Potter) – hampered on jumping away by SHE'S DELICIOUS, which shifted in, and NIGHT NEWS, which shifted out.

SHE'S DELICIOUS (D. Tourneur) – jumped away awkwardly and shifted in, hampering DADDY'S LITTLELADY.

**INTOSSICARE** (T. O'Donnell) – hung in throughout the event.

## RACE 6: SAL BENCHMARK 64 HANDICAP - 2000 metres

**GATALISTIC** (S. Cahill) – rider dislodged in the vicinity of the 600 metres. S. Cahill was examined by the First Care Medical Personnel and was stood down from his remaining engagements. A post-race veterinary examination revealed a fractured near radius and ulna. The gelding was humanly euthanased.

**VALENTINIAN (USA)** (J. Cartwright) – inconvenienced in the vicinity of the 600 metres when attempting to avoid fallen runners.

**SOME DO** (J. Maund) – rider dislodged in the vicinity of the 600 metres. J Maund was examined by the First Care Medical personnel and conveyed to hospital for precautionary x-rays.

**HUNTED** (E. Finnegan) – over-raced in the early and middle stage of the event. A post-race veterinary examination revealed no visible abnormalities.

**YET ANOTHER TIME** (E. Boyd) - over-raced in the early and middle stage of the event. In the vicinity of the 1000 metres had to be restrained after improving onto the heels of SIX OF HEARTS.

Stewards will inquire into the circumstances in which S. Cahill (GATALISTIC) and J. Maund (SOME DO) were dislodged from their mounts in the vicinity of the 600 metres at a date to be fixed.

# RACE 7: ELDERS BENCHMARK 60 HANDICAP - 1430 metres

The start of this race was rescheduled to 5.12 pm.

**TELASNIP** (D. Tourneur) – kicked by another runner on arrival at the barriers. A pre-race veterinary examination ruled the gelding fit to race. Over-raced in the early and middle stages of the event. In the vicinity of the 1000 metres had to be restrained after improving onto the heels of ANY GIVEN GLASS.

**INSTANT CONVERT** (T. O'Donnell) – kicked by another runner on arrival at the barriers. A pre-race veterinary examination ruled the gelding fit to race. Slow to begin.
