STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Penong Racecourse
by Penong Racing Club on Saturday, 12 March 2016

Stewards: D. Bucknell (A/Chairman), P. Dearman (HT), M. Chandler (F) & R. Evans (Deputy Stewards), Dr. G. Sezun (Veterinary Surgeon)

TRACK: Good

WEATHER: Fine

Rail: True

RACE 1 : CEDUNA FORESHORE HOTEL MOTEL / SABOIS MAIDEN PLATE - 1200 metres

DESH (T. Zanker) – a post-race veterinary examination revealed the gelding had strained its near fore flexor tendon. Veterinary Certificate of Fitness required prior to trial or race.

WILLIS (B. Griffiths) - slow to begin.

SHAZZAMATTAZ (C. Davies) - a post-race veterinary examination revealed no visible abnormalities. Trainer advised the mare would now be retired.

RACE 2 : LION & CO / BEVAN CAMPBELL BENCHMARK 54 HANDICAP - 1000 metres

MY BOY BRANDO (T. Zanker) – laid in under pressure in the straight. In the vicinity of the 100 metres bumped WESTERN BOY, which shifted out. As a result the rider momentarily lost the use of her inside rein. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$200.

LEWIS STREET (D. Tootell) - a post-race veterinary examination revealed no visible abnormalities.

GOT TO HURRY (C. Davies) – began awkwardly.

WESTERN BOY (L. Stojakovic) – inclined to lay out under pressure in the straight. Bumped another runner in the vicinity of the 100 metres.

RACE 3 : PENONG HOTEL / WEST COAST FUEL BENCHMARK 60 HANDICAP - 1200 metres

CONTEGO (T. Zanker) – began awkwardly.

STRAVINSKA (A. Doyle) – laid in under pressure in the straight.

COSMIC KHELEYF (C. Davies) – rider pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in consecutive strides prior to the 100 metres and was reprimanded. He also pleaded guilty under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was suspended from riding in races for a period to commence at midnight on Monday, 14 March, and to conclude at midnight on Saturday, 19 March 2016: a period of three (3) meetings.

RACE 4 : FAR WEST FARMERS PENONG CUP - 1600 metres

VOODOO BLACK MAGIC (W. Kerford) – bucked for a short distance shortly after the start and as a result lost ground. Trainer advised that the gelding would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

EMAIL ((L. Stojakovic) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$100.

RACE 4 : FAR WEST FARMERS PENONG CUP - 1600 metres (Cont'd)

LUSTREMANN (B. Griffiths) – rider pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in consecutive strides prior to the 100 metres and was reprimanded. He also pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was suspended from riding in races for a period to commence at midnight on Monday, 14 March, and to conclude at midnight on Saturday, 19 March 2016: a period of three (3) meetings.

RACE 5 : GYPSUM RESOURCES AUSTRALIA / PENONG STATION BENCHMARK 54 HANDICAP
– 1400 metres

WILLY THE RABBIT (W. Kerford) – began awkwardly shortly after the start, attempted to buck, refused to race and took no competitive part in the event. Trainer advised the gelding would now be retired. Stewards advised should the gelding return to racing it would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

NANNA KNOWS BEST (A. Doyle) – laid in under pressure in the straight and shifted in abruptly approaching the winning post.

Race 5 – WILLY THE RABBIT Suspended - Required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race – Attempted to buck, raced intractably.
