**TRACK:** Soft 5 (*Upgraded to Good 4 @ 2.35 pm retrospective to Race 4*)      **WEATHER:** Fine

**RAIL:** Out 8 metres from 1000 metres to winning post, 5 metres remainder.

**RACE 1 : PROJECTION GRAPHICS BENCHMARK 75 HANDICAP - 1400 metres**

**BELUGA BLUE** (C. Lindop) - jumped away awkwardly and was slow to begin. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**JOYFUL JOURNEY** (T. Pannell) – rider pleaded guilty to a charge under AR137(b) in that he failed to ride his mare out to the end of the race and was fined \$400.

**RACE 2 : UBET SABOIS THREE-YEARS-OLD MAIDEN PLATE - 1000 metres**

**CAPTAIN MIRAGE** (J. Cartwright) – shifted in on jumping away and bumped MORNING SUNSHINE.

**CHICO BUBBLES** (J. Toeroek) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

**CLEVER TOMMY** (S. Cahill) – difficult to load. Warning issued. Jumped away awkwardly.

**IMA SPECIAL KID** (O. Ridge) – shifted in under riding inside the 100 metres. Rider reminded of his obligations when shifting ground in future. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**BLONDE VOYAGE** (R. Hurdle) – commenced to hang out in the vicinity of the 700 metres, shifted out near the 600 metres and clipped the heels of CHICO BUBBLES. Warning issued. A post-race veterinary examination revealed the filly to be lame in the off foreleg and a laceration on the off foreleg, consistent with being galloped on. Veterinary Certificate of Fitness required prior to trial or race.

**MORNING SUNSHINE** (M. Neilson) – contacted on jumping away. Lost its position shortly after the start when BARABBA BOY shifted out and away from IMA SPECIAL KID.

**TEGULA SUNRISE** (J. Bowditch) – raced in restricted room for a number of strides inside the 100 metres when IMA SPECIAL KID shifted in.

**RACE 3 : ADELAIDE GALVANISING SABOIS PLUS BENCHMARK 70 HANDICAP - 1950 metres**

**LONCAVA (NZ)** (C. Jones) – raced wide without cover throughout the event.

**ROOBOY** (J. Cartwright) - a post-race veterinary examination revealed a rub wound to the near hind fetlock. First aid administered.

**RACE 3 : ADELAIDE GALVANISING SABOIS PLUS BENCHMARK 70 HANDICAP - 1950 metres**  
(Cont'd)

**ELMANTOSH** (J. Toeroek) – raced keenly in the early and middle stages of the event.

**HUSSON'S SHOUT** (M. Neilson) - jumped away awkwardly. Inclined to lay in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**RACE 4 : STEVE DAVIS SABOIS TWO-YEAR-OLD HANDICAP - 1000 metres**

**WHITE FEATHER** (J. Kah) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 5 : QATAR AIRWAYS BENCHMARK 64 HANDICAP - 1000 metres**

**THE BRONX** (J. Kah) – shifted in on jumping away and bumped KILIM.

**RUBYONE** (J. Holder) – forced to race in restricted room over the concluding 70 metres.

**TORI'S GIFT** (P. Gatt) – slow to begin. A post-race veterinary examination revealed the mare to be lame in the near foreleg. First aid administered. Veterinary Certificate of Fitness required prior to trial or race.

**KILIM** (C. Jones) – shifted out on jumping away and bumped THE BRONX.

**SPARTAN WARRIOR** (J. Toeroek) – raced greenly in the straight and inside the 100 metres shifted out under riding onto RUBYONE. Rider reminded of his obligations when shifting ground in future. A post-race veterinary examination revealed no visible abnormalities.

**RACE 6 : HUGHES CHAUFFEURED LIMOUSINES BENCHMARK 64 HANDICAP - 1250 metres**

**KILLAWARRA** (J. Kah) – held up from the vicinity of the 400 metres until near the 200 metres. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

**MOONLIGHT HUSSLER** (C. Jones) – raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**BAKER'S DOZEN** (J. Toeroek) – bumped by SUPER SWIFT in the vicinity of the 200 metres. Near the 150 metres shifted out and away from the whip of J. Cartwright onto SUPER SWIFT.

**SUPER SWIFT** (J. Bowditch) – rolled in near the 200 metres and bumped BAKER'S DOZEN.

**ENCHANTING BEAUTY** (C. Lindop) - jumped away awkwardly. In the vicinity of the 150 metres was tightened and lost its position when SUPER SWIFT was taken out by BAKER'S DOZEN, which shifted out and away from the whip of J. Cartwright. A post-race veterinary examination revealed no visible abnormalities.

**RACE 7 : SCHWEPPE'S SABOIS THREE-YEAR-OLD HANDICAP - 1550 metres**

**ASK ME HOW I KNOW** – Acting on confirmed advice from Trainer Mr P. Stokes that the filly was lame in the near foreleg and would be unfit to race, Stewards ordered the withdrawal of ASK ME HOW I KNOW at 10.20 am.

**ABU DHABI** (J. Bowditch) – shifted in under riding over the concluding 100 metres inconveniencing DROPPED.

**MOSS GO NOW** (J. Cartwright) - a post-race veterinary examination revealed no visible abnormalities.

**BATTLE BREWING** (C. Lindop) – had to take hold and lost its position approaching the 600 metres when DROPPED shifted in.

**RACE 7 : SCHWEPPE SABOIS THREE-YEAR-OLD HANDICAP - 1550 metres (Cont'd)**

**DROPPED** (J. Holder) – shifted in approaching the 600 metres onto BATTLE BREWING resulting in that runner being forced to take hold and lose its position. Rider pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Monday, 28 March, and to conclude at midnight on Wednesday, 6 April 2016: a period of four (4) meetings.

**DASHEBO** (R. Hurdle) – approaching the 600 metres had to be steadied off the heels of BATTLE BREWING.

**RACE 8 : MAC DRINK DRIVING? GROW UP HANDICAP - 1400 metres**

**PRESIDIUM** (D. Caboche) – had to momentarily steady in the vicinity of the 1200 metre when SATURDAY MAGIC shifted in. Laid out under pressure in the straight and approaching the finish shifted out towards NIGHT BREEZE. Warning issued.

**SLADE DE CERISY (FR)** (C. Jones) – laid out over the concluding stages and brushed TUSCAN FEVER approaching the finish.

**TUSCAN FEVER** (J. Kah) – held up at the entrance to the straight for a short distance.

**SATURDAY MAGIC** (J. Cartwright) – shifted in, in the vicinity of the 1200 metres onto PRESIDIUUM. Rider severely reprimanded.

**NIGHT BREEZE** (J. Bowditch) – trainer advised he would instruct J. Bowditch to attempt to ride the gelding more forward in today's event.

**YEN** (C. Lindop) – raced keenly in the early and middle stages of the event. Momentarily held up at the entrance to the straight when racing behind TUSCAN FEVER.

Correct weight for this event was delayed when J. Bowditch (NIGHT BREEZE) placed third lodged an objection alleging interference against PRESIDIUUM (D. Caboche) placed second over the concluding 150 metres. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* the objection.
