**RACE 1 : COWELL COMMERCIAL, KIMBA GATEWAY HOTELS / SABOIS MAIDEN PLATE - 1210 metres**

The start of this race was rescheduled to start at 1.08 pm.

**BERRY BABY** (T. O'Donnell) – jumped away awkwardly and shifted out. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100m and was fined \$600.

**MISS ALLIE** (M. Poon) – bumped on jumping away.

**PIERREMONT MAGIC** (D. Caboche) – bumped on jumping away.

**NIPPY LIPPY** (J. Kah) – jumped away awkwardly and shifted out.

**ON DUTY** (B. Griffiths) – rider dislodged en route to the start. B. Griffiths was examined by the First Care Medical personnel and ruled unfit to fulfil his remaining engagements. He was transported to hospital for observation. Stewards withdrew ON DUTY at 12.25 pm.

**RACE 2 : CUMMINS MILL AND BUTTERFIELD FARM DIRECT BENCHMARK 60 HANDICAP - 1750 metres**

The start of this race was rescheduled to start at 1.42 pm.

**CALIGO** (S. Cahill) – knuckled on jumping away and was slow into stride.

**DUCHOVNY** (J. Kah) – over-raced in the early and middle stages. Laid in under pressure in the home straight.

**MINDSTORMS** (T. Zanker) – over-raced in the early and middle stages.

**RACE 3 : ELDERS INSURANCE BENCHMARKS 54 HANDICAP (Division 1) - 1390 metres**

The start of this race was rescheduled to start at 2.20 pm.

**PATCHE** (J. Kah) – shifted in when insufficiently clear in the vicinity of the 100m. Rider issued with a reprimand.

**RACE 3 : ELDERS INSURANCE BENCHMARKS 54 HANDICAP (Division 1) - 1390 metres (Cont'd)**

**DIVADEBEER** (T. Pannell) – slow to begin.

**HOST ESPRIT** (T. Zanker) – slow to begin. Rider explained the mare never travelled in the early and middle stages of the event and when placed under pressure, failed to respond to his riding. A post-race veterinary examination revealed no visible abnormalities.

**ARJAE** (M. Poon) – slow to begin. Had to be momentarily steadied in the vicinity of the 100m when racing tight inside PATCHE.

**RACE 4 : AGSAVE MERCHANDISE BENCHMARK 54 HANDICAP (Division 2) - 1390 metres**

The start of this race was rescheduled to start at 2.55 pm.

**POINT DRUMMOND** (J. Kah) – shifted in under pressure in the vicinity of the 200m.

**LIZANA** (D. Caboche) – jumped away awkwardly and as a result was very slow to begin. Raced ungenerously in the early stages. A post-race veterinary examination revealed no visible abnormalities. Trainer Ms. C. Rose advised a warning had been issued on the mare's racing manners.

**BENGAL TIGER** (T. Pannell) – had to be momentarily steadied in the vicinity of the 200m.

**RACE 5 : BUD WOOLFORD MEMORIAL BENCHMARK 64 HANDICAP - 1000 metres**

The start of this race was rescheduled to start at 3.35 pm.

**SNIP IN TIME** (M. Poon) – jumped away awkwardly and shifted out.

**RACE 6 : HARDER TRANSPORT BENCHMARK 72 HANDICAP - 1390 metres**

The start of this race was rescheduled to start at 4.12 pm.

**EXTREME VALUE** (T. O'Donnell) – slow to begin.

**FRAAR MANDY** (L. Stojakovic) – slow to begin.

**RACE 7 : WUDINNA HOTEL MOTEL KIMBA CUP - 1950 metres**

The start of this race was rescheduled to start at 4.55 pm.

**MOON DEVIL** (M. Poon) – jumped away awkwardly and was slow to begin. In the vicinity of the 1200m, shifted in when insufficiently clear. Rider issued with a reprimand. In the vicinity of the 800m, shifted in when insufficiently clear. Rider issued with a severe reprimand.

**JAPAN** (L. Stojakovic) – had to be momentarily steadied in the vicinity of the 1200m and lost its position.

**JOKEN JIM** (D. Caboche) – had to be momentarily steadied in the vicinity of the 800m, losing its position, when racing tight inside MOON DEVIL.

**RACE 8 : MARINA HOTEL BENCHMARK 60 HANDICAP - 1210 metres**

The start of this race was rescheduled to start at 5.39 pm.

**ALL KRUPT** – withdrawn by Stewards at 4.45 pm as there was no rider available.

**PERUVIAN POWER** (R. Hurdle) – had to be momentarily steadied in the vicinity of the 200m and lost its position.

**RACE 8 : MARINA HOTEL BENCHMARK 60 HANDICAP - 1210 metres (Cont'd)**

**BARELY A BEAT** (T. Pannell) – shifted out momentarily under pressure in the vicinity of the 200m.

**I DREAM OF GINA** (T. O'Donnell) – a pre-race veterinary examination ruled the mare fit to race. Trainer, Mr. M. White was fined \$50 under AR59A for failing to produce the Thoroughbred Identification Card. The horse was identified from records held by Stewards and permitted to start. Jumped away awkwardly. Shortly after the start the rider lost the use of both irons and was unable to ride the mare out in her normal manner.

**HAPPYENDO** (L. Stojakovic) – bucked for a short distance shortly after the start and refused to take any part in the event. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr. H. Montgomerie was advised the gelding would be required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to accepting for a future race.

**ARTFUL FRANCYL** (M. Poon) - Trainer, Ms. J. Branford was fined \$50 under AR59A for failing to produce the Thoroughbred Identification Card. The horse was identified from records held by Stewards and permitted to start.

Correct Weight for this event was delayed to allow Stewards to review the official footage of the start in relation to I DREAM OF GINA.
