Report on Race Meeting held at Clare Racecourse by the Clare Valley Racing Club on Saturday, 26 March 2016

RACE 1 : UBET / SABOIS DISTANCE MAIDEN PLATE - 1800 metres

GRAND ARROW (L. Stojakovic) – arrived late on course. A pre-race veterinary examination ruled the gelding fit to race. Over-raced in the early and middle stages of the event.

WITHIN RANGE (S. Cahill) – shifted in and bumped SKILLZ THAT KILLZ on entering the straight. Laid in, under pressure, in the straight and shifted in and crowded SKILLZ THAT KILLZ. Rider issued with a severe reprimand.

SKILLZ THAT KILLZ (Jemma Frew) – contacted by WITHIN RANGE on entering the straight. In the vicinity of the 100m crowded for room.

Correct Weight for this event was delayed owing to Stewards, Judges and connections to view the official footage.

RACE 2 : THE MAGPIE AND STUMP HOTEL BENCHMARK 64 HANDICAP - 1800 metres

HEREFORD (D. Tootell) – over-raced in the early and middle stages of the event.

ALL ROADS (Jemma Frew) – rider reported the mare raced very keenly in the early stages and as a result she was unable to restrain her mount. Rider also reported in the vicinity of the 300m ALL ROADS began to give ground and finished the race off in a disappointing manner. A post-race veterinary examination revealed a small laceration above the near hind coronary band. Jemma Frew pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100m and was fined \$400.

RACE 3 : MAGIC FM / 5CS SABOIS MAIDEN PLATE - 1200 metres

THE REMOVALIST (D. Tootell) – jumped away awkwardly, shifted out and bumped ANOTHER ENEMY.

ANOTHER ENEMY (L. Stojakovic) – jumped away awkwardly, shifted in and bumped THE REMOVALIST. A post-race veterinary examination revealed no visible abnormalities.

ZAZIPZOOM (Jemma Frew) – raced wide rounding the home turn and raced greenly in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100m and was fined \$400. A post-race veterinary examination revealed a small laceration on the near side of the rump.

RACE 4 : XXXX GOLD / SABOIS FILLIES & MARES MAIDEN PLATE - 1100 metres

BEESRULETHEWORLD (T. O'Donnell) – jumped away awkwardly, shifted in and bumped JESSIE'S OWN.

JESSIE'S OWN (M. Poon) – jumped away awkwardly, shifted out and bumped BEESRULETHEWORLD. Shifted out approaching the 100m when insufficiently clear of MISS COMMUNICATION, taking that mare out across the running of MONICA'S MACHINE, which was forced to check and in doing so, clipped the heels of MISS COMMUNICATION. M. Poon was charged with Careless Riding under AR137(a). An inquiry was opened and adjourned to a date to be fixed to allow M. Poon's Master, Mr. R. Jolly, to be present.

MISS COMMUNICATION (S. Cahill) – bumped in the vicinity of the 150m by JESSIE'S OWN and taken wider on the track.

MONICA'S MACHINE (K. Brooks) – severely hampered in the vicinity of the 150m.

RONDAFERRO (L. Stojakovic) – raced keenly throughout the event.

TUFFSKI (Jemma Frew) – jumped away awkwardly. Held up for clear running entering the straight.

SAVANETA (D. Tootell) - reared as the start was effected and was slow to begin.

Correct Weight for this event was delayed to allow Co-Trainer Mr. C. Binnie, the Trainer of JESSIE'S OWN, placed second, to view the official footage in the straight. After doing so, Mr. Binnie lodged an objection against MISS COMMUNICATION (S. Cahill) being declared the winner on the grounds of alleged interference in the straight. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* Mr. Binnie's objection. Correct Weight was also delayed to allow Mr. G. Oakes, the Trainer of MONICA'S MACHINE, placed fourth, to view the official footage in the straight. After doing so, Mr. Oakes lodged an objection against MISS COMMUNICATION being declared the winner and JESSIE'S OWN being declared second on the grounds of alleged interference in the straight. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* Mr. Oakes' objection against MISS COMMUNICATION being declared the winner and JESSIE'S OWN being declared second on the grounds of alleged interference in the straight. RACE 5 : BALMAIN BENCHMARK 54 HANDICAP - 1800 metres

ARTEMISIA (Jemma Frew) – raced ungenerously throughout the event with its head in the air and as a result raced wide throughout.

FREDERATION (T. O'Donnell) – over-raced in the early and middle stages of the event.

RACE 6 : O'DEA SOLAR AND ELECTRICAL BENCHMARK 64 HANDICAP - 1200 metres

SVETSKI (S. Cahill) – raced wide without cover throughout the event.

RACE 7 : AIRMASTER AUSTRALIA RATING 0-58 HANDICAP - 1100 metres

THE HARD WAY (D. Tootell) – rider concerned with the mare's action en route to start. A pre-race veterinary examination reported the mare to be lame in the near foreleg and unfit to race. Acting on that advice, Stewards withdrew THE HARD WAY at 4.37 pm.

KOSMOS TERCEDES (Jemma Frew) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100m and was fined \$500. She was advised she would be required to attend the Riders' Advisory Panel.

YOU AND ME (T. O'Donnell) - a post-race veterinary examination revealed no visible abnormalities.
