**RACE 1 : ALLENDALE STUDS / SABOIS TWO-YEAR-OLD AND OVER MAIDEN PLATE –**  
**1550 metres**

**AL SLAMMER** (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

**MONDATCHEV** (J. Frew) – J. Frew pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$100.

**FLETCHINGLY** (M. Neilson) – hung in when placed under pressure in the straight. A post-race veterinary examination revealed the mare to be lame in the near foreleg. Trainer Mr. S. Theodore was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

**GOLD TILLIE** (K. Brooks) – proved difficult en route to the barriers. Slow to begin and raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr. D. Hall was advised a warning had been issued regarding the mare's pre-race manners.

**RACE 2 : UPPER SE LIQUID WASTE / SABOIS TWO-YEAR-OLD & OVER MAIDEN PLATE –**  
**1300 metres**

**CHENERS** (K. Brooks) – laid in when placed under pressure in the straight.

**PLATINUM SET** (D. Caboche) – slow to begin.

**THE ENGINEER** (M. Neilson) – slow to begin. Taken in onto ZAZIPZOOM in the vicinity of the 150m when ON DUTY shifted in.

**CAFE DELFINIA** (P. Marks) – over-raced in the early and middle stages of the event.

**ZAZIPZOOM** (D. Tourneur) – had to be restrained in the vicinity of the 150m to avoid the heels of THE ENGINEER, which was taken in by ON DUTY. Crowded for room in the vicinity of the 100m. A post-race veterinary examination revealed no visible abnormalities.

**ON DUTY** (B. Griffiths) – in the vicinity of the 150m shifted in when insufficiently clear of THE ENGINEER, which was taken in onto ZAZIPZOOM, which had to be restrained to avoid the heels of THE ENGINEER. B. Griffiths was issued with a reprimand.

Following this race K. Brooks was examined by the First Care Medical personnel and ruled unfit to fulfil her remaining engagements.

**RACE 3 : LOCAL BOOKMAKERS / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE –**  
**1100 metres**

**SACRED MONARCH** (J. Frew) – over-raced in the early stages of the event. Hung in when placed under pressure in the straight.

**WILKIN** (Jemma Frew) – jumped away awkwardly.

**ASTRO VITA** (D. Tourneur) – disappointed for a tight run between SANDHILL EXPRESS, which shifted in, and WILKIN, which shifted out, in the vicinity of the 300m and as a result was obliged to shift out to improve into clear running.

**RACE 4 : KANIVA CLUB HOTEL BENCHMARK 64 HANDICAP - 1300 metres**

**BRIMARVI CUGAT** (J. Frew) – jumped away awkwardly and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**LEAD THE WITNESS** (D. Tourneur) – bumped by MSITA HOLYFIELD on entering the straight.

**MISTA HOLYFIELD** (M. Neilson) – on entering the straight, shifted out to improve and bumped LEAD THE WITNESS.

**HURRICANE SONNY** (Jemma Frew) – Jemma Frew pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100m and was suspended from riding in races for a period to commence at midnight on Sunday, 10 April and to conclude at midnight on Sunday, 17 April 2016; a period of three (3) meetings.

**RACE 5 : MCCARTHY TRANSPORT BENCHMARK 60 HANDICAP - 2000 metres**

**GOT THE EDGE** (G. Cartwright) – had to be steadied in the vicinity of the 1700m to avoid the heels of BELLE OF THE SOUTH.

**ANGEL SUEZ** (D. Caboche) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**BELLE OF THE SOUTH** (Jemma Frew) – shifted in, in the vicinity of the 1700m, when insufficiently clear of GOT THE EDGE, which had to be steadied. Jemma Frew was issued with a reprimand.

**MR LAMBORGHINI** (A. Doyle) – jumped away awkwardly and was slow to begin.

**INSTANT CONVERT** (T. O'Donnell) – raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities. Trainer Ms. V. Dishon was advised a warning had been issued regarding the gelding being uncompetitive.

**RACE 6 : TATIARA INDUSTRIAL REPAIRS RATING 0-58 HANDICAP - 1550 metres**

**NEHRU** (J. Frew) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr. J. Dodgson was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

**RIGHT AND READY** (D. Caboche) – D. Caboche was found guilty of a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was suspended from riding in races for a period to commence at midnight on Sunday, 3 April and to conclude at midnight on Sunday, 10 April 2016; a period of three (3) meetings.

**A LOTTA ROSIE** (A. Doyle) – slow to begin.

**SEPTEMBER STORM** (Jemma Frew) – held up for clear running from the 600m to the 400m.

**RACE 7 : BORDERTOWN STONE SUPPLIES RATING 0-58 HANDICAP - 1100 metres**

**SUBJECT TO CHANGE** (D. Tourneur) – raced greenly when placed under pressure in the straight.
