Report on Race Meeting held at Balaklava Racecourse

RACE 1 : AEP HEALTH GROUP / SABOIS MAIDEN PLATE - 1050 metres

The start of this event was delayed approximately two minutes.

HOLY TRILOGEY (J. Toeroek) - slow to begin.

MONETRE BAY (J. Holder) – difficult to load. Trainer advised the mare would be required to load tractably in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed lacerations to the near hind pastern. First aid administered.

AVOID THE MISSUS (J. Kah) - slow to begin. Had difficulty in obtaining clear ground from the entrance to the straight until approaching the 200 metres when awkwardly placed behind TEMPTING FAITH.

SPLASH OF CRISTAL (J. Bowditch) – trainer fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards. Raced keenly in the middle stages of the event whilst being restrained off the heels of SOU SOUNI PRINCESS. Held up from the entrance to the straight until the vicinity of the 300 metres. A post-race veterinary examination revealed no visible abnormalities.

RACE 2 : BALAKLAVA VET'S DAY 10TH ANNIVERSARY / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1050 metres

NEVA DOUBT US (M. Poon) - jumped away awkwardly and shifted out onto LACE THE LADY. Saddle shifted to the near side in the early stages of the event placing the rider at a severe disadvantage throughout.

DOLLAR DOLLAR BILL (D. Caboche) - slow to begin.

HELMARA (P. Gatt) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

LACE THE LADY (E. Finnegan) – Trainer fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards. Hampered on jumping away. Rider was concerned with the filly's action in the straight. A post-race veterinary examination revealed no visible abnormalities.

LARKING (J. Holder) - slow to begin. Raced greenly and was inclined to lay in, in the straight and near the 200 metres was obliged to be steadied when POSH JOURNEY shifted out. A post-race veterinary examination revealed a laceration to the off hind pastern.

RACE 2 : BALAKLAVA VET'S DAY 10TH ANNIVERSARY / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1050 metres (Cont'd)

MALMOOSA (M. Neilson) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

POSH JOURNEY (R. Hurdle) – raced fiercely in the early and middle stages of the event. In the vicinity of the 500 metres had to momentarily steady off the heels of WREAKED, which raced greenly and shifted about. Had difficulty in obtaining clear ground from the entrance to the straight until approaching the 200 metres when it shifted out inconveniencing LARKING. Rider reprimanded. A post-race veterinary examination revealed no visible abnormalities.

TOYSHOP (D. Tourneur) – laid in under pressure in the straight. A post-race veterinary examination revealed a laceration to the off fore pastern.

WREAKED (M. Mamat) – laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 3 : CITY HOLDEN SA'S NO 1 / SABOIS MAIDEN PLATE - 1600 metres

YARN (A. Doyle) – jumped away awkwardly and was slow into stride.

DAMOCLES (J. Kah) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

BANGARANG (P. Gatt) – rolled in slightly approaching the 200 metres away from DAMOCLES.

DE LA CRUZ (J. Bowditch) - trainer fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards. Steadied approaching the 200 metres to avoid the heels of SANIMA STAR. Difficulty obtaining clear ground in the early stages of the straight.

SANIMA STAR (D. Tourneur) – approaching the 200 metres rolled out and contacted BANGARANG, shortly after shifted in and away onto DE LA CRUZ. Rider reprimanded. Difficulty obtaining clear ground in the early stages of the straight. A post-race veterinary examination revealed a laceration to the off hind pastern.

RACE 4 : TPI TROPHY / SABOIS MAIDEN PLATE - 1300 metres

SACRED DAYS (J. Kah) – raced keenly in the early and middle stages of the event.

CATALUNA (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

SISTER ANGEL (D. Caboche) – held up from the 150 metres for the remainder of the race when positioned behind CATALUNA. A post-race veterinary examination revealed no visible abnormalities.

THE CASTLE KAT (R. Hurdle) – hampered in the vicinity of the 700 metres when CERRO BLANCO shifted out. A post-race veterinary examination revealed lacerations to the near foreleg and off hind heel. First aid administered. Lost its near fore plate during the event.

CERRO BLANCO (D. Tootell) – made the turn in the vicinity of the 700 metres awkwardly and shifted out abruptly into the running line of THE CASTLE KAT. A post-race veterinary examination revealed lacerations to the off hind leg consistent with being galloped on. First aid administered. Lost its off hind plate during the event.

CENTRAL WITNESS (D. Tourneur) – wide without cover throughout the event.

RACE 5 : GILLES PLAINS & HAMPSTEAD RSL BENCHMARK 80 HANDICAP - 1400 metres

The start of this event was delayed approximately eleven minutes.

RACE 5 : GILLES PLAINS & HAMPSTEAD RSL BENCHMARK 80 HANDICAP - 1400 metres (Cont'd)

SANDHILL WARRIOR (M. Poon) – rider reported the gelding commenced to make excessive respiratory noise in the vicinity of the 200 metres and for this reason had not ridden the gelding out in his normal manner. A post-race veterinary examination revealed the gelding to have atrial fibrillation. Trainer advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

KINGDOM OF DREAMS (D. Caboche) – rider became concerned with the gelding's action at the entrance to the straight and for that reason had not ridden the gelding out in his normal manner. A post-race veterinary examination revealed no visible abnormalities.

PRESIDIUM – dislodged K. Brooks en route to the barrier. K. Brooks was examined by the First Care Medical Personnel and ruled unfit to fulfil her remaining engagements. During the delay Stewards permitted A. Doyle to weigh out and ride the gelding. Raced fiercely in the early and middle stages of the event. Trainer was advised that the gelding would be required to proceed to the start without delay in an Official Barrier Trial prior to accepting for a future race.

RACE 6 : PORT PIRIE RSL CLASS TWO HANDICAP – 1200 metres

The start of this event was delayed approximately two minutes owing to the delay in the previous event.

ROYAL MINT (NZ) (M. Neilson) – a post-race veterinary examination revealed no visible abnormalities.

CYCLONE THOMAS (J. Kah) – shifted out abruptly over the concluding 100 metres and bumped **STREAMING BY** (GB).

MISS COMMUNICATION (D. Tourneur) – raced keenly in the early and middle stages of the event. Held up from the vicinity of the 200 metres until inside the 100 metres when awkwardly placed between the heels of **SOCIAL LANE** and **SNAKE FARLEY**.

GEORDIE'S LASS (T. Zanker) – raced in restricted room in the early part of the straight when positioned inside **WINDSOR CUP**.

Correct weight for this event was delayed to allow P. Gatt (**STREAMING BY** (GB)) placed second to view the official photo for first.

RACE 7 : RSL CENTENARY BENCHMARK 60 HANDICAP - 1600 metres

ROOBOY (D. Caboche) – shifted out on jumping away onto **GO CAROL GO**.

BEAU ACRE (M. Poon) - slow to begin.

NIGHT BREEZE (M. Neilson) - a post-race veterinary examination revealed no visible abnormalities.

WICKED PROMISE (C. Jones) – difficulty in obtaining clear ground from inside the 200 metres until inside the 100 metres. Rider concerned with the gelding's action in the straight. A post-race veterinary examination revealed no visible abnormalities.

GO CAROL GO (J. Kah) – hampered on jumping away.

MOONIES CHOICE (D. Tootell) – unable to obtain clear ground over the concluding stages when **ROOBOY** shifted in under pressure.

DOOMSDAY PREPPER (C. Lindop) - a post-race veterinary examination revealed the mare had bled from one nostril. Trainer advised **DOOMSDAY PREPPER** would be required to gallop a 1000 metres in the presence of a Steward prior to accepting for a future race in accordance with AR53A(7).

RACE 8 : MORPHETT VALE RSL BENCHMARK 60 HANDICAP - 1400 metres

JOCKS GLEN (M. Poon) – rider accidentally dropped his whip approaching the 50 metres and was fined \$50.

KING CADEL (J. Toeroek) – raced keenly in the early and middle stages of the event.

C’EST VRAI (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

ASTRO DAMUS (D. Tourneur) – improved onto the heels of BEL STREAK in the vicinity of the 1000 metres and had to be steadied.

BEL STREAK (J. Bowditch) – raced keenly in the early and middle stages of the event.

INCANDESCENT (C. Lindop) - slow to begin.

LATER BABY (T. Pannell) – raced wide without cover throughout the event.

STRYKING GOLD (J. Holder) – was slow into stride.

ASH ROAD (D. Caboche) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

Race 5 – SANDHILL WARRIOR - Suspended – Results of ECG to be forwarded to TRSA Vet & Vet Certificate of Fitness required prior to performing satisfactorily in Official Barrier Trial - Atrial fibrillation Race 7 - DOOMSDAY PREPPER – Suspended – One nostril bleed – Required to gallop a 1000 metres.
